In response to your questions raised, I advise that the number of visitor serving officers post Covid-19 is 518 as at 27 July 2020, the only staff that ended their employment at the Dunedin City Council during Covid-19 lockdown were those staff that were on fixed term contracts with an end date during that period.

The total staff number presented in our 2019 Annual Report is correct and I advise that as at 27 July 2020 the total staff number is 984.
