I refer to your request for information as below.

1. You have asked for all income and expenditure by year for administering the Dog Control Act 1996 (DCA) since 1996.

The Council is not required to keep financial records for any longer than 7 years. However our ledger system commenced in 2003 and we can provide information from 2003 onwards, but pursuant to section 17(g) of LGOIMA that the information is not held by the Council we decline to provide financial information from 1996 – 2003.

In regards to the information from 2003 I advise that pursuant to section 14 (1) (a) that the request requires a search through a large quantity of information we are extending the time to reply to this part of your request by 20 working days (21 August 2020)

2. You have also asked for a full and complete account of regulations adopted by the Dunedin City Council under DCA, sections 10, 20, 33, 83 and 86 of the DCA. In your request you refer to Dog Control Act 1993 but earlier you refer to 1996. We assume you mean 1996 Act as there is no 1993 version of this Act, and note there is no section 83 and 86 of the Dog Control Act.

I advise that the regulations made under the Dog Control Act are made by Government and not the Dunedin City Council, therefore we do not hold any information. The regulations made under the DCA and the DCC Dog Control Policy and Bylaw are publicly available we are not obliged to provide this pursuant to section 17(d) of LGOIMA.
