Local Government Official Information and Meetings Act 1987 (LGOIMA) request for Subdivision Consent Processing Statistics for each month for the July 2019 to June 2020.

I am writing in response to your LGOIMA request for the following information:

I am looking to obtain figures for the past year on Subdivision Consent processing numbers. If possible, I would like to obtain each month for the past year (July 2019 to June 2020):

Subdivision Consent applications

- Number of Subdivision Consents lodged
- Average processing time (mean and median) for non-notified consents (working days, excluding on-hold days) for consents granted
- Average processing time (mean and median) for non-notified consents (working days, including on-hold days) for consents granted

223 Certificates

- Number of 223 application requests
- Average processing times (mean & median) (working days) for certificates issued

224c Certificates

- Number of 224c application requests
- Average processing times (mean & median) (working days) for certificates issued

This request is being sent to all city and district Council's in the hope of obtaining a nationwide picture on the number of consents and processing timeframes. I will be looking to update the information each month and potentially publish a summary of results within industry publications.

Please find attached a spreadsheet with the information that we hold. As we do not hold the mean and media processing times for any of the above this has been declined, pursuant to section 17(g) of LGOIMA that information is not held by the local authority.
