I refer to your e-mail requesting the number of unauthorised vegetation clearances in the last three years. The Senior Planner – Monitoring and Compliance, Helen Dempster, has provided the following in response to your questions raised.

Reported incidents of unauthorised vegetation clearance (i.e. 'Complaints'/COM): A search of the Council's records indicates that the Planning Compliance team have received the following five complaints during the period of 2017 to present-day (inclusive) regarding vegetation clearance that was subsequently determined by Council staff to be unauthorised*:

* there have been other complaints received by the Council Planning Compliance team *alleging* vegetation clearance that were received during the last 3 years, however investigations by Council staff found that the clearance was permitted by the District Plan rules or a resource consent (and therefore the clearance was not 'unauthorised').

The Council has, very recently received a further complaint alleging indigenous vegetation clearance. Council staff have not yet had a chance to inspect the property in question to determine if unauthorised vegetation clearance has been undertaken; here are the particulars for this COM:
