 Yes
- b) How many fixtures are there currently in your district? There is a total of 15,371 fixture. Of these 13,843 are owned by the Dunedin City Council (Council); 1,206 owned by Waka Kotahi; and 322 privately owned.
- c) How many of these (b) are currently LED fixtures, and in what year were they installed? (Please provide number of luminaires installed per year)

The table below shows that of the 15,371 fixtures, 14,125 are LED, along with when they were installed.
