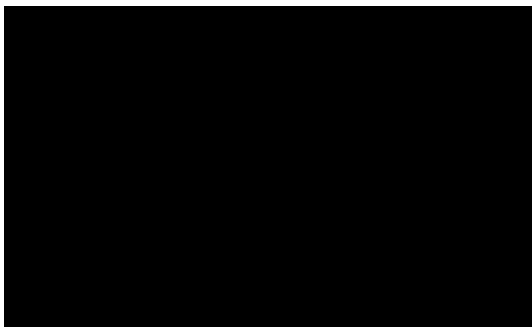

Kia ora,

I am conducting research for a business plan, and need to know the costs and frequency of fireworks displays by DCC, or any DCC controlled organisations (CCO).

Could you please provide me with the following information:

- How many fireworks events have been paid for by DCC/CCO in the past 5 years, and what were the costs involved (price of fireworks and price of total running costs for said event (e.g., fireworks on New Years eve = \$X, total running costs of fireworks display = \$X))
- Has the DCC considered a reduction of fireworks displays in Dunedin, and if so, for what reasons?
- Has DCC considered an alternative to fireworks? If so, what/what company?

- How many complaints were made against DCC/CCO funded displays, and how many complaints were made against other fireworks displays (e.g., if a private company had a fireworks show in a public area, or on a private property but they were unduly large/loud/bright).

- If such consents exist (I can't find anything about large scale permits required on the Council website), what is the DCC consent process to have a large-scale fireworks display in a public area? How many consent applications are made each year, how many are declined/approved? (e.g., New Years eve, Chinese New Year etc)

If there isn't any data for the year just gone (2021), presumably because these numbers aren't yet logged, or because there was such little activity due to Covid, perhaps the years '18, '19, and '20 would be useful.
