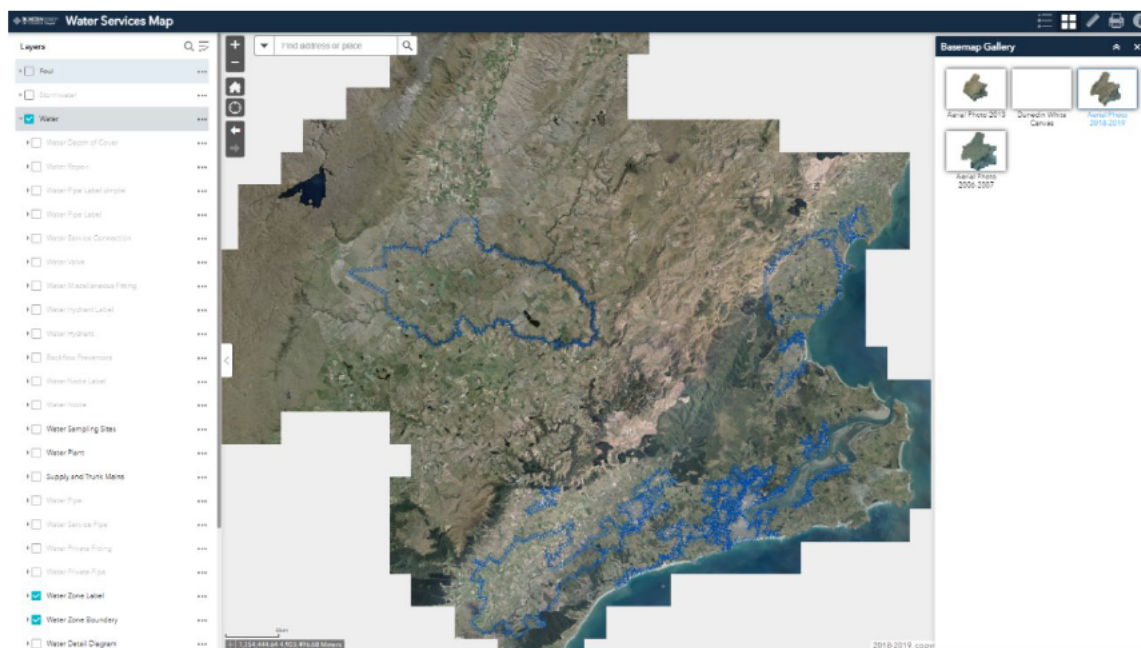
Local Government Official Information and Meetings Act 1987 (LGOIMA) Request for Information

Further to our letter of 6 November 2023, acknowledging receipt of your information request transferred to Council from the Ministry of Business, Innovation and Employment (MBIE).

Set out below is our response to each of the information requests:

1. The area(s)/locations that are not on a Council supplied water scheme.

The areas that are serviced by Dunedin City Council are available to view using the Water Services online map at <https://www.dunedin.govt.nz/dunedin-city/maps-and-photos/water-services-map-and-wws-work-in-progress> (see below image). Please note that properties which fall outside of the blue water zone boundary lines (as indicated on the map) are un-serviced by the Dunedin City Council.



2. The supply points for verified water's carriers to buy water and the cost per m³

We advise that the current price is \$1.93m³ for treated water supply.
