I refer to your e-mail below and our telephone conversation relating to your request and the definition of crime, and your clarification that you were not interested in matters such as trespass notices. Please accept my apologies for the delay in replying to your request.

Despite reasonable efforts to locate the information requested, we have not been able to find any documentation and therefore decline your request under section 17(e) of LGOIMA.

However I can advise that while Council does not have formal involvement in the prevention of crime, it does work proactively with its stakeholders including the University of Otago, to ensure the health and wellbeing of Dunedin residents. Staff meet with the police on a regular basis. Kevin Mechen is our City Safety Co-ordinator and he meets with police on a regular basis. You are most welcome to contact him on kevin.mechan@dcc.govt.nz if you wish to discuss your request with him and he can call you back.

As we have declined to provide the information requested you are advised that you have the right to seek a review by the Office of the Ombudsman.

Dear Dunedin City Council

I am interested in the information you hold about crime and public disorder in Dunedin to enhance my understanding of the impact of crime and responses to crime in Dunedin.

Under section 10(1) of the Local Government and Official Information and Meeting Act 1987, I request the following information:

- *All analyses, assessments, recommendations, reports, updates, aide-memoire, evaluations, and final copies of written documents the Dunedin City Council has produced or received (including from Police) regarding crime and public disorder in Dunedin since 1 June 2019 that are not currently in the public domain.*
- *All communications and correspondence the Dunedin City Council has had with any agencies, organisations and representatives regarding crime and public disorder in Dunedin, including efforts to reduce or prevent such crime and public disorder, since 1 January 2022.*

Where information is withheld, I request you provide the reason for refusal and the grounds in support of that reason.

I request where an entire document is withheld that the title, date and a summary of the information it contains be provided in so far as is consistent with the Act.

This is not a request for the names of officials or their personal and private information.

I ask receipt of this request is acknowledged.
