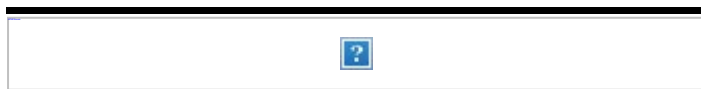

I hope 2024 has begun well for you and you were able to enjoy relaxing time with friends and family over the holiday period, though I can imagine the demands of your portfolios will be significant.

I am looking forward to working with the new Government this year, and it will come as no surprise that the New Dunedin Hospital (NDH) is an area of particular interest. It is a great talking point around town as we see so many cranes working busily on the 2 sites. We can clearly visualise the structure of the Outpatients building as its steelwork frame fills the sky and the piles for Inpatients are steadily forming a mighty foundation.

Thank you for your advocacy of completion of this project to the services and facilities agreed in the Detailed Business Case. That endorsement triggered the previous Government to increase their commitment and led to multi-party support.

I enjoyed one of my first official meetings this year with Associate Minister of Health, Matt Doocey and it was good to be able to convey to him the enthusiasm that the people of Dunedin and our wider Otago Southland region have for this construction. Naturally I pointed out that his home province of Canterbury also has an interest in the facility, as in the inevitable event of AF8, Dunedin Hospital will be located on the most stable site in the South Island.

You are quite right that the pathology provisions for NDH will need a separate business case and I would like to offer our services if we can be of any help in that process.

Thank you for all you have done so far. I have received positive feedback from health professionals who welcome your intention to shift more decision making back to local.

Subject: Decisions on the future of New Dunedin Hospital

Hello,

Today the Minister of Health, the Minister of Infrastructure and the Health New Zealand Commissioners confirmed an increased Budget for the New Dunedin Hospital Project.

An additional \$290 million, held in contingency by Cabinet, brings the new envelope to \$1.88 Billion for the design, construction and commissioning of a modern hospital in Dunedin.

Under current settings, however, the cost of completion is forecast to exceed even this new limit.

This ongoing cost escalation and the recommendations of a review into the Inpatients Building, undertaken by Infrastructure Commission, Te Waihangā, has informed a decision by Ministers to review options to manage costs.

Health NZ has been instructed to work urgently to develop options that can be achieved within the budget and deliver a modern hospital and health services that are driven by clinical safety and new models of care.

Two options are being considered, both incorporating the Outpatient Building:

- Revision of the project's specification and scope within the existing structural envelope, such as reducing the number of floors, delaying the fit-out of some areas until they're needed, and/or identifying further services that can be retained on the existing hospital site or in other Health NZ buildings within Dunedin among other possible solutions.
- A staged development on the old hospital site including a new clinical services building and refurbishing the existing ward tower.

Health NZ will consult with key Southern stakeholders, including clinical leaders, to ensure they understand the benefits and risks before a final decision is made. We will be working hard to minimise any delays to opening dates.

The announcement today does not impact the Outpatient Building, which is due to open for patients towards the end of 2026. Health NZ will be prioritising the planning for the opening of this building. This new infrastructure is a key part of New Dunedin Hospital and will make a tangible difference to delivery of planned care in the Southern Region.

We acknowledge the challenges and the concerns of the community and taxpayers. Our focus now is to move forward and provide certainty as fast as we can.

The context we are working in recognises significant pressures on the health budget, despite record investment. We know that other major hospitals around New Zealand also require significant capital investment.

Colleagues

It was an interesting trip to Wellington today.

Minister Reti was as supportive as he could be but while there are no cuts proposed to clinical services at this time, there are cost overruns.

In the first instance, he is focused on construction costs because that is where the cost increases lie. Additional negotiation resources are being deployed in that regard.

In the meantime, in line with general community feeling, it is worth resuming our campaign in order to head off any reduction in clinical facilities or services.

To that end, I have started referring to the hospital as the New Southern Region Tertiary Hospital rather than NDH. Various commentators have depreciated the importance of the hospital by calling it a local facility, so I would urge you all to adopt the longer and more accurate terminology in order to head off that line of thought.
