Kia ora

I am writing in response to your information request, received on 24 October 2024 for information on public trees within the Dunedin City Council's jurisdiction, specifically the records for public tree removal and public tree plantings from 1 January 2022 until 16 October 2024. You also sought any reports or assessment on urban tree management of the overall strategy for public tree planning and removal from January 2017.

We advise that we do not hold any information for the 2022 and 2023 years and decline this part of your request pursuant to section 17 (e) of the Local Government Official Information and Meetings Act 1987 - as the document alleged to contain the information request does not exist or, despite reasonable efforts to locate, cannot be found.

Information held on the tree species and the reason for removal or for planting for the current 2024 year is attached for your information. For clarification we advise that the reference to "formative" contained in the list refers to the planting of trees.

We advise that the reason for the majority of the removals is for senescent (old) trees as deemed by Parks and Recreation staff as a health and safety risk to members of the public, and Council's contractors. Staff advise that as a general rule, most plantings are carried out in the spaces where trees have been removed either historically, or recently.

In regard to your request for "any reports or assessment on urban tree management of the overall strategy for public tree planning and removal from January 2017". We advise that DCC do not have an urban forest management plan and refer you to the Second Generation District Plan (2GP) which includes a list of scheduled trees https://www.dunedin.govt.nz/ data/assets/pdf file/0006/1083732/PC1-Schedule-of-Trees-FAQ.pdf
