Part Ocean Beach Domain being Local Purpose Reserve (Coastal Conservation) located at 41A Tahuna Road, St Kilda, Dunedin

The lease from Council is under Section 61 of the Reserves Act 1977

Waikouaiti Campground

Part Waikouaiti Domain being Recreation Reserve located at 186 Beach Street, Waikouaiti. The lease from Council is under Section 59A of the Reserves Act 1977.

As these are operated as campgrounds, they are required to comply with the relevant laws and regulations applying to campgrounds, including the Camping-Grounds Regulations 1985.

Please note freedom camping has separate legislation – the Freedom Camping Act 2011 as well as local authority bylaws.
