I refer to your e-mails of 4 November 2024 clarifying your request.

We have provided the costs below, however the lower garden electricity expenditure is measured through a single metre which includes electricity use of Winter Garden display houses, information Centre plus staff workshop facilities so we are unable to identify the actual cost for the Winter Garden. The Council uses a mix of electricity and gas to heat water at Moana Pool but it is not possible to determine what portion is just the "pool water".
