Hi All

I attended a meeting with Lime Scooters and Sue this afternoon. Lime Scooters is very keen to establish in Dunedin, ideally this year. Sue is keen to help facilitate this ambition. I'm sure you will have heard some of the negative publicity over the ChCh and Auckland releases in the past few weeks. There is also some positive news such as Auckland has had the fastest uptake globally and ChCh is 3rd. And ACC claims as a proportion of rides completed safely is insignificant.....(according to Lime)

A benefit to us is that they will share ride use data (the scooters are GPS tracked so Lime will share where from, where to, when, etc across the network). I expect this will be valuable data for our transport planning.

If Lime proceed, they will work with us to establish where the scooters are positioned and if there are any scooter 'no parking' areas that we may want to establish.

Simon P has looked at the regulatory aspects and there is no bylaw to prevent their use. As far as Simon P can establish to date is that they may need a license to occupy a public space for commercial purposes (similar to street food vendors) as they will need to park scooters in public spaces.

I'll keep you posted as things develop. Any queries or comments, please feel free to contact me.

# Hi Simon,

Hope you are feeling better.

This is a quick heads up in terms of the matters raised/discussed at todays meeting.

I apologised that you were unwell and couldn't be there – and that while I wasn't as close to the issues as you I could give them an overview of the Councils current position and what we were looking at doing.

I told them that we believed Lime were going to establish an operation in Dunedin –discussions had already been held with them, and that when they start the Council would be entering into a MOU with them and matters covered in that MOU would include safety and responsibility expectations on users etc.

Also said that we had looked at bylaws and there was nothing in current bylaws that would preclude them from operating in Dunedin — and that we were looking at a public places bylaw — at this stage we are investigating the practicalities of such a bylaw and how that may control the use of scooters — however the bylaw would be months away and not in place before Lime start operating in Dunedin. If a public places bylaw consultation proceed there would be opportunities for their group to be heard and put their views.

Lynley Hood talked about the Commercial Use of Footpaths policy and said that surely we could control them under that – I said that the advice we had received was that the commercial transaction took place elsewhere that in Dunedin, she also referred to the docking stations and suggested that they would need to get a permit for them – so that could be an opportunity to prohibit them. Other than her making that statement the conversation didn't progress along those lines.

Other points that came up include:

- Use of cycle lanes and whether the scooters should be on cycle lanes, the road, or the footpath. I noted that was a matter for NZTA and that they may want to engage with NZTA to put their views, and seek clarification.
- Lynley Hood referred to the Stony Batter court case which she reckons is relevant? Refers to a private property issue in Waiheki Island.
- NZTA regulations and definitions "driver of a vehicle" and 'vehicle'
- Some seemed to think that Lime is a long way off however both myself and Paul said that we thought they
  would be operating in Dunedin soon
- I mentioned that our legal team were looking at legislation and were following something in the Summary Offences Act up with the Police Lynley expressed concern about the interest and attitude of the Police in the matter
- Where does the DCC sit on the situation? referred them to the points I made earlier (i.e. at the top of this
  email)
- Interested in what is happening in other cities I said that we were as well and would be following / liaising with Auckland.

The meeting was cordial and I did stress that they should talk to NZTA, and I also offered for one of us to attend their next meeting which I think is in February.

Hopefully see you on Monday.

# General guidelines on e-scooters - provided to Otago Daily Times 13 November:

E-scooters can be ridden on all the areas listed below, however the painted-on cycle lanes\* do have a safety caveat over them:

E-scooter riders may use painted cycle lanes\* if they are impeding traffic flow to allow vehicles
to pass safely, but it is expected that the e-scooter rider will go back to the road or footpath as
soon as they can do so safely.

\*usually these are painted green with no solid separation from the road traffic lane. E-scooters can be ridden on:

- Footpaths
- Shared paths
- Roads
- Segregated/ separated cycle paths.

# More guidance on e-scooters and safe use:

- The main guidance for e-scooter riders is to be as safe as possible and be aware that cyclists, other road users and pedestrians may not hear them approaching.
- The Transport Agency strongly recommends e-scooter riders wear helmets, and we understand
  the commercial operators of e-scooter rideshare schemes will actively encourage their
  customers to wear helmets.
- E-scooter riders who do use the road rather than the footpath, are required to keep as far to the left as is practicable for their own and others' safety.
- E-Scooter riders may use painted cycle lanes if they are impeding traffic flow to allow vehicles to pass, but it is expected that the e-scooter rider will return to the road or footpath as soon as practicable.
- Good and safe behaviour remains the priority when people ride e-scooters and anyone riding dangerously on any part of the footpath, cycle lanes or road may be subject to Police enforcement.
- Given the wider range of vehicles and new technologies now available for people to use, a wider review of the transport rules is planned.

Thanks very much for your help yesterday-greatly appreciated!

I have two (unrelated) queries today.

A) Traffic/cycle lane issues.

The first is a followup on the Dunedin cycleway/ traffic story of yesterday (and this morning traffic moved very well, no traffic jams when I arrived shortly before 8.30aml).

Re traffic matters:

I understand that the main remaining part of State Highway 1 in Dunedin to have the cycle lanes added is between the Leviathan Hotel (mentioned yesterday), just north of the Queen's Gardens, and the University Book Shop, just north of the Captain Cook Tavern (or whatever it is called these days.) The questions were:

1) It looks like the cyclelane project on State Highway 1 may be entering its last phase.

When is this expected to end, are there any projected milestones on the way, eg the next bit to be done etc (and I gather quite a bit of preparatory work has been done, even for parts of the area yet to be completed);

- 2) Are there any plans (as I imagine there are) to limit traffic jam disruption during this final (?) phase, and could you sketch in what steps will be taken etc?
- (B) I have also been asked to write something today on the vexed issue of electric scooters on footpaths.

This is already in the public domain, and you may have already seen this.

I'm not inviting comment on all of this statement, but just include it for background context.

In fact the only two matters I want to ask about are, specifically:

E-scooters are fast and unstable. E-scooter riders frequently weave recklessly through pedestrians. Pedestrians with poor hearing and eyesight can easily step straight into the path of an oncoming scooter. Teenage pedestrians wearing headphones are just as vulnerable.

It's hypocritical for the government to say it supports active transport, while at the same time putting pedestrians at risk. If the government really cared about active transport, it would prioritise pedestrian safety.

Nearly four times as many pedestrians as cyclists are killed on our roads each year, and the carnage on footpaths is escalating.

Over the past five years, 527 pedestrians were hospitalised with serious injuries caused by collisions with low powered vehicles such as bicycles. In most collisions between a bike and a pedestrian, the pedestrian comes out second-best.

Dr Hood says pedestrians effectively have no voice in government decisionmaking.

Government decisions about how footpaths are used tend to made for cyclists by cyclists. It is clear that many cyclists see walking as a slow, low status form of transport. This is a completely unacceptable viewpoint. Walking is New Zealand's most popular, most affordable, sustainable, inclusive, accessible and environmentally-

[1] In January, in response to an Official Information Act request, the NZTA had the following to say:

an electric scooter would be considered to be a motor vehicle and would need to be registered. However, as it would not be able to meet any of the standards it would not be able to be registered as a moped. In addition, as it is considered a motor vehicle it cannot be driven on a footpath in accordance with Section 2.13 of the Land Transport (Road User) Rule 2004 which can be found via:

Has Lime and the DCC had any discussions about potentially launching the hire scooter service in Dunedin? If so when have those discussions taken place and how far along were they?

Lime met with Council staff for the first time a couple of weeks ago. At that stage, Lime indicated they would be launching their e-scooter service in Dunedin and wanted to explain how the service worked.

Does the company need to apply for a permit to operate in the city?

We are currently exploring issues that exist, or may arise in the future around the use of e-scooters. This will inform the potential development of a public places bylaw. The DCC is keen to have vibrant and liveable spaces within our city without compromising safety. which will enable us to regulate e-scooters and other similar devices. However, any bylaw won't be developed in time before Lime launches.

Has the company applied for a permit to operate the service in Dunedin? If not are the DCC expecting the company to make an application?

As above – there are currently no bylaws or regulations to issue a permit under.

If an application has been made, did the DCC know when the service might launch in Dunedin? (A ballpark estimate would be fine)

Lime indicated that it would likely be around Christmas.

If the company was to launch in the city would there be restrictions on where the scooters could be used? i.e footpaths/cycle lanes?

The advice we have from the NZTA is that e-scooters are not classified as motor vehicles so they can be used without registration or a drivers licence. E-scooters can be used on the footpath or the road – except in designated cycle lanes that are part of the road (which were designed for the sole use of cyclists).

Did the DCC have any concerns about pedestrian and user safety if the service was to launch in the city?

We are closely monitoring the situation in Auckland and Christchurch to see how the scooters are being used and what issues arise. NZTA states that on the footpath the e-scooter user must:

- operate the device in a careful and considerate manner
- operate the device at a speed that does not put other footpath users at risk
- give way to both pedestrians and drivers of mobility devices.

On the road, e-scooters must be operated as near as practicable to the edge of the roadway. A helmet is not legally required to be worn when using an e-scooter, but is recommended. These messages will be part of the MoU with Lime.

Has the DCC had any discussions with other bike/scooter hire companies about setting up in the city? If so who?

We have not been approached by other companies.







Here is the draft MoU for your review. Apologies for the delay – some key staff have been away and unable to feed into the document until today.

As mentioned during our last conversation, there are currency no regulatory mechanisms to issue a permit to LIME. However this MoU sets out expectations around how we would like to see you operate.

We are currently undertaking a review of our bylaws dealing with the use of public places. Depending on how e-scooter riders behave and consequently, how the community react, it may be necessary to introduce restrictions or even prohibit the use of e-scooter altogether. That is why this MoU is critical in setting out a common understanding on communication, operations, responsibilities and complaint resolution.

When you've had a chance to review please come back to me.

Hi Simon,

Thanks for coming back to me. The updated MOU looks good. My responses to your queries are below.

Hotspots - please see the google maps link with our populated hotspots. These hotspots are data generated based on a range of criteria, including building importance and how frequented they are. We will go through these and make slight tweaks as we deem necessary (based on local knowledge of the infrastructure). [https://drive.google.com/a/limebike.com/open?id=1R6g7fToqfkqHpnV\_lurlGnGJzM2udN0y&usp=sharing]

Please note that not all of these will be filled by scooters at any one time. They are possible locations for deployment. We have an optimiser in our platform that turns hotspots on and off, dependant on demand day-by-day and the number of scooters in our fleet. Also, we don't necessarily deploy directly at the pin. Each pin has a 50m radius of possible deployment, to ensure our Operations Team and Juicers deploy in an appropriate position. We educate everyone best deployment practice to eliminate clutter and hazards.

Following launch, a small number of issues with these may surface, and we will adjust accordingly. This would include either moving or deleting the hotspot, and can be actioned in minutes. To give you an idea, I've adjusted approximately 2-3 in the last month in Christchurch due to minor issues, such as scooters being in front of a shop window.

**Speed data** - as mentioned, we don't collect this data. Therefore, we are unable to provide it to our existing stakeholders.

We are all setup and in accordance with New Zealand law regarding insurance and employment.

Andrew, our Operations Manager, and I will be available for a chat at 3:30pm at the council if you are free.

  deal with allegations of reckless use of the scooters.
- Insurance We would expect that an operator would carry out good business processes /practices which would include adequate insurance (public liability), and they'd also be required to comply with all other relevant laws and regulations e.g. as to tax and employment of staff/contractors etc. We wouldn't normally set these out within an MoU.

#### **PARTIES**

Dunedin City Council, a local authority under the Local Government Act 2002 (DCC)

and

Lime Technology Limited, a duly incorporated Company, trading as "Lime" (LIME);

#### **Purpose and Intent**

The Parties wish to ensure the management of public places and to provide reasonable controls to protect the health and safety of and the public from nuisance, while meeting customer expectations and supporting the wider transport objectives for Dunedin City.

# Relationship principles

- The Parties acknowledge that the following relationship principles will govern their interactions:
  - i The Parties will be collaborative, conduct their interactions with each other in a professional manner, and communicate in a way that is open and effective; and
  - If The Parties will address any issues that arise in a timely manner and engage in discussions to resolve any issues in good faith.
  - III The Partles will promote and endeavour to ensure the safe and convenience passage of pedestrians on the footpath

## Obligations and responsibilities of LIME

In order, to uphold the purpose and intent of this Memorandum of Understanding (MOU), LIME agree to do or undertake the following:

#### Location and Placement of E-Scooters

- 3.1 At the start of each day, deploy no more than five E-Scooters in the deployment locations.
- 3.2 That neither LIME nor any of its agents will park E-Scooters, in inappropriate locations including, without limitation:
  - a) In positions that restrict footpaths to less than 1.2m width in suburban and rural areas, and 2m in the central business district includes shops, schools, aged persons homes or facilities, hospitals, tourist attractions, bus stops, libraries.);
  - b) where they could pose a safety hazard;
  - where they could interfere with pedestrian access generally or access to amenities;
     or
  - d) any other areas identified by a Council officer, that in the Council's discretion, to be an inappropriate location;

- e) in the way of pedestrian crossing points, or the path of pedestrian traffic adjacent to those crossings
- f) at the kerb within bus stop extents, or directly adjacent to taxi stand, mobility parking or an authorised vehicle only parking space.
- 3.3 The location and placement of the E-Scooters set out above in clause 3.1 is subject to review by the DCC within three months of signing this MOU and at three monthly intervals thereafter and may be altered at the DCC's discretion but only after discussion with LIME.
- 3.4 Will inform its users or riders of the requirements set out above in clause 3.2.
- 3.5 Will ensure that E-Scooters are removed from public places every evening of operation.
- 3.6 Where a DCC enforcement officer advises LIME that an E-Scooter is parked or left in an area which it has identified as an inappropriate location, LIME will, within a reasonable time remove the E-Scooter. Any E-scooter removed following a request from the DCC may be redeployed to a location and in accordance with the clauses 3.1 and 3.2.
- 3.7 LIME must ensure E-Scooters are effectively redistributed to avoid excessive build up in any one area and provide the DCC with a rebalancing, relocation and redistribution plan to meet the Operation and Parking KPIs set out in Appendix A.
- To deliver on the expectations of the DCC to ensure the management of public places and the delivery of the expected support for the wider transport objectives for Dunedin City, LIME will target the Operation and Parking KPIs set out in Appendix A.

#### Use of E-Scooters

- 4 LIME will educate customers about safety checks, responsible riding and correct parking, including the impacts to the public of using inappropriate locations to the public.
- 5 LIME will advise riders that they can incur penalties for breaching any law, regulation, standard or applicable rule including, by way of example, unauthorised use of special vehicle lanes, or operating a vehicle inconsiderately.
- 6 LIME will advise riders that E-Scooters must not be used or ridden in a manner that is or might be dangerous to the public or to any person and that this includes use in parks and reserves.
- 7 LIME will advise riders that E-Scooters are to be used safely and carefully and that riders must be considerate to all other road and footpath users, ensuring that:
- 7.1 When on the road, users must keep as close as possible to the edge of the roadway; and
- 7.2 When on the footpath, users must:
  - 7.2.1 Not ride at speeds that put other footpath users at risk; and
  - 7.2.2 Always give way to pedestrians and drivers of mobility vehicles.

# Safety and Maintenance

- 8 LIME will ensure that:
- 8.1 Each E-Scooter is legal and approved under standards or definitions set out by the New Zealand Transport Agency as a wheeled recreational device;
- 8.2 Each E-Scooters has:
  - 8.2.1 A working bell;

- 8.2.2 A steady or flashing rear-facing red light(s) that can be seen at night from a distance of 200 metres; and
- 8.2.3 A white or yellow headlight(s) that can be seen at night from a distance of 200 metres;
- 8.3 The design, performance and assembly of each E-Scooter complies with appropriate standards; and
- 8.4 Each E-Scooter is regularly inspected and maintained to ensure it is compliant.
- 9 LIME must provide the ability for users, as well as the public, to report safety and maintenance issues with the E-Scooters. This must include a publicly displayed New Zealand contact phone number and email address on each E-Scooter.
- 10 LIME commits to meeting the Safety and Maintenance KPIs set out in Appendix B.
- 11 LIME agree to speak to or otherwise communicate with representatives of the disability or mobility sector or any other interested public service groups, whether referred to them by the DCC or not, to address any issues or concerns that these sectors may have in respect of the use and operation of LIME's E-scooters in the City.

#### Obligations and Responsibilities of the DCC

- 12 The DCC agrees to undertake the following:
- 12.1 Assign and provide LIME with a key representative who may be contacted by LIME to discuss any matter to which this MOU relates;
- 12.2 To reasonably advise LIME if any E-Scooter is seen located in breach of any condition of this MOU;
- 12.3 Liaise with the LIME key representative about rebalancing, relocation, and redistribution plans to assist LIME meet its obligations set out in Appendix A.
- 12.4 To refer a member of any disability or mobility sector or public interest group wishing to raise an issue or express concern in respect of the use and operation of LIME's E-scooters. Any referral shall be made at first instance to the LIME Key representative named in this MOU.

#### Reporting

- 12.1 LIME will provide raw non-identifiable information (Appendix C) to the Council on a monthly basis subject to Council introducing measures agreeable to LIME to protect its commercially sensitive information.
- 12.2 LIME will report monthly to the DCC on the reporting measures set out in Appendices A and B.

## Confidentiality

- 13.1 In relation to all information that the Parties provide and/or receive under this MOU, the Parties agree that:
  - 13.1.1 Where a Party is providing information that it believes is confidential and/or commercially sensitive, it will advise the receiving Party, that the information is being provided on a confidential basis.
  - 13.1.2 Where a Party is receiving information provided on a confidential basis, it will not disclose that information unless:

- 13.1.2.1 the disclosure is required by law; or
- 13.1.2.2 the information is already publicly available (other than through a breach of this clause); or
- 12.1.2.3 the Party who provided the information has given its written consent to the disclosure;
- 13.2 The Parties acknowledge that the DCC is subject to the Local Government Official Information and Meetings Act 1987, and may disclose information relating to this MOU to the requester.
- 13.3 The Parties agree that the undertakings given in relation to the confidential information shall continue notwithstanding the termination of this MOU.

# 14 Key Representatives

- 14.1 The DCC nominates Simon Pickford as their representative in respect of any discussions, actions to be carried out, or decisions to be made under this MOU. #### General

- The Parties acknowledge that the Privacy Act 1993 applies to their respective operations and will act to ensure compliance with this Act.
- Any policy developed by LIME or the obligations upon either Party under this MOU may be superseded by requirements or obligations imposed by statute, regulation or legal process.
- 17 While this MOU is based on a spirit of collaboration, if a dispute arises, the Key Representatives of the Parties will meet and seek to resolve the dispute through good faith discussions.
- Notwithstanding any other clause in this MOU, this MOU does not bind or restrict DCC as a regulatory authority, and any consent or agreement given by DCC.
- Noting that this memorandum relates to roads and footpaths and other public places under DCC control only.



### 11.2 Things in Roads -

- (1) No person shall without the consent of the Council or in accordance with the provisions of this Bylaw place or leave anything on any road other than a vehicle lawfully parked.
- (2) Without limiting the generality of 11.2 (1) no person shall:
- (a) Leave on any road for any period greater than four hours any vehicle which is not in complete and working order; or
- (b) On any road construct or rebuild or repair or make alterations to any vehicle, except for repairs rendered necessary by reason of accident or breakdown; or
- (c) Display any article or articles whatsoever outside any shop, shop window, or doorway or in any other place so as to encroach on any road; or
- (d) Place, pack or unpack any goods on any road, or
- (e) Erect any scaffolding, fence or structure of any kind on or over any road; or
- (f) Use any hoist or crane on or above any road; or
- (g) Erect or install or cause to be erected or installed any gates or doors capable of being swung over or across any roads; or
- (h) Being a person in charge of a vehicle or machine permit any clay, gravel or other material to be carried on to any road; or
- (i) Permit or suffer anything to fall from any vehicle into

### 11.3 The Council may allow Things in Roads -

- (1) The Council may grant to any person on such terms as it thinks fit permission for a specified thing or things to occupy a place or places in a road.
- (2) The Council may in granting permission under 11.3 (1) impose conditions on the grant of permission in relation to the health, safety and convenience of users of the road and for the protection of the road and for any other relevant matter. The Council may

charge such fee as it may fix in respect of the grant of permission for the thing to occupy roads.

(3) If a thing is left in the road in breach of conditions imposed pursuant to 11.3, or the fee payable under the clause has not been paid, the Council may require the thing to be removed.

Hi Sue,

I have had a look through existing policies/bylaws and spoken to the Regulatory and Parks teams. In short, we don't believe there is any impediment to Lime (or another company) operating their e-scooter business. Scooters can use the footpaths or cycleways. The hubs can operate (with DCC permission) from footpaths or reserves e.g. the Octagon.

Related policies/bylaws are:

The Control of Skateboarding bylaw (2005) which has lapsed and not been renewed (there was insufficient evidence of issues/complaints)

The Commercial Use of Footpaths Policy (2005) allows businesses to use footpath space so long as pedestrians aren't obstructed and the 'visual amenity of our streetscapes is maintained'. There is an application process and small fee.

The Reserves and Beaches Bylaw (2017) allows trading with the prior permission of an Authorised Officer, or Council resolution.

## Dockless Cycle Share Code of Practice

December 2017

### 1. Introduction

Auckland has seen a significant increase in the number of people cycling in recent years with an increase of 248% in cycle trips into the city via Upper Queen Street since 2013 and 45,600 new cyclists in Auckland in 2016. With 230,000 people living within a 30 minute bike ride to the city, Auckland is the ideal candidate for cycle initiatives that support the success of new cycle ways such as Cycle Share schemes.

To continue to grow cycling, Auckland Council and Auckland Transport recognise we must work together to make the city a place where people choose to walk and cycle more often. The potential to get more people cycling is big, and dockless bikes are a way to make cycling more accessible and will complement Auckland's cycle network and existing public transport network.

Alongside this, streets must be made more accessible for those who prefer to walk, especially our vulnerable users such as children, older people and those with accessibility issues. Safety remains our primary objective and it is our duty to protect the rights of the public to use and enjoy Auckland's roads and walkways. Dockless cycle share schemes must work for everyone without impacting, or causing a danger or nuisance to other road users.

This Code of Practice outlines the requirements that cycle share operators applying for a licence to operate must adhere too. It outlines the requirements and recommendations that dockless cycle share operators are expected to follow as part of delivering safe and effective cycle share schemes in Auckland.

If there is non-compliance by the Operator which is not remedied to a satisfactory degree, Auckland Council will revoke the license.

This Code of Practice will be reviewed and updated as required in the future so that it continues to reflect best practice and the interests of the Auckland community. The conditions will be subject to change throughout this transition.

It is important to note that Auckland Council needs to remain agile in its approach to issuing approvals due to big shifts in consumer behaviour and cycle share usage, and how each of these varies with seasonal weather for example. Auckland Council therefore reserves the right to issue approvals to operators using a phased approach to avoid saturating the streets with too many bikes.

For the purpose of this Code of Practice, Auckland Council refers to Auckland Council and its Council Controlled Organisations including Auckland Transport, and any person or organisation delegated by Auckland Council to act on its behalf.

## 2. Aim and scope

- 2.1. A key aim of this Code of Practice is to ensure that dockless cycle share schemes are well-designed and complement Auckland's cycle network development, public transport network and support our vision and our Urban Cycleways Programme.
- 2.2 This guidance applies to all Operators and sets out the operational and safety standards that Operators must adhere to in order to be issued, and maintain an approval to operate in Auckland under the Trading and Events in Public Places Bylaw 2015.

## 3. Engagement

- 3.1. Prior to launching a scheme, Operators must contact Auckland Council with a plan demonstrating how a proposed scheme will adhere to this Code of Practice, including how its operation will be terminated if it no longer meets the code and has its license to operate revoked. The plan must also address how bikes will be re-balanced around the city to avoid bunching.
- 3.2 Operators must retain an open line of communication with Auckland Council.
- 3.3 Operators must provide Auckland Council with the contact details of references that can provide information regarding the Operator's previous performance.
- 3.4 As part of the engagement process, Operators will work together with Auckland Council to determine an appropriate scheme size that is fit for purpose for Auckland.
- 3.5 Operators must seek Auckland Council approval of any promotion/media mentioning Auckland Council and its Council Controlled Organisations and Council activities.

## 4. Safety and maintenance

- 4.1 Operators must comply with relevant New Zealand health and safety regulations and hold public liability insurance of at least NZ\$1,000,000. The Operators must be able to show ongoing proof of their public liability insurance.
- 4.2 Operators must ensure each bicycle is always supplied with a helmet that meets current safety standards as required by New Zealand law.
- 4.3 Bicycle equipment must also meet legal requirements for riding a bicycle in New Zealand as specified in the Official New Zealand Code for Cyclists <a href="http://www.nzta.govt.nz/resources/roadcode/cyclist-code/">http://www.nzta.govt.nz/resources/roadcode/cyclist-code/</a>.
- 4.4 Integrated dynamo light systems are preferable but must continue to run while waiting at intersections.
- 4.5 Electric bikes must comply with the New Zealand Transport Agency's definition of a low-powered vehicle. Its electric motor must have a maximum power not exceeding 300W and be designed to be primarily propelled by the muscular energy of the rider.
- 4.6 Bicycle equipment must be of sufficiently high quality to withstand constant public use and exposure to the Auckland elements, while meeting rider safety and comfort standards. The bicycles should include smart technology with active Global Positioning System (GPS) and wireless connectivity to enable maintenance and proactive rebalancing.
- 4.7 Operators must have a system in place to ensure bicycle equipment, including helmets, continues to comply with legal standards and requirements. At a minimum, bicycles should be given a full service every six months, with both helmets and bicycles given regular checks and repairs throughout the year. All mechanical services and repairs must be logged and available for review by Auckland Council whenever requested or to an agreed reporting schedule.
- 4.8 Operators must recommend that registered users aged under 18 years of age should be accompanied by an adult.
- 4.9 Ideally, operators should be able to integrate on-bike location technologies and eventually on-board wireless diagnostics, to more easily identify mechanical failure, and proactively intervene through preventive maintenance. Auckland Council reserves the right to make these technologies a requirement in the future.
- 4.10 Accidents causing injury must be recorded and included in the data made available to Auckland Council.

## Operations

- 5.1 In order to operate a dockless cycle share scheme within Auckland, Operators must apply for and be granted a license, under the Trading and Events in Public Places Bylaw 2015 prior to any operation being launched. Auckland Transport has delegated both administration and enforcement of this bylaw to Auckland Council.
- 5.2 Auckland Council reserves the right to limit the number of operators and the number of bikes.
- 5.3 The operation of dockless cycle share schemes in Auckland must not cause disruption or nuisance. Operators must ensure cycle share schemes do not compromise the maintenance of orderly streets or have a negative impact on other street users, including vision-impaired people or those with disabilities.
- 5.5 Operators must come to an agreement with Auckland Council on where bikes can and cannot be parked. Bikes should be parked beside cycle parking stands where possible. If this is not possible they should be parked where they do not impede on pedestrian and vehicle access. This information must be conveyed clearly to the customer.
- 5.6 Damaged bikes or bikes parked in a non-compliant manner or place need to be removed by the Operators within 12 hours of being reported. If not, Operators will pay any removal costs incurred by Council. The cost to get the bike back from the Council after removal is \$371 per bike at time of writing this. This cost may alter over time.
- 5.7 Any bike that is parked outside a licensed area, for more than seven consecutive days must be moved by the operator to a licensed location or it may be removed by Auckland Council at the expense of the Operator.
- 5.8 Operators should have systems in place that incentivise good parking behaviour and penalise non-compliance by users.
- 5.9 Any specific infrastructure improvements required for successful operations would need to be considered and approved by Auckland Council and Auckland Transport.
- 5.10 Operators must have capability to manage the redistribution of bicycles due to bunching, in advance of major events or at the request of Auckland Council.
- 5.11 In order to manage the increase in the numbers of bikes on Auckland streets, bike parking requirements will be subject to change as Auckland Council adapts to the increase in bikes in Auckland as a result of these operations.
- 5.12 Operators must provide Auckland Council with up to date and relevant contact details for the operational point of contact who will resolve any issues that arise.
- 5.13 Although preferred, but not required at this stage, geofencing capability could be required in the future as Auckland Transport and Auckland Council establish best practice for Auckland. Auckland Council reserve the right to require Operators to ensure users do not park in specific areas.

## Customer Experience and Education

- 6.1 Operators must provide 24-hour communication channels for users, including a clearly advertised telephone number provided on their website, apps and bicycles and must also have a complaints handling process. Operators must be able to provide Auckland Council with a record of their complaints and response times logs when requested.
- 6.2 Terms and conditions of use must be agreed by users when they use the bicycle equipment and these terms must promote safe and legal riding, and good parking behaviour. This will include a link to the NZ Cycling Rules (<a href="http://www.nzta.govt.nz/resources/roadcode/cyclist-code/about-cycling/rules/">http://www.nzta.govt.nz/resources/roadcode/cyclist-code/about-cycling/rules/</a>).

## 7. Data requirements

- 7.1 All personal information must be collected, processed and stored in accordance with the requirements of the New Zealand Privacy Act 1993.
- 7.2 It is a requirement that anonymised data collected by the Operator is shared with Auckland Council to assist with ongoing network planning and cycle facility improvements. The clauses below sets out what data is required.
- 7.2.1 The following table outlines the usage data to be provided to Auckland Council for each trip record. This is to be sent to Auckland Council whenever requested or to an agreed reporting schedule.

- 7.2.2 Operators shall provide Auckland Council with real-time information on the entire fleet through a documented Application Program Interface (API) from day one. The data to be published to the Auckland Council API will include the following information in real time for every parked bicycle:
  - 1. Bicycle identification number
  - 2. GPS Co-ordinate
  - 3. Availability start date
  - 4. Availability start time
  - 5. Fuel level (if electric)

- 6. Date of last service
- 7. Time to next service
- 8. Service status
- 7.3 Customer data integration and transfer may be required in the future, both with Auckland Transport's journey planning platforms (including AT Mobile) and NZTA's Mobility as a Service project (as digital capabilities are extended). Auckland Council reserves the right to update this condition if or when required.
- 7.4 Operators will support the General Bikeshare Feed Specification (GBFS), an open data standard for cycle share. GBFS makes real-time data feeds publicly available online in a uniform format so that map and transportation based apps can easily incorporate this data into their platforms.
- 7.5 Auckland Council reserves the right to display information about cycle share operators on their websites. Auckland Transport may choose to integrate cycle share into Auckland Transports Mobile app.

# 8. Integration with the New Zealand Transport Agency's Mobility Marketplace

Currently, NZTA is piloting a Mobility as a Service (MaaS) project, which brings together any legal transport operators into a Mobility Marketplace. The Mobility Marketplace is powered by a real-time data processing platform, and operates on open data principles.

8.1 Operators of new transport services, including cycle share, should ensure the technological capability to integrate their services into this Mobility Marketplace, allowing customers to view all transport choices, in one place.

The information outlined in Appendix 1 will be pushed to a central MaaS Platform using an API (note: this feed could be pulled directly from the company's existing app). This system will query the transport service provider's database and return available options to the customers to view, compare, book, and (eventually) pay for this mode of transport.

Here are some stories likely to appear in the media over the next few days.

- · Lime scooters In response to an enquiry from Stuff about the company's launch in Dunedin this Thursday, staff advised the DCC recently met with Lime and developed an agreement on safety messaging and reporting incidents. The company does not require a permit to operate in Dunedin.
- New artificial turf, Logan Park We updated the ODT about the project, which is on track. Staff advised the finished playing surfaces won't be fenced as we want to keep Logan Park open. Staff explained that there is agreed usage with Football South as the main fundraiser, but this is a community asset which will be available for public booking.
- St Clair slip In response to a follow up enquiry from the ODT, staff advised that we are in regular contact with the property owners. EQC, the owners' insurance companies, or the owners are responsible for engineer Inspections. Our records show some work was needed on the foundations of one of the houses in 1992, but the need for the work wasn't clearly identified.
- · Conference location The ODT enquired why an upcoming conference was not being held in the city this year. Staff dld not give information about the industry involved, but confirmed Dunedin was considered and another location chosen. The event was expected to be held over two days and attract 300 people. We are working on a number of other events and our conference industry is doing well, worth approximately \$16.7 million a year.



Is Lime paying the DCC to run the share scooter service in Dunedin? If not why not? No Lime is not paying a fee as they do not require a permit to operate.

What if any rules or restrictions has the DCC placed on Lime Scooters use in Dunedin? such as speed limits or helmet use?

Any rules or restrictions relating to Lime scooters are governed by the NZTA under the Land Transport Act.

With regards to helmet use legislation stipulates when a helmet must be used by specified road users; e.g. cyclists, cycle pillion passengers, and moped users. Legislation does not require skateboarders or scooter users to wear helmets. Helmet use is a matter for central government.

Will the scooter be able to be used on the council's shared paths and cycleways? if not why not?

The scooters will be permitted on the footpath and road, but not on cycle lanes as these are only for cycles.

However they are permitted on cycle paths which are physically separated by a barrier or are off the road altogether.

Has the DCC sought to restrict the speed the scooters are allowed to be ridden on footpaths, similar to what is being suggested in Auckland?

- Currently the DCC does not have speed restrictions for scooters when ridden on footpaths but this question should also be referred to Sue as she may wish to add to this comment.



## Hi Lyndon

We cannot do a bylaw in a way that manages them - as Auckland and Chch have found. We have been looking at a public places bylaw but we can not over-ride NZTA's decision to allow them on footpaths, we can't set speed limits, we can't mandate helmets. We have little in the way of levers. The safeguards I imagine you want, we cannot mandate. Although Chch and Auckland have what they both call a 'trial' it is a quirk of their wording in their 'commercial use of footpaths' bylaw - but in reality they have the same limitations as we do.

We have been advocating to government around NZTA's rules - as it seems mandating helmets and cycleway use would be sensible. But to little effect thus far.

Lime have only just announced they are launching, since Simon went on leave. We knew they were coming but it was initially late November, early December, late December and now mid January.

Thank you for your email which Sue passed on to me. We are in discussion with NZTA and various teams across DCC to consider this issue. I have passed on your email to our legal team for consideration but haven't received a response yet.

However, from early discussions it seems that the best tool to control the use of these devices would be a bylaw rather than a change to the LGA or the Road User Rule. That way it would take into account the local situation, devices could be assessed against criteria and permits issued (or not) with restrictions on how they might operate (location, speed etc). However, we're testing this and will propose an approach for the Council to consider. We're also in communication with Auckland, Christchurch and Wellington Council about the issues we're facing and they have been a great help so far.

Lynley Hood has referred me to the Land Transport Road User Rule 2004 as amended in 2017 to enable road controlling authorities, such as councils to make bylaws allowing electric vehicles to use specified special vehicle lanes. From 1.9.17 it will be up to individual road controlling authorities to decide if they will make by-laws that allow electric vehicles access to any special vehicle lanes within their network. As the definition of an electric vehicle means a motor vehicle with motive power wholly or partly derived from an external source of electricity and an e-scooter is obviously not a motor vehicle are Councils now looking to Central Government to make further amendments to the Road User Rule 2004?

I note mobility scooters are already covered by the above Rules.



Has Lime and the DCC had any discussions about potentially launching the hire scooter service in Dunedin? If so when have those discussions taken place and how far along were they?

Lime met with Council staff for the first time a couple of weeks ago. At that stage, Lime indicated they would be launching their e-scooter service in Dunedin and wanted to explain how the service worked.

Does the company need to apply for a permit to operate in the city?

There is currently no framework for prohibiting e-scooters in Dunedin. However, we are in discussion with Lime about developing an agreement on safety messaging and reporting incidents.

We are currently exploring issues that exist, or may arise in the future, in our public places and how we may address these. The DCC is keen to have vibrant and liveable spaces within our city without compromising safety.

Has the company applied for a permit to operate the service in Dunedin? If not are the DCC expecting the company to make an application?

As above – there are currently no bylaws or regulations to issue a permit under.

If an application has been made, did the DCC know when the service might launch in Dunedin? (A ballpark estimate would be fine)

Lime indicated that it would likely be around Christmas.

If the company was to launch in the city would there be restrictions on where the scooters could be used? i.e footpaths/cycle lanes?

Here are some stories which are likely to appear in the media over the next few days.

- . Manor Place parking and safety improvements We sent a media advisory saying the DCC is planning to increase parking in Manor Place and install a small roundabout at the intersection of Manor Place and Melville Street. Between 2003 and 2009, six crashes were recorded at this intersection and the roundabout will improve safety and traffic flow. A total of 26 parking spaces will be added in Manor Place by converting parallel parks to angle parks. Kerbs will be extended to help create the angle parks, slow down traffic and make crossing the road easier for pedestrians. Consultation on this work closes on 30 November.
- · Lime scooters In response to an enquiry from the ODT, we said Lime has indicated to the DCC the e-scooter service would launch in Dunedin around Christmas, Lime has met with DCC staff to explain how the service works. We are currently exploring issues that exist, or may arise in the future around the use of e-scooters. This will inform the potential development of a public places bylaw. The DCC is keen to have vibrant and liveable spaces within our city without compromising safety, which will enable us to regulate e-scooters and other similar devices. However, any bylaw won't be developed in time before Lime launches. We're closely monitoring the situation in Auckland and Christchurch to see how the scooters are being used and what issues arise.
- Barnes Dance crossings, Albany St In response to an enquiry from the ODT, we said we're aware of NZTA's plans to trial Barnes Dance pedestrian crossings at the Great King and Cumberland St intersections of Albany St. We're supportive of the trial in an effort to provide safe and efficient crossings for pedestrians and cyclists.
