I am writing in response to your LGOIMA request of 2 August 2019 requesting information on Riccarton Road West, Mosgiel. Please find below answers to your request.

- 1 Is Council negotiating with any landowners to acquire or buy land on or along Riccarton Road West, and if so what purpose is the land being acquired for ?

*Yes. A landowner who had recently purchased a property along Riccarton Road West contacted the Council to enquire if we would be interested in purchasing a strip of his land to reconcile the road boundary with the boundary of adjoining land.*

- 2 Does the Council have any allowances in its current or future budgets to acquire land on or along Riccarton Road West, and if so what purpose is money noted as being applied ?

*No*
