Dear Chris

I refer to your request for information below about complaints filed against all Dunedin City Councillors since the start of this triennium. Please accept my apology for the delay in responding to you.

I understand that in terms of your questions, you are primarily wanting to know the details of who the complaint was made on behalf of (ie the person who the complainant raised as being bullied or harassed).

In most cases complaints have been made by witnesses rather than the person subject to behaviours. Complaints are recorded in Vault (our IT system) as 'sensitive' with names of the complainant (who is often not the person who was felt to be subject to bullying or harassment) not recorded. As such, we are unable to provide you with information on who has made the complaints.

1. Since the start of the current council term in 2016, how many complaints have been filed against all Dunedin city councillors?

Since October 2016, 12 complaints have been filed.

2. How many of those complaints are ABOUT (note, not from) council staff, and how many of those are female staff?
