In addition to the Dunstan Constituency values I confirm that for the 2019 triennial elections there were:

14,673 registered electors in the Moeraki Constituency, enrolled on the Waitaki DC electoral roll.

14,131 registered electors in the Molyneux Regional Constituency enrolled on the Dunedin CC electoral roll.

12,016 registered electors in the Molyneux Regional Constituency enrolled on the Clutha DC electoral roll.

79,276 registered electors in the Dunedin Regional Constituency enrolled on the Dunedin CC electoral roll.

LGOIMA request: Voting results into Wards for ORC Election 2019

Under the LGOIMA (1987), I request the following official information held by yourself in your capacity as Returning Officer for the most recent Otago Regional Council (ORC) elections;

1. **For the Dunstan Ward**, a breakdown of each candidate's vote based upon the Wards of the two territorial authorities (CODC and QLDC) involved - ie the votes for each of the candidates Bell, Bowman, Forbes, Hunt, Kelliher and Laws plus the separately recorded informal and 'blank' votes for each Ward;
2. **For the Dunstan Ward**, the same candidate breakdown but for the 'Special Votes' so allowed and processed;
3. **For the Molyneux Ward**, the candidate break down of votes recorded in each of the territorial authority districts - ie the Clutha District Council and the relevant part of the Dunedin City Council. that made up the Molyneux Ward.
