In response to your email request received on 2 September 2019, I provide a response to your request ::

I see in the ODT that you have a policy/policies about non-compliant buildings. Apparently included are that you are obliged to follow up all complaints and that you check the compliance of complainants as well. Could I please have a copy of the policy documents from which these 2 examples are taken.

Under section 17 of the Building Act 2004 (Act), 'All building work must comply with the building code to the extent required by the Act whether or not a building consent is required in respect of that building work.'

Additionally under section 40 the Building Act 2004 (Act), 'A person must not carry out any building work except in accordance with a building consent and a person commits an offence if the person fails to comply with this section.'.

The Council follows up on all customer complaints (requests for service). In regard to the issue of 'check the compliance of complainants as well', I advise that we are not aware of any specific policy documented for this, nor do Resource Consents have a policy to investigate the complainants site, therefore there is no documentation I am able to provide you as per your request.

I trust that this answers your query in relation to your request as stated above.
