#### **DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE**

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

#### **DECISION**

This is an application by Ganen Lin Limited for an alcohol on-licence in respect of the premises situated at 282 Moray Place, Dunedin, and known as "Wong Gok". The applicant has asked that the licence is endorsed pursuant to s.37 of the Act which makes special provision to identify the premises as having a BYO style licence.

The application results from a change of licensee. The premises is currently operating under a temporary authority.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an on-licence authorising the carriage of alcohol to the premises by patrons for consumption on the premises. Any alcohol not consumed may be removed by the person who brought it to the premises so long as the container in which it was brought remains sealed or has been resealed.





## **INTRODUCTION**

- [1] The applicant has applied for a special licence with two events on the one application. The first is for New Year's Eve on 31 December 2019 and the other is for Friday 10 April 2020 which is Good Friday when the Highlanders play the Chiefs at Dunedin.
- [2] The reporting agencies indicated that the New Year's Eve part of the application is not opposed and agreed that this part of the application should be separated from the opposed portion.
- [3] A request to change the hours for the Good Friday was received on 28 November 2019 asking that the hours are 2.30 pm to 4.00 pm and 'an hour' when the bus returns to the premises so safe transport home can be arranged.

## Mr Alexander

- [4] Mr Alexander is the General manager of the St Kilda Tavern. He apologised for the wrong information being included on the application. He was completing it in haste so he could get the application in before he went on holiday in the past an application was submitted late for the new year and was subsequently declined. He decided to append the Good Friday request on to the same application.
- [5] The applicant has 20 season passes for when the Highlanders play a Super 15 fixture at the Forsyth Bar Stadium. The same people utilise the passes each game along with about six others with their own passes. In total there are 30 people at the maximum who are part of the group that go to the stadium. Not much alcohol is consumed with some not drinking at all.
- [6] Whenever there is a game at the stadium those with season passes meet at the premises, have something to eat and a drink before getting onto a bus which will take them to the game. When the game is over they go back to the tavern where they arrange safe transport home. While they are waiting for their rides some may want to have another drink, use the bathroom, etc.
- [7] On 10 April 2020, Good Friday, the Highlanders will be playing the Chiefs at the Forsyth Barr Stadium at 5.00 pm. The Act does not allow premises to trade on Good Friday unless the people present are there to dine or there is a special licence in place. The applicant decided to apply for a special licence for the evening even though there was a possibility he did not need one.
- [8] On the day the applicant said those going to watch the game would be the only people present at the premises. There would be a free barbeque put on for those turning up from 2.30 pm and drinks for those who want them. At 4.00 pm they would get on the bus to go to the stadium. When the bus returns after the game sometime between 6.45 and 7.00 pm, the applicant would like to be able to take them from the bus to inside the premises while transport is organised. Some may want to use the bathroom, have a beer while others a cup of tea/coffee and possibly a snack.
- [9] The applicant said he did not apply for special licence for either the Ed Sheeran Weekend in Easter 2018 nor the Rugby World Cup (RWC2019) because he felt that a lot of the people who would have turned up would not have been present for either of the two events. This time, however, the people who will be present will be Highlanders supporters.
- [10] In response to questions from the Committee Mr Alexander said anyone not being part of the group who intended to enter the premises would be told it was a private function and there would be no entry allowed.
- [11] When asked about the 'event', the applicant admitted the event was at the stadium, not the tavern, but there have been precedents set with Ed Sheeran and the RWC2019.
- [12] The applicant confirmed to the Committee that the group comes together for games at the stadium only, not away games. He said they could put on a meal to have during a televised game but wouldn't be sure it would work. He would rather be up front and honest and not 'sugar-coat' a situation.
- [13] The Police asked if, when the bus returned from the stadium, there would be anything different at the premises than would be the case on any ordinary evening. Mr Alexander said it wouldn't really be any different other than the barbeque being used instead of the kitchen. The people would get off the bus and go inside while transport is arranged. He said he would rather have them inside than standing around the carpark, especially if it was a cold day. Even if they could go inside without the bar being open would be fine. They would be sheltered and be able to use the bathroom and may be have a tea/coffee and snack. It isn't necessary to serve alcohol. He said they might only be there for 30 minutes before they are picked up.

[14] Ms Blair asked how he would ensure people there would be eating. Mr Alexander said one couldn't force them to eat but the food would be available. The group that will be there will eat because it'll be available. They are a group of mid to late aged people who come together with the common interest in the Highlanders Rugby team.

## **Sgt Paulin**

- [15] Sgt Paulin is the Alcohol Harm Prevention Officer for the Dunedin area.
- [16] He circulated his evidence prior to the hearing and this was taken as read. In summary, he does not believe the proposed event meets the criteria for a special licence. He said a special licence enables a licensee to sell and supply alcohol to people attending an event: an event is described in the Act as being an occasion or a gathering. On this occasion, the event is at the Forsyth Barr Stadium and not the premises for which this special licence is sought.
- [17] At the outset the Police commented that, if the barbeque proposed by the applicant is substantial and requires eating utensils then no special licence would be required for the period before the bus is to leave for the stadium.
- [18] Sgt Paulin described the characteristics of a 'social gathering' that should be considered for a special licence as set out in the often quoted "Fitzroy Tavern", Magistrates Court, New Plymouth 2/12/77 decision. They are:
  - a. There must be a purpose for the function or gathering other than the mere enjoyment of the bar facilities
  - b. Liquor consumption must be ancillary to the true purpose
  - c. Attendees must only be promoters, the participants and specially invited guests who are participators to the principal activity
  - d. The gathering must come close to being "special"
  - e. Regularity is not necessarily a disqualifying feature.
- [19] The Police also cited the Bullock Bar Limited and The Luggate Hotel Limited (QLDLC 0012/14) which reinforced the above and offers the following to help the decision-making process:
  - a. The price of entry. The lower the price the more members of the general public the applicant appears to be encouraging to attend
  - b. Whether there is some generic factor with the customers (such as guests at a wedding or people with a special interest in the event)
  - c. Whether it is anticipated that members of the public will attend. It will be noted that under s.147(1)(h) of the Act a licensing committee may impose a condition excluding members of the from the premises
  - d. Whether the intrusion into Good Friday and/or Easter Sunday is significant or restrained. In other words, whether the applicant seeks to trade for as many hours as possible
  - e. Whether a reasonable person attending the event would immediately notice a difference between the ambience of the occasion and any other trading day
- [20] And finally, the extent of the planning that has taken place, and the thought that has been given to the way the event is to be run. The less organised the applicant, the more likely that the event has been thought about after the decision has been made to apply for a special licence.
- [21] The Police submit that, after considering previous decisions, this application does not meet the criteria to be issued a special licence for when the bus returns from the stadium, assuming the meeting before embarking on the bus is considered them being present to dine.

[22] The Committee sought the Police view on the supporters being able to use the premises after the game but without any alcohol being involved, for example, to shelter from the weather if required, use the bathroom, etc. Sgt Paulin said no-one can be in an on-licensed premises outside of normal trading hours unless they are present to dine or there is a special licence in force. The Act requires premises to be closed on the sacrosanct days therefore being in the premises on Good Friday would be a breach of the Act in that the applicant would be allowing them on the premises outside licensing hours.

#### Ms Paterson

- [23] Ms Paterson is delegated by the Medical Officer of Health to carry out their functions pursuant to the Act.
- [24] She prepared a submission for the Committee and is accepted as being read. In summary Ms Paterson said the pre-game component of the day would not require a special licence because the attendees will be dining, so long as it is a substantial meal, before leaving for the stadium.
- [25] However, the post-game element of the application is of concern. Ms Paterson does not believe a genuine event has been proposed and therefore the special licence should not be granted. Various caselaw is cited in the evidence which is similar to that of the Police therefore it will not be repeated here.
- [26] Ms Paterson said it appears as if the Good Friday date was included on the New Year's Eve application as an after thought with no real thought having gone into it. She suggested the applicant could have contacted the agencies who would have pointed out the legislative requirements and supporting caselaw.

## Ms Blair

- [27] Ms Blair is a Licensing Inspector for the Dunedin City Council.
- [28] She highlighted the same concerns expressed by the Police and Medical Officer of Health, emphasising that the event was at the Forsyth Barr Stadium, not the St Kilda Tavern. Ms Blair said there was no special licence required for when they meet before going to the game because there was going to be a meal for everyone. However, there was no organised event arranged for when they returned to the tavern after the game.
- [29] Ms Blair told the Committee this was an important decision because it may set a precedent for the industry. If it is granted we could expect to see a lot more applications with the applicants using the same type of argument to justify trading on the sacrosanct days.

## Mr Alexander

[30] In his final comments Mr Alexander said he has always tried to be honest and up front, that is why he applied for this special licence. He said he could set up the barbeque for when the bus returned after the game but all he wants to do is allow the supported access to the tavern while safe transport is arranged. While he would like them to get home as quickly as possible, it takes time. He would prefer them to wait inside instead of in the carpark. The service of alcohol is not necessary after the game.

## DECISION

[31] This application is to allow Highlanders rugby supporters to be able to meet at the St Kilda Tavern before going to a home game at the Forsyth Barr Stadium and then to use the facilities after the game while they arrange safe transport home. The game is on Good Friday, a day during which

on-licensed premises must be closed unless there is a special licence in force or the patrons a present to dine.

- [32] A special licence can be granted to allow the licensee to sell and supply alcohol at the premises to people attending an event described in it where an 'event' is described in the Act as an occasion or gathering.
- [33] It is clear from the evidence that the Committee has heard that there is no need for a special licence for when the supports meet prior to leaving for the game at the stadium. A barbeque will be put on for those who turn up early and one assumes this will be a substantial meal to ensure they are well fed before watching the game.
- [34] The applicant indicated during the hearing that the sale of alcohol when the supported return after the match is not necessary, but he would prefer them to wait inside the premises while they arrange their safe transport home. They would be able to use the bathroom and if there was poor weather, they would have shelter.
- [35] Prior to finalising this decision, the Committee received notice that the applicant has withdrawn the part of the special licence application pertaining to Good Friday. He does not need a special licence to put on a substantial barbeque meal prior to leaving for the game and afterwards, the applicant will keep the supporters away from the premises while they wait for their rides home.
- [36] We would like to think the agencies would take a pragmatic approach if the applicant allows a supporter access to the premises to use the bathroom facilities.
- [37] There being no decision to be made the matter is withdrawn and no further action required.


