In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

DECISION

DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

DECISION

This is an application by General Distributors Limited for the renewal of an alcohol off-licence in respect of their premises situated at 323 Andersons Bay Road, Dunedin, and known as "Countdown Dunedin South".

While the application is for a roll-over of the present conditions, the trading hours are required to be amended to bring them within the maximum allowed in Dunedin's Local Alcohol Policy.

The application was duly advertised and no objection has been received.

The application was, however, opposed by the Medical Officer of Health because they did not believe the single alcohol area complied with the legislation. Changes were made to the layout of the premises and several attempts were made to meet a representative in Dunedin however the meeting never took place.

There have been several appeal hearings in relation to single alcohol areas in supermarkets in the time the application has been on hold. The licence is due to expire in June 2019, so the Medical Officer of Health has withdrawn their opposition to allow the licence to be renewed. The single alcohol area will be reassessed when the renewal application is received.

Accordingly, we deal with the matter on the papers.

The Licensing Inspector has assessed the application against the criteria in the new Act and is satisfied that if the application was made pursuant to the new Act, it would be granted.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and therefore renew the licence until 19 June 2019, that being the anniversary date of the licence and three years from the most recent date of expiry, and authorise the issue of a replacement licence and notice of renewal.

The single alcohol area as depicted on the attached plan is deemed to be acceptable



The application is for a roll-over of the present conditions.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

The applicant has had several problems with the premises in the time he has had it. They have obtained a building consent to carry out remedial work, so they can increase the numbers able to be present and to be able to host events. However, the consent has been set aside in the meantime and the applicant will continue to trade as a restaurant.

The Building Compliance Officer at the Dunedin City Council carried out an audit of the premises and has found several deficiencies. He will repeat the audit in 12 months.

The Licensing Inspector has indicated there is only one certified manager at the moment but Mr Broad, the Director of the applicant company, has indicated he will be sitting the Licence Controller Qualification, so he may apply for a manager's certificate.

The matters identified in the building audit are more administrative failings, with the exception of a blocked egress from the building. If the audit to be carried out in 12 months continues to find problems, there may well be consequences pursuant to the building legislation with an associated impact on the alcohol licence.

We also urge Mr Broad to complete the LCQ as soon as possible so there is a second certified person when the premises is operating.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and therefore renew the licence until 1 November 2021, that being the anniversary date of the licence and three years from the most recent date of expiry, and authorise the issue of a replacement licence and notice of renewal.
