**DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE**

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

**DECISION**

This is an application by The Dunedin Rugby Football Club Incorporated for the renewal of an alcohol club licence in respect of their premises situated at 16 Moana Rua Road, Dunedin, and known as the "Dunedin Rugby Football Club".

The applicant has sought a variation to their trading times so they better suit the club membership. Their current trading hours are Monday to Thursday 6pm to 10pm and Fridays 6pm to 11pm. They have asked if they could be varied to Monday to Thursday 3pm to 10pm and Fridays 3pm to 12 midnight. The weekend hours are to remain unchanged.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

The Licensing Inspector has assessed the application against the criteria in the Act and is satisfied that the premises is being operated properly and there are no concerns regarding the suitability of the applicant.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and therefore renew the licence, with the extended trading times, until 1 June 2022, that being the anniversary date of the licence and three years from the most recent date of expiry and authorise the issue of a replacement licence and notice of renewal.

**DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE**

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

**DECISION**

This is an application by R C & P J Flannery Limited for an off-licence in respect of the premises situated at 133 Great King Street, Dunedin, and known as "Centre City New World".

The premises is a supermarket in terms of s.32(1)(e) of the Act. The single alcohol area is shown on the attached plan.

The application results from a change of licensee. The premises is currently operating under a temporary authority.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

The premises is in one of two large supermarkets in Dunedin's central business district.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an off-licence authorising the sale and supply of alcohol for consumption off the premises, and to supply alcohol free, as a sample, for consumption on the premises.

The applicant's attention is drawn to ss.56 and 57(a) of the Act obliging the holder of an off-licence to display:-

1. A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; AND,
2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; AND,
3. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

The licence will be subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day

(b) Alcohol may be sold only on the following days and during the following hours:

**Monday to Sunday                      7.00 am to 10.00 pm**

(c) No alcohol may be sold other than—

- i) beer that complies with the appropriate New Zealand food standard for beer; or
  - ii) mead that complies with the appropriate New Zealand food standard for mead; or
  - iii) fruit or vegetable wine that complies with the appropriate New Zealand food standard for fruit or vegetable wine; or
  - iv) grape wine that complies with the appropriate New Zealand food standard for grape wine; or
  - v) a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
- (d) While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being provided
- (e) Only the area delineated on the attached plan is a permitted area for the display and promotion of alcohol.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance(s) to the premises as outlined in the plan received by the Dunedin District Licensing Committee on 17 June 2019. The entrance from the carpark designated as the principal entrance.

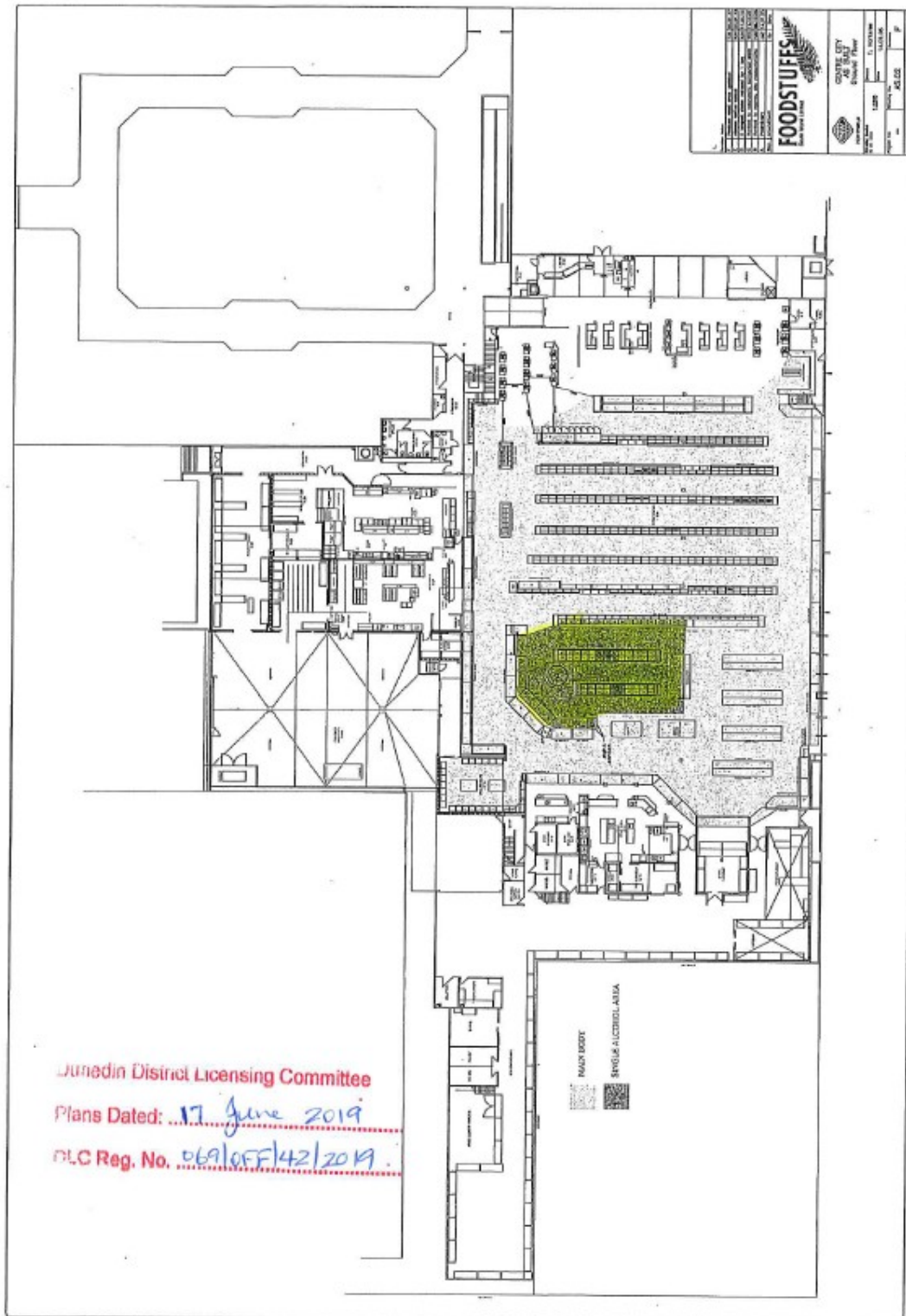

**INTRODUCTION**

- [1] This is an application by Sri Sai Liquor Limited for an off-licence for the premises situated at 111 George Street, Dunedin, and to be known as "Dunedin Fine Wines & Spirits". The premises is currently being operated pursuant to a temporary authority.
- [2] The applicant has a sole director and shareholder, Ms Himabindu Korella. She owns three other off-licensed premises in the Auckland area, none of which have been the subject of any enforcement action. Ms Koralla's husband, Mr P Garnepally, is at the hearing to speak on her behalf.
- [3] The applicant is seeking to trade Monday to Sunday from 10.00 am to 10.00 pm and they are seeking a supervised designation for the premises.
- [4] There have been no public objections received however the regulatory agencies, Police and Medical Officer of Health, have opposed the application with the support of the Licensing Inspector.

**HEARING**

**Mr P Garnepally**

- [5] Mr Pavithran Garnepally is the husband of the sole director and shareholder of the applicant company. He said they own three premises in the Auckland area and have never failed a controlled purchase operation (CPO) nor have any of the store's licences been suspended. He said his wife's role is in the 'back office' and does not have anything to do with the day to day operation of the stores.

- [6] Mr Garnepally said he manages the three Auckland stores and his brother, Mr Sricharan Garnepally, will be the manager of the Dunedin store. He has worked in bottle stores for the past three years.
- [7] He said when the Dunedin store was purchased it was with the intention of renovating it. He admitted that when the agencies visited the store it was messy however, this was because they were in the middle of carrying out renovations and, because of the time of year, there had been delays in getting work carried out.
- [8] The renovations for the store include the addition of a 12 door, walk-in chiller. There will be eight doors displaying white wines and four displaying craft beers and ciders. The mainstream beers and RTDs will be located at the rear of the chiller and will not be visible from the street or from inside the store itself.
- [9] Mr Garnepally said when they bought the premises they were not told that the previous operator had conditions imposed on the granting of the licence.
- [10] The hours sought in the application are to ensure they are competitive with the other two bottle stores in the centre of town. If they were to close earlier than the other premises they would lose their place in the market. However, if it is very quiet, especially earlier in the week, the store will be closed early.
- [11] Mr Garnepally emphasised that the product range will match the name of the store, that is, there will be fine wines. They also intend to carry a range of organic wines and those suitable for Vegans. There will be a wine display at the front of the shop to attract people to the store.
- [12] All of the spirits will be on shelves behind the counter where they will be 'protected' by the staff in the store.
- [13] As well as alcohol the store will also sell low and non-alcoholic beverages, tobacco products and a range of snacks. They will ensure there is always water and appropriate food available whenever they have tastings.
- [14] After meeting with the reporting agencies Mr Garnepally accepts they shall not display beer or RTDs at the front of the store.
- [15] The target market for this store will be people working in the area and tourists to town who wish to purchase high-end product. He said they cannot compete with 'franchise' stores because of their purchasing power and will not have this store arranged to look like such a store.
- [16] The premises is about 150m from the Octagon where many of the late night venues are located. Mr Garnepally said they will not sell single cans of beer or RTDs in sizes less than 500ml to minimise the risk of people pre-loading or side-loading.
- [17] Mr Garnepally presented recent photographs of the store and explained the layout. He also showed photos of their Auckland stores which have been operating for some time so the Committee could get a better understanding of their intentions. Signage for the store will consist of the premises name on the front window and on a sign under the verandah over the footpath. There will be a wine display visible from the footpath but no advertising.
- [18] The Committee sought clarification of the single unit sales. Mr Garnepally said they would sell single craft beers which are more expensive than mainstream product. At the moment they only had two shelves for the craft beer but would like to expand this area.
- [19] When asked if he understood the dynamics of the people in the area Mr S Garnepally said he had worked in the store for the last three months and has noted that the majority of people walking past are business people and visitors to the city who look at the wines and spirits. There are a lot of students who walk past and occasionally they try to buy single cans however sales are not made.
- [20] When asked by the Committee Mr Garnepally said they wanted to concentrate on fine wines and spirits. He said he did not believe Dunedin had a premises with this kind of focus.

- [21] Sgt Paulin asked about RTDs and a 'White Rhino' promotion. Mr Garnepally acknowledged that the 'White Rhino' is a popular drink and admitted promoting it on line but said it was for a good cause. RTDs are not promoted generally either on-line or in store.
- [22] In response to another question from Sgt Paulin he said that they could not compete with the franchise stores and had no agreement with them. He said they have bought product from one of the franchise stores but said they could not sell it for the prices charged in those stores.

### **Sgt Paulin**

- [23] Sgt Paulin is the Police Alcohol Harm Prevention Officer for the Dunedin area. He has opposed the grant of this licence on the grounds of the object of the Act, the suitability of the applicant, design and layout of the premises and whether the applicant has appropriate systems, staff and training to comply with the law.
- [24] He said that he was surprised when he and the other agency representatives visited the store and found a wide range of RTDs and 'high octane' beer being displayed near the shop entrance. He said it did not give the appearance of a high-end bottle store.
- [25] Sgt Paulin also stated that the Police data indicated the inner-city area had a high number of alcohol-related harm incidents and that the good order and amenity of the area will get worse if this premises is licensed.
- [26] When asked Sgt Paulin said George Street was still the main thoroughfare for the students. Between 11.00 pm and 2.30 am the area was 'packed' with students.
- [27] The Committee asked why Sgt Paulin considered the applicant to be unsuitable to hold a licence. He said it was based on the White Rhino promotion, although he acknowledged it was only promoted on line and could not be ordered. He said Super Liquor and Liquorland stores promoted it in their stores and did not want to see the same happen in the main street.

### **Mr Mole**

- [28] Mr Mole is one of the Licensing Inspectors for the Dunedin City Council.
- [29] He provided a brief history of the store saying that when it was first licensed after a hearing in April 2017, it was on the understanding that it would not be open at times when the problem of pre-loading was prevalent and that it would not compete on price with the other franchise-based off-licences. When the licence was renewed after 12 months the closing time was extended to 10.00 pm.
- [30] The agencies are now concerned that the new owner is moving away from the high-end product on which the first licence was based. A walk-in chiller was being installed and at the time of the agency visit there was a display of beer in the front window and there appeared to be a greater range of RTDs available.
- [31] Mr Mole noted that stores intend to sell high-end product soon change when the 'economic realities' become apparent.
- [32] Mr Mole did acknowledge that the Local Alcohol Policy does provide some assistance in reducing alcohol related harm with the maximum closing time of off-licensed premises now at 10.00 pm.
- [33] When asked Mr Mole said "Meenan's Liquorland" and "Henry's" tended to sell the high-end products but they do sell the mainstream products as well.
- [34] After a brief adjournment where the applicant met with the reporting agencies Mr Garnepally said that he had come to an agreement with the agencies regarding the store including that they would not sign up to any franchise, will not display RTDs or beers within the shop itself and will not sell single cans of beer or RTDs less than 500ml, with the exception of craft beers.

- [35] The Committee adjourned the hearing to allow the parties the opportunity to prepare and present their final positions in writing. The applicant's position was circulated to the agencies and some dialogue took place between them.
- [36] After considering the party's positions the Committee was satisfied they had sufficient information with which to make a decision without the need to reconvene.

### **RESERVED DECISION**

- [37] The applicant has responded with a list of undertakings that they have agreed to after discussion with the agencies. They are:
- a. The applicant will not separate retail ready packaging of beer and RTD products and that they would not sell single units of beer or RTDs in less than 500ml packaging except for boutique or handcrafted beer or cider.
  - b. There will be no signage or advertising of any RTD products or mainstream beer externally visible from the premises.
  - c. The applicant would not undertake a franchise agreement with a mainstream branded bottle store chain during ownership of the premises.
- [38] The agencies expressed concern that the applicant proposes to sell high alcohol beers like Haagen Strong Lager and Kingfisher Strong which are greater than 7% alcohol. They said these products are the 'go to' drinks for people who want to get 'value' for their money with each 500ml can being approximately 2.4 standard drinks. Further, they believe the sale of such product is not in keeping with the name of the premises.
- [39] In response the applicant has pointed out that they buy these brands from the wholesaler in 24 packs. They would not sell them in the wholesale packs and therefore they must separate the packs to sell single cans of 500ml each. It has also been pointed out that these products are sold in nearby supermarkets for less than the applicant will sell them.
- [40] The Committee does not believe either party will move in their respective positions so we have not called for a resumption of the hearing.
- [41] The premises for which this licence is sought comes under section 32(1)(b), that is, it is a retail premises where, in our opinion, at least 85% of the annual sales revenue is expected to be earned from the sale of alcohol for consumption somewhere else. It is a bottle store and the Committee has no ability to restrict the type of alcohol that may be sold in the premises.
- [42] A view of the outside of the premises gives the impression of a small, discrete bottle store. Other than the name of the premises, there is no outward facing advertising. The display of alcohol seen from the public space comprises wines and spirits.
- [43] Inside the premises there is a chiller on the left hand side about a third of the way into the store itself. Again, there is no indication of what may be in that part of the store. There is no advertising of beer or RTDs visible until one enters the chiller.
- [44] The Police opposed the application for the following reasons:
- a) the object of the Act;
  - b) the suitability of the applicant;
  - c) design and layout of the premises; and
  - d) whether the applicant has appropriate systems, staff and training to comply with the law.
- [45] The Medical Officer of Health also opposed the application believing the amenity and good order of the location was already so badly affected by the effects of issue of existing licences that while it would unlikely be further reduced, that it was not desirable to issue any further licences.
- [46] The object of the Act is that the sale, supply, and consumption of alcohol should be undertaken safely and responsibly and that the harm caused by the excessive or inappropriate consumption of alcohol should be minimised. The Police did not elaborate on

their reasons for believing the applicant's business would be contrary to this object. Sgt Paulin did briefly discuss the sale of 'high octane' beers from the premises but we do not see that the sale of these products is contrary to the object of the Act.

- [47] The suitability of the applicant to have a licence was not canvassed. When asked by the Committee, Sgt Paulin said he based this opposition on the fact that a product called White Rhino was promoted on line but during the hearing acknowledged that the product could not be ordered on line. There was no further discussion regarding the applicant's suitability.
- [48] The design and layout of the premises was also challenged. While this was not discussed at any length, there is no display of beer or RTDs visible from the street, nor from the front of the premises. There was some discussion about such displays soon after the applicant began trading from the premises but this was explained by the applicant in their evidence that it was when the premises was being refitted for their use. The products had to be put somewhere. We assume the Police report was completed after the agencies visited the premises but before the final layout was completed. We do not find the design nor the layout of the premises to be an issue.
- [49] The systems, staff and training to be used at the premises was one of the grounds for opposition but again, this was not raised during the hearing.
- [50] The Police indicated that there was a high number of alcohol-related harm incidents in the inner city and they believe the amenity and good order of this area will be decreased further if this licence is granted. Sgt Paulin also said the students from North Dunedin used George Street as their main thoroughfare to and from the central city between 11pm and 2.30am. The Committee notes that this is after the city's off-licensed premises are closed.
- [51] The amenity and good order was not cited as a ground for opposition by the Police but it was by the Medical Officer of Health (MOH). Unfortunately, the MOH did not present any evidence nor speak to their report. We will, however, comment that this is an application for an existing premises therefore it is unlikely the amenity and good order will be further reduced by the grant of this licence as suggested in the report from the MOH. The premises is closed at the more risky period when people are walking in to town therefore we see no reason to consider it undesirable not to grant this licence.
- [52] In *Foodcorp Distribution Limited*, [2013] NZARLA PH 511, at [37], the Authority cited evidence presented by Professor Connor from the University of Otago that noted how young people were inclined to purchase alcohol on the spur of the moment and often when intoxicated. The off-licensed premises in the city are closed by 10pm therefore the spur of the moment purchases by any young person walking to town during the busy period has been eliminated.
- [53] Mr Mole said the agencies were concerned that the new owner is moving away from the high-end product on which the first licence was based. This application has been submitted by a new entity and while they have indicated they would be focussing on fine wines and spirits, there is nothing to preclude them from selling mainstream beer and RTDs. They stated that they will not sign a contract with any of the franchise style premises and therefore would never be able to compete with such outlets on price. The applicant has also stated there would not be any signage or advertising of RTDs or mainstream beers visible from the street therefore there should be nothing to 'attract' people looking for cheap alcohol.
- [54] The Committee is satisfied the applicant meets the criteria we must have regard to in section 105 of the Act therefore we grant the applicant an off-licence authorising the sale and supply of alcohol to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The undertakings made by the applicant and stated in a letter circulated after the hearing will also be accepted.
- [55] For clarity, the undertakings conceded by the applicant are:
  - (a) The applicant will not separate retail ready packaging of beer and RTD products and that they would not sell single units of beer or RTDs in less than 500ml packaging except for boutique or handcrafted beer or cider.
  - (b) There will be no signage or advertising of any RTD products or mainstream beer externally visible from the premises.

- (c) The applicant would not undertake and franchise agreement with a mainstream branded bottle store chain during ownership of the premises.

While these are not conditions on the licence itself the licence is granted conditional on these undertakings. Any breach of the undertakings will raise questions regarding the suitability of the applicant.

[56] The applicant's attention is drawn to ss.56 and 57(a) of the Act obliging the holder of an off-licence to display:-

- (a) A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of liquor; AND,
- (b) A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; AND,
- (c) A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

[57] The licence will be subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day
- (b) Alcohol may be sold only on the following days and during the following hours:  
**Monday to Sunday                      10.00 am to 10.00 pm**
- (c) The whole of the premises is designated a supervised area.
- (d) While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- (e) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.

[58] A copy of this licence must be displayed at the principal entrance(s) to the premises as outlined in the plan received by the Dunedin District Licensing Committee on 24 January 2019. The entrance from George Street is designated as the principal entrance.

[59] The performance of the premises will be considered against the section 105 criteria at the first renewal in 12 months.

[60] The licence will not be issued until after 10 working days from the date this decision is notified to the parties and no appeal has been lodged with the Authority.
