### **DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE**

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

#### **DECISION**

- [1] This is an application by Petridish Limited for an on-licence in respect of their premises situated at 8 Stafford Street, Dunedin, and known as "Petridish". The general nature of the business to be undertaken is that of an entertainment venue.
- [2] The premises has not been previously licensed therefore there is no temporary authority in place.
- [3] The application was duly advertised and no objection has been received.
- [4] However, the reporting agencies (Police, Medical Officer of Health and Licensing Inspector) have raised an issue for consideration.
- [5] Another licensee has a lease on part of the ground floor and they have recently extended their licensed area into a 'common area'. Until the first renewal of that licence they were utilising a caterer's on-licence to cater for and serve alcohol for functions in the common area. They do not use the space all of the time.
- [6] The applicant in this matter also seeks to have the common area included in the defined area on their licence. Like the other licensee, this area would only be used for functions and at times when the space is not being used for other purposes.
- [7] The Police have asked for a hearing to be convened so that the Committee might be satisfied there would be no conflict over the use of the area. The Medical Officer of Health has asked for the matter to be referred to the Alcohol Regulatory and Licensing Authority for a determination. Both have stated in their reports that both licensees have indicated there would be no conflict over the use of the space but seek clarification because the legislation does not appear to cover this situation.
- [8] The Committee directed the Secretary to contact the Authority who advised us to seek a legal opinion locally. They would not offer an opinion.

- [9] Legal advice was obtained in Dunedin, so we will deal with the matter on the papers with assistance from the opinion. As has been pointed out by the agencies, the Act is silent, no doubt because of the unique nature of the situation.
- [10] Premises is defined in the Act as including any part of a premises and, in relation to a licence, means the premises it was issued for. The Oxford Dictionary defines "premises" as the building and land occupied by a business.
- [11] A licensed premises is defined in the Act as any premises for which a licence is held.
- [12] We then look at the Act's definition of a licence in relation to a licensed premises. Section 5 of the Act defines it as meaning the licence issued for them (or, in the case of premises that 2 or more licences have been issued for, any of those licences). The Act does not clarify whether the multiple licences are held by one licensee or they can be held by different licensees.
- [13] The Committee has three questions to consider:
  - a. Is the 'common area' in the building a 'premises'?
    - We find that 8 Stafford Street is a premises and that, while the 'common area' is within the building, it can be consider a premises in its own right.
  - b. Can the 'common area' have two licences?
    - As mentioned above, the Act allows for more than one licence for a premises but does not state whether the licensee must be the same or can be different. As the Act does not preclude there being two licensees, we find this licence can be issued to a second licensee.
  - c. This leads to the more vexed question will there be sufficient control over the 'common area' to ensure there will not be a conflict with its use?
    - Both the Police and Medical Officer of Health have indicated that the applicant and current ground floor licensee have stated the space will only be used for functions and that they will not use the space in conflict with the other. They have stated this to the reporting agencies, so we will assume they will keep their word.
- [14] We find the licence can be granted to Petridish Limited but on the condition that they will work with the other licensee to ensure there is a separation of functions to avoid conflict. If there is to be two functions on the one day we would expect there to be a period when the 'common area' is vacated to clean up/set up and to ensure there is a clear separation of control of the space.
- [15] We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol for consumption on the premises, to any person who is present on the premises.

This is an application by Hospo Venues Limited for the renewal of an alcohol on-licence in respect of THE premises situated at 142 Princes Street, Dunedin, and known as the "xyz".

This is the first renewal for the premises and is for a roll-over of the present conditions.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

The Licensing Inspector has assessed the application against the criteria in the Act and is satisfied that the premises has been operated properly.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and therefore renew the licence until 16 October 2022, that being three years from the first anniversary of the licence and authorise the issue of a replacement licence and notice of renewal.
