DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

DECISION

This is an application by Savour Society Limited for a **new** off-licence, endorsed as a remote seller, in respect of their premises situated at 9 Montreal Street, Dunedin, and known as "Robin Hood Drinks".

The application is in respect of premises in which the principal business is the sale of alcohol.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an off-licence, endorsed as a remote seller, authorising the sale and supply of alcohol for consumption off the premises.

Although sales are made remotely, the licensee must ensure a certified manager is appointed to the business at all times.

Remote sellers have different requirements to other premises. The first is a response to the fact the buyer is not confronted at the time of purchase and to this end, regulation 14 of the Sale and Supply of Alcohol Regulations 2013 details the requirements imposed on licensees to ensure prohibited people do not purchase alcohol. This regulation is reproduced here for clarity:

14 Reasonable steps to verify that people not under purchase age

- (1) The procedures described in subclauses (2) to (4) are reasonable procedures for the purposes of complying with <u>section 59(3)</u> of the Act (which requires the holder of an off-licence to take reasonable steps to verify that the buyer of any alcohol that the holder sells by remote sale (and, if a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age).
- (2) In the case of an order made using an internet site, the procedure is to—
 - (a) ask the prospective buyer to declare, by ticking an on-screen box, that he or she is 18 years of age or over (and, where a prospective receiver is involved, that the prospective receiver is also 18 years of age or over)—
 - (i) once when the prospective buyer first enters the internet site; and
 - (ii) again, immediately before the sale of any alcohol is completed; and

- (b) refuse to sell alcohol to the prospective buyer unless, on both occasions, he or she declares that he or she is 18 years of age or over (and, where a prospective receiver is involved, also declares that the prospective receiver is 18 years of age or over).
- (3) In the case of a telephone order, the procedure is to—
 - (a) ask the prospective buyer to declare, orally, that he or she is 18 years of age or over (and, where a prospective receiver is involved, that the prospective receiver is also 18 years of age or over)—
 - (i) once when the conversation concerned begins; and
 - (ii) again, immediately before the conversation is completed; and
 - (a) refuse to sell alcohol to the prospective buyer unless, on both occasions, he or she declares that he or she is 18 years of age or over (and, where a prospective receiver is involved, also declares that the prospective receiver is 18 years of age or over).
- (4) In the case of an order made on a physical order form, the procedure is to—
 - (a) ensure that the form—
 - (i) requires the prospective buyer to sign the form at a place at or near its end; and
 - (ii) contains 2 requests for the prospective buyer to declare, by ticking a box, that he or she is 18 years of age or over (and, where a prospective receiver is involved, that the prospective receiver is also 18 years of age or over)—
 - (A) one at the beginning of the form; and
 - (B) the other, immediately before the place on the form where the prospective buyer is required to sign it; and
 - (b) refuse to sell alcohol to the prospective buyer unless he or she has ticked both boxes and signed the form.

Regulation 15 describes the information to be provided by remote sellers. When using an internet website the licence holder must display prominently on the website, any catalogue produced and every receipt issued for alcohol sold remotely:

- (a) The licence holder's name and licence number
- (b) The date the licence expires.
- (c) And in addition to this either a legible image of the licence, or a clearly identified link to such image, must be clearly displayed on the website.

The licence will be subject to the following conditions:

- (a) No alcohol shall be delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day.
- (b) Alcohol may be sold from the premises at any time on any day, and delivered somewhere else for consumption off the premises, only on the following days and during the following hours:

Monday to Sunday 6.00 am to 11.00 pm

- (c) The licensee shall ensure that the provisions of regulation 14 of the Sale and Supply of Alcohol Regulations 2013 relating to the sale and supply of liquor to prohibited persons are observed and shall display appropriate signs on the Internet web page detailing the statutory restriction on the supply of alcohol to minors.
- (d) The Licensee must display on its website and in its catalogue and on every receipt issued for alcohol sold remotely:
 - (i) The licence holder's name and licence number;
 - (ii) The date on which the licence expires;

(iii) A legible image of the licence, or a clearly identified link to such image, to be displayed in a prominent place on the website.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance(s) to the premises as outlined in the plan received by the Dunedin District Licensing Committee on 23 October 2020. The entrance from Montreal Street is designated as the principal entrance.

INTRODUCTION

- [1] This is an application by Adiaar Holdings PVT Limited for an off-licence for the premises situated at 146 Victoria Road, Dunedin, and known as "Wobbly's Sports Bar". Mr Cherian is the sole director and shareholder of the applicant company.
- [2] The premises is in the rear of the main of Forbury Park Raceway and operates independently of the racing club. It has held an off-licence in the past but not in the past ten years.
- [3] There have been no public objections received however the Police and Medical Officer of Health (MOH) have opposed the grant of the licence. They do not believe the layout of the premises is suitable to hold an off-licence and the MOH believes the premises is adjacent to an early childhood service. The MOH also questions whether the premises is actually a 'tavern'.
- [4] Other than the question regarding the nature of the business, the application meets all s.105 criteria.

Procedural Matter

- [5] The MOH has tendered an apology for their non-attendance at this hearing. Their evidence has been tabled and taken as read. The applicant is advised that if they have any specific questions from the MOH the Committee will follow up the matter and relay the information back to the parties.
- [6] The Licensing Inspector, supported by the Police, wanted it noted that the applicant had not filed any evidence prior to the hearing. They said they would be going into the hearing 'blind', that is, they have no idea of what the applicant is likely to present to the Committee. They were, however, agreeable to the matter proceeding.
- [7] The Chair advised the matter would proceed but would take an adjournment if the reporting agencies needed time to consider the evidence and prepare responses.

HEARING

Mr Cherian

- [8] Mr Cherian is the sole director and shareholder of the applicant company. He has been in the hospitality sector in Dunedin for about 20 years and in that time has had several successful businesses.
- [9] The applicant took over the lease on "Wobbly's Sports Bar" about two years ago. He retained the sports bar and established the "Equinox" restaurant and function area in the adjacent spaces.
- [10] He said that business went down during the pandemic lockdown and has had to look at alternative income streams. An off-licence operating from the sports bar was considered. It is not intended that the off-licence will become a major part of the business but rather an extra for the local people.
- [11] Mr Cherian said that after the meeting with the agencies on site he has reconsidered the layout of the proposed off-licence. The new 'plan' is to have the alcohol for sale from the off-licence to be displayed behind the bar, or notified on a board, and the person behind the bar would get the product and hand it over after the sale has been made. He said he would only be carrying the types of alcohol consumed by the 'common person'. He would not be selling boxes of alcohol but instead singles to those wanting them.
- [12] When asked, Mr Cherian said he had no interest in becoming part of a franchise. He would stay independent so he could sell to the locals. There would be no external signs advertising the presence of an off-licence but there would be a sign inside the bar advising of the products available.
- [13] With reference to the early childhood facility on the 'boundary', he said the bar on the site in some form or another for over 125 years, far longer than the childcare. He said they had no contact with the people from the facility because it was so far away.
- [14] In response to a commented in the MOH opposition, he said the "Equinox" restaurant was 60-65% food based. The 'Wobbly's Sports Bar" was very much a bar with separate entrances.
- [15] Mr Cherian confirmed that the plan submitted with the application is 'redundant' now that he would be selling over the counter with the customer not being able to browse around shelving. Behind the bar would be changing to accommodate the off-licence alcohol but it would not be part of the 'public' area. There would be a blackboard telling people what was available.

- [16] The Committee asked how much he anticipated selling at 9am. Mr Cherian said the off-licence sales would not happen before 11am and that the application should be changed. the closing time of 10pm would remain.
- [17] When asked, Mr Cherian said staff will be ensuring people do not buy off-licence alcohol and consume it in the bar. This will not be allowed at all. On a busy night there would be 15-20 people in the bar so staff will be able to monitor off-licence purchases.
- [18] In response to a question about deliveries, Mr Cherian said he had not considered deliveries of alcohol. They deliver food but because he didn't have the off-licence it had not been considered. However, if someone did ask, he believed the volume would be based on what was ordered.
- [19] The Licensing Inspector asked Mr Cherian to describe the business at Wobbly's. He said it was a restaurant with a bar and function facilities.
- [20] When asked about his website, Mr Cherian said it was possible to add online food and alcohol orders. He said the issue would be minors placing orders so there would need to be a way of monitoring age.
- [21] Mr Cherian confirmed they do their own deliveries as well as using 'Uber Eats'. They would use them for alcohol deliveries as well because they have their own processes to ensure age is verified. He said they would ensure the people doing the deliveries had the appropriate training.
- [22] The Police asked what the applicant would do if someone bought a six pack of beers, stayed in the bar to drink but when they started to leave showed signs of intoxication. Mr Cherian said the alcohol would not be handed over. They person would need to come back the next day to pick up the alcohol.

Sgt Paulin

- [23] Sgt Paulin advised the Police will withdraw their opposition now the layout has changed, and sales would be over the counter.
- [24] He commented on the presence of the childcare facility saying there was some confusion between the boundary and distance.

Mr Mole

- [25] Mr Mole said he had nothing to add to his report now the layout has been resolved. However, he asked the Committee to consider whether the premises was a tavern because if it wasn't the off-licence could not be granted. He had sympathy with the applicant. The premises looks like a tavern but the other side is a restaurant. The two styles are operating on the one licence for convenience and it is the combined licence which means the bias is towards the food.
- [26] He commented that there are other premises in Dunedin that look like taverns, but food sale made up greater than 50% of the sales. Do we challenge these premises when they are due for renewal?
- [27] The Committee sought clarification regarding the separation between the bar and restaurant. Mr Mole said they were two distinct operations, but the one licence covered the two parts. One either walked into the bar or restaurant. Separate licences would resolve the issue but there would be added costs associated with this.
- [28] Mr Cherian clarified this by stating the restaurant was made up of 80% food sales while the bar was mostly alcohol sales.
- [29] Mr Cherian asked for some time to consider a policy relating to the delivery of alcohol with food.

[30] The Committee agreed to adjourn the matter for two weeks to allow the applicant time to develop policies relating to off-licence sales and delivery with food.

Resumed Hearing - on papers

- [31] Mr Cherian provided detail of his off-licence proposal and this was circulated to the agencies. Both the Police and Licensing Inspector advised they were comfortable with the circulated document, so the Committee finalised the decision on the papers.
- [32] The following additions are to be added to the application:
 - a. Clauses to be added to the Host Responsibility Policy:
 - i. Alcohol purchased from the bottle shop cannot be consumed on the premises
 - ii. If the person purchasing off-licence alcohol wishes to socialise in the bar the alcohol will be kept behind the bar until the person is to leave
 - iii. Intoxicated people will not be able to purchase alcohol at all, nor remove pre-purchased alcohol from the premises.
 - b. Prices and types of alcohol for off-licence sales:
 - Reasonable range of beers (Speight's, Steinlager, Corona, ciders, etc) ranging between \$18-36 per six pack
 - ii. Non-alcohol and low alcohol beers between \$15-24 per six pack
 - iii. Small range of wines priced \$18-40 per bottle
 - iv. RTDs priced \$25-30 per six pack.
 - c. No discounting, specials or promotions of any alcohol to be sold off-licence.
 - d. Bulk sales only to clubs, e.g., Dunedin Ice Hockey, Forbury Bowling Club.
 - e. Delivery of alcohol:
 - i. Alcohol will only be delivered with a meal
 - ii. One bottle of wine or a six pack will be allowed with meal orders over \$15.00
 - iii. A second bottle of wine or six pack with a minimum meal order of \$35.00
 - iv. Maximum three bottles of wine or six packs for a meal spend over \$70.00
 - v. Alcohol deliveries will be done by own delivery service, not any third-party delivery
 - vi. IDs will be checked at time of delivery.
- [33] The Committee believe the additions to the applicant's policies are acceptable and satisfy the points raised during the hearing.

DECISION

- [34] The layout of the premises has been resolved to the satisfaction of the parties.
- [35] There were two matters raised in the reports. The first related to the Local Alcohol Policy stating new premises could not be granted a licence if they were adjacent to early childhood facilities. The intent of this clause is to ensure the children were not confronted with alcohol images, etc. In this matter, while the two properties share a common boundary, there is about 270 m between the entrance of the premises and the boundary which is taken up by paddock. We do not see the premises as being adjacent to the childcare facility.

- [36] We must now consider s.32 and whether the premises meets the criteria to have an off-licence. Section 3(2) of the Act outlines its purpose and more specifically the characteristics of the new system: it is reasonable, and its administration helps to achieve the object of this Act.
- [37] There is no suggestion that an off-licence at this premises will be contrary to the object of the Act which is that the sale, supply and consumption of alcohol should be undertaken safely and responsibly and any harm caused by the excessive on inappropriate consumption is minimised.
- [38] It appears to us that the Act has not kept up with the times. A lot of 'taverns' are now selling more food than alcohol which assists with the object of the Act.
- [39] In this matter the premises is in two parts: a bar and restaurant. It has been stated by the Inspector that when one enters the bar, it looks like a tavern. The applicant has the two parts of the business under the one licence for convenience and to save costs.
- [40] The off-licence will be a part of the tavern which is separated from the restaurant. To ask the applicant to get a separate on-licence for either side would be, in our opinion, unreasonable.
- [41] The applicant has amended the application with additional information as outlined at paragraph [32] above.
- [42] In his evidence, Mr Cherian said they would not have any external signage advertising of an off-licence. Any signage would be visible once one has entered the premises. While this is not something to be included as a condition of the licence itself, other than the signage requirements stated in ss. 56 and 57(a) detailed below, no other signage relating to the off-licence, or the products offered for sale, is to be displayed on the outside of the premises.
- [43] We are satisfied as to the other matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an off-licence authorising the sale and supply to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.
- [44] The applicant's attention is drawn to ss.56 and 57(a) of the Act obliging the holder of an off-licence to display:-
 - 1. A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; AND,
 - 2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; AND,
 - 3. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.
- [45] The licence will be subject to the following conditions:
 - a. No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day.
 - b. Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 11.00 am to 10.00 pm

- c. The following parts of the premises is designated a supervised area: Every bar.
- d. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- e. Alcohol may only be delivered with meal orders as detailed in the decision for this licence.

- f. The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- [46] A copy of this licence must be displayed at the principal entrance(s) to the premises as outlined in the plan received by the Dunedin District Licensing Committee on 1 October 2020. The entrance from the foyer is designated as the principal entrance.






