# **DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE**

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

# **DECISION**

This is an application by Yan Min Trading Company Limited for the renewal of an alcohol off-licence in respect of their premises situated at 497 Portobello Road, Macandrew Bay, and known as the "Macandrew Bay Store".

The application is for a roll-over of the present conditions.

The application was duly advertised, and no objection has been received. The Police and Medical Officer of Health have not raised any matter however the Licensing Inspector believes the premises is a dairy and its location cannot be considered 'isolated'. The Inspector has not opposed the application per se but has left it to us to consider the points raised. We will consider the matter on the papers.

The applicant submitted certified sales figures for the year ending 31 May 2020. These figures show that food products, excluding convenience foods, make up 59.94% of the net revenue. This is one of the matters to consider when determining the nature of the store and as the Committee is concerned, it indicates to us the store is a genuine grocery store.

In 2016, at a public hearing, the Committee considered whether the store could be granted an off-licence. At that time the Committee was told the grocery food items made up 58.68% of revenue and we concluded it was a grocery store.

The Inspector does not believe the stores location can be considered an isolated area. As we stated in the 2016 decision, section 34 of the Act allows an exception for the issue of a licence to a premises, so long as it is not a dairy or convenience store, and it is located in an area where it would be uneconomical for a bottle store, alcohol manufacturer, supermarket or grocery store to be established and there would be no significant increase in alcohol-related harm. Macandrew Bay is not an area known for its alcohol-related harm and it is not viable for any of the above to be established. We have found the premises to be a grocery therefore it would meet the criteria for

section 34 consideration as an isolated location. To support this contention, the Dunedin Local Alcohol Policy has listed Macandrew Bay as a 'Remote Area' for the purposes of the policy.

The reports indicate the store has the alcohol confined to a single alcohol area and this has not changed since the last renewal.

We are satisfied as to the other matters to which we must have regard as set out in s.105 of the Act and therefore renew the licence until 11 July 2023, that being the anniversary date of the licence and three years from the most recent date of expiry and authorise the issue of a replacement licence and notice of renewal.

# **DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE**

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

#### **DECISION**

This is an application by Holly Dawn Linton (the "Applicant") for an off-licence, endorsed as a remote seller, in respect of premises situated at 115 Factory Road, Mosgiel, and known as "Project Dawn".

The application is in respect of premises in which the sale of alcohol would be an appropriate complement to the kind of goods sold in the premises.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an off-licence authorising the sale and supply of alcohol for consumption off the premises.

Although sales are made remotely, the licensee must ensure a certified manager is appointed to the business at all times.

Remote sellers have different requirements to other premises. The first is a response to the fact the buyer is not confronted at the time of purchase and to this end, regulation 14 of the Sale and Supply of Alcohol Regulations 2013 details the requirements imposed on licensees to ensure prohibited people do not purchase alcohol. This regulation is reproduced here for clarity:

# 14 Reasonable steps to verify that people not under purchase age

- (1) The procedures described in subclauses (2) to (4) are reasonable procedures for the purposes of complying with <u>section 59(3)</u> of the Act (which requires the holder of an off-licence to take reasonable steps to verify that the buyer of any alcohol that the holder sells by remote sale (and, if a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age).
- (2) In the case of an order made using an internet site, the procedure is to—

- (a) ask the prospective buyer to declare, by ticking an on-screen box, that he or she is 18 years of age or over (and, where a prospective receiver is involved, that the prospective receiver is also 18 years of age or over)—
  - (i) once when the prospective buyer first enters the internet site; and
  - (ii) again, immediately before the sale of any alcohol is completed; and
- (b) refuse to sell alcohol to the prospective buyer unless, on both occasions, he or she declares that he or she is 18 years of age or over (and, where a prospective receiver is involved, also declares that the prospective receiver is 18 years of age or over).
- (3) In the case of a telephone order, the procedure is to—
  - (a) ask the prospective buyer to declare, orally, that he or she is 18 years of age or over (and, where a prospective receiver is involved, that the prospective receiver is also 18 years of age or over)—
    - (i) once when the conversation concerned begins; and
    - (ii) again, immediately before the conversation is completed; and
  - (a) refuse to sell alcohol to the prospective buyer unless, on both occasions, he or she declares that he or she is 18 years of age or over (and, where a prospective receiver is involved, also declares that the prospective receiver is 18 years of age or over).
- (4) In the case of an order made on a physical order form, the procedure is to—
  - (a) ensure that the form—
    - (i) requires the prospective buyer to sign the form at a place at or near its end; and
    - (ii) contains 2 requests for the prospective buyer to declare, by ticking a box, that he or she is 18 years of age or over (and, where a prospective receiver is involved, that the prospective receiver is also 18 years of age or over)—
      - (A) one at the beginning of the form; and
      - (B) the other, immediately before the place on the form where the prospective buyer is required to sign it; and
  - (b) refuse to sell alcohol to the prospective buyer unless he or she has ticked both boxes and signed the form.

Regulation 15 describes the information to be provided by remote sellers. When using an internet website, the licence holder must display prominently on the website, any catalogue produced and every receipt issued for alcohol sold remotely:

- (a) The licence holder's name and licence number
- (b) The date the licence expires.
- (c) And in addition to this either a legible image of the licence, or a clearly identified link to such image, must be clearly displayed on the website.

The licence will be subject to the following conditions:

- (a) No alcohol shall be delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day.
- (b) Alcohol may be sold from the premises at any time on any day, and delivered somewhere else for consumption off the premises, only on the following days and during the following hours:

Monday to Sunday 6.00 am to 11.00 pm

- (c) The licensee shall ensure that the provisions of regulation 14 of the Sale and Supply of Alcohol Regulations 2013 relating to the sale and supply of liquor to prohibited persons are observed and shall display appropriate signs on the Internet web page detailing the statutory restriction on the supply of alcohol to minors.
- (d) The Licensee must display on its website and in its catalogue and on every receipt issued for alcohol sold remotely:
  - (i) The licence holder's name and licence number;
  - (ii) The date on which the licence expires;
  - (iii) A legible image of the licence, or a clearly identified link to such image, to be displayed in a prominent place on the website.

A copy of this licence must be displayed in a prominent position on the website or, as an alternative, a clearly identified link to such an image to be displayed.

# **DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE**

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

## **DECISION**

This is an application by Becharre Liquor Limited for an off-licence in respect of **new** premises situated at 212 Main South Road, Green Island, and known as "Super Liquor Green Island".

The application is in respect of premises in which the principal business is the sale of alcohol.

The premises is a former bank and has not been licensed in the past. A certificate from the Council's Planning Department accompanies the application which states that the sale of alcohol in this area is a permitted activity. As soon as the new premises is licensed the bottle store currently part of the Commercial Tavern, which is operated by the applicant in this matter, will cease to trade and the licence surrendered.

The application was duly advertised, and one objection was received. However, the objector did not establish an interest greater than the public generally and lived more than 3.5km from the proposed new premises. They also indicated they did not want to be heard at a public hearing.

The Police and Licensing Inspector have no concerns with the application. They stated that the applicant was aware of the nearby Churches and had a risk mitigation plan which included CCTV and limiting the external signage at the front of their site.

However, the Medical Officer of Health voiced their concern that once this new premises was licensed the premises situated at the Commercial Tavern would not close with the result being an increase in the number of licensed premises in the Green Island area. They did, however, indicate their opposition would be withdrawn upon the surrender of that licence when the new premises is open.

The Committee called for a hearing into this matter to discuss the opening times of the premises, its proximity to 'sensitive' sites and to get assurance that the licence for the Commercial Tavern site would be surrendered. When we relooked at the application against the Local Alcohol Policy (LAP) we note that Churches are not classed as 'sensitive facilities' therefore the location of the premises is not an issue.

We communicated with the applicant regarding three matters. This first was the closure of the bottle store which is part of the Commercial Tavern. They have guaranteed that, when this new premises opens, the other site will be closed, and the licence surrendered.

With regards to the Churches in the immediate area, to avoid the possibility of adverse comment and conflict, the applicant agreed that a midday opening on Sundays would be acceptable and a good compromise.

The third matter we had 'reservations' about was the proximity to a bus stop that is used by school children to change buses on their way home from school. The applicant said they believed the Super Liquor guidelines for external advertising protected vulnerable people from excessive exposure to alcohol messaging. They do not use external promotional material. During the times school children are waiting for buses the applicant will ensure greater vigilance to ensure restricted people do not enter the store.

We are satisfied with the reassurances provided by the applicant and the comments made by the Police and Inspector with regard to the suitability of the applicant. We will consider the application without a hearing on the assumption that the off-licence associated with the Commercial Tavern will be surrendered when this licence is issued.

The Medical Officer of Health makes mention of the proximity of schools nearby but with the closure of one premises and the opening of another in the same area the 'amenity and good order' of the area should not noticeably change.

We are satisfied as to other matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an off-licence authorising the sale and supply of alcohol for consumption off the premises, and to supply alcohol free, as a sample, for consumption on the premises.

The applicant is currently refitting the premises therefore the licence will be issued when we are advised the premises is ready for occupation.

The applicant's attention is drawn to ss.56 and 57(a) of the Act obliging the holder of an off-licence to display: -

- A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; <u>AND</u>,
- 2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; <u>AND</u>,
- 3. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

The licence will be subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day
- (b) Alcohol may be sold only on the following days and during the following hours:

Monday to Saturday 10.00 am to 10.00 pm
Sunday 12.00 noon to 10.00 pm

- (c) The whole of the premises is designated a supervised area.
- (d) While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.

(e) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.

# **DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S**
