Sunday to Thursday 9.00 am to 11.00 pm

Friday and Saturday 9.00 am to 12.00 midnight

- (c) The following steps must be taken to promote the responsible consumption of alcohol:
 - (i) A range of food choices must be readily available at all times that the premises is open. Menus must be visible, and food should be actively promoted. A minimum of three types of food should be available. The range or style of food will be shown on any menu submitted. Alternatively, the range of food should include such items as paninis, pizzas, lasagne, toasted or fresh sandwiches, wedges, pies, filled rolls, and/or salads.
 - (ii) A range of low alcohol and non-alcoholic drinks must be readily available at all time the premises is open.
 - (iii) Water must be freely available at all times that the premises is open.
- (d) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:

INTRODUCTION

- [1] This is an application by the Otago University Students Association Incorporated (OUSA) for the renewal of an on-licence for the premises situated at 155 Frederick Street, Dunedin, and known as the "Starters Bar". The applicant would also like to vary the closing time at the premises to 3am on Friday, Saturday and Sunday mornings. This is the first renewal of the premises.
- [2] At a hearing to consider the location of the premises in 2019 it was deemed not to be in or adjacent to a residential area for the purposes of the Local Alcohol Plan. The predominant activity in the area is not domestic housing but rather student rental properties on the edge of the student quarter. There are also industrial premises in the immediate area of the premises.

- [3] There were no public objections to the renewal of this licence, although one was received two working days before this hearing, well outside the time allowed for objections.
- [4] The reporting agencies have not opposed the application.
- [5] The Committee has called this hearing because they want to be reassured there are systems and processes in place to ensure potential problems can be dealt with effectively. They would also like to hear the reporting agency's reasons for supporting the increase in trading hours.
- [6] Because this hearing has been called by the Committee to satisfy itself the applicant will continue to operate the premises properly, and the reporting agencies are not opposed, the matter will be heard non-public.

Mr Schroeder

- [7] Mr Schroeder is the Events and Venues Manager for the OUSA and is one of those from the organisation with overall responsibility for the premises.
- [8] Since the 1990s the premises has been one of the mainstay locations of student drinking. As other student premises started closing the premises has become an important part of the student culture.
- [9] When the OUSA bought the premises, it was with the intention of providing a safe place for students to socialise while having a drink. Since they have taken over there is more emphasis on the food provided being better quality, the entertainment is better quality and is more targeted at the student population. There is more security working than one would normally expect of a bar, but this is for the safety of the patrons. The 'R U OK' group also work in the premises to ensued everyone is in a 'safe' place and not getting too intoxicated.
- [10] Since they took over the running of the bar, Mr Schroeder said they have received very positive feedback.
- [11] The OUSA took over the running of the Hyde Street Keg Party because the event was becoming unsafe. They essentially manage it to reduce alcohol-related harm on the day by controlling what happens.
- [12] With the closure of numerous student bars people wanting to drink are tending to have street parties and then go into the bars in town. As a result of this the alcohol-related harm is increasing.
- [13] The reason for seeking the extended hours is so that a more complete evening can be provided so that when patrons leave the premises they feel as if their evening is finished and they return home. There will hopefully be no need for them to feel that they need to go elsewhere to continue their night.
- [14] Mr Schroeder said they are unaware of any noise issues from the premises. The only issues they are aware of is the queues, but they are working at resolving these issues.
- [15] During re-orientation earlier this year they had a special licence to operate until 3am for five consecutive nights. The OUSA believe this was very successful and received positive feedback during and after the week had ended.
- [16] Mr Schroeder said the OUSA sent one of the neighbouring property owners, Ms Seque, an email at the end of 2019 asking for feedback but did not receive a reply. They assumed there

were no issues with how they were operating the premises. He was disappointed that Ms Seque decided to make comment to the Otago Daily Times (ODT) rather than responding to their email or using the renewal process as a way to voice her concerns.

- [17] The Starters Bar is named in the "Sophia Charter" as a venue the University of Otago will work with to support student activities to ensure a safe environment for students to socialise.
- [18] Mr Schroeder informed the Committee that the OUSA Orientation events for 2021 will be moving away from the Forsyth Barr Stadium. The venue was no longer financially viable for them to hire, especially in the face of the Covid-19 pandemic. Functions will be held at the Union Hall, but this only has a capacity of 1400 people so there will be more people out in the streets during the orientation week.
- [19] In response to a question from the Committee, Mr Schroeder said under Alert level 1 the Union Hall would be able to hold events with up to 1400 people, however, if Otago was at Alert Level 2, they would be restricted to 100 people. They will be looking at smaller events generally because they have nowhere to match the capacity of the Stadium. The Starters Bar will become the focus of student events going forward.
- [20] When asked, Mr Schroeder said the occupancy at the Starters Bar was 400 at Alert Level 1 but at level 2, they were limited to 180 people, plus staff, spread over two separate areas.
- [21] In response to another question, he said there were quiz nights held on Wednesday nights, comedy nights and bingo nights. They also offer a 'Hall Pass' to encourage first year students to socialise at the bar rather than street parties in the nearby streets. If there is to be an event at the premises they put it on their board so passers-by can see what is coming up. Anyone is able to see these notices.
- [22] Mr Schroeder told the Committee that if they were able to trade until 3am it would not be every night. The extra time would allow them greater flexibility to close later if there are people present. They would also be able to attract 'drum and bass' bands which are what the students like to hear. With the 1am closing the students will often leave about 11.30 pm to go into town. However, during reorientation, they students started trickling out at 2am and the place was usually clear by 2.30 am.
- [23] When there are big nights at the premises, Mr Schroeder said they hire barriers that can be filled with water to manage the queues. There is good lighting in the areas used for queuing as well as CCTV cameras that can be monitored from the office. When there is a big event planned, they arrange meetings with the Dunedin Police and Campus Watch to ensure they had everything covered.
- [24] Another problem they have are the other street/flat parties in the area. The people from these parties mingle with, and try to join, the queue for the bar. When there is something big on, they over-staff the security to ensure the area remains safe. They work closely with their security provider and the Police to ensure they get it right. The queue management is always being finetuned.
- [25] There have been issues in the past with people attempting to enter the premises by climbing over the rear fence. This is another area they are looking to improve.
- [26] When asked, Mr Schroeder said the CCTV is not linked to the network monitored by Campus Watch but if there is an issue the images will be shared with the Police so long as the time of an incident, and the nature of the incident, is stated. When required, Mr Cassidy sits with the member of police while the footage is being viewed.

- [27] When asked about the comments made by Ms Seque to the ODT, Mr Schroeder said he was disappointed. The renewal was publicly notified properly, and she failed to notice the advertisements and missed her opportunity. The later hours may impact her tenants but the OUSA has always stated they would take any complaint seriously. The OUSA has tried to contact her but she hasn't responded so it has been assumed there were no issues.
- [28] Mr Schroeder emphasised the licence would not be used to its full hours all the time, but it would give them more flexibility.
- [29] Discussion took place regarding the noise limits and the applicant's understanding of those limits. Mr Bell was asked questions to clarify the legal limit at the premises boundary which is 40 dB. He said it was difficult to use noise meters in a bar situation. When there is a noise complaint the Noise Control Officer will assess the noise subjectively, considering whether the noise is 'unreasonable' in the area and whether or not people would be 'inconvenienced' by that noise. Mr Schroeder said it was difficult to get accurate noise readings from the bands because of the crowd noise associated with the patrons from the premises as well as the other parties in the area. It was suggested the band noise was assessed through the day when the other noises were not present, and this was noted by the applicant.
- [30] Mr Bell said there have been no seizures required from this premises nor has there been any abatement notices issued.
- [31] In response to another question, Mr Schroeder said he was aware that there were discussions within the halls of resident about extending the hours of alcohol consumption at the halls from 9pm to 11pm to encourage the predominantly first year students from feeling the need to go into town. He is unsure if this has been progressed beyond discussions.
- [32] The Committee asked why they don't seek special licences when they know there are band booked. Mr Schroeder said that was a possibility but when the bands are there now, which is a regular feature at the premises, they pack up early because of the Starters Bar closing time so they can get into town for later gigs. By having later hours the bands will stay at the premises which in turn will keep the students in North Dunedin.
- [33] When asked about the importance of Thursday nights, they said people leave early to get into town so they are inside before the one-way door starts. Their trip into town in uncontrolled, the same as the street parties that some of them go to. The OUSA would like to be responsible by trying to keep them in a safer environment off the streets.
- [34] When they had a special licence during reorientation, the Starters Bar used 2am as the time to begin the one-way door and it worked well. They started it at 2.30 am one morning but they found the earlier time worked for them.
- [35] When asked about staffing at the premises, Mr Cassidy said they have 25 bar and kitchen staff. At any time, they will have up to eight security staff working, depending on the number of people present in the bar. There are two duty managers working with up to six others in the premises. The majority of their staff are students working 10-15 hours each. The duty managers work 30 hours each with only Mr Cassidy and one other staff member working fulltime. The OUSA is committed to the 'living wage' so that is the base hourly rate. As far as the OUSA is aware, none of their staff at the premises are working on a work permit.
- [36] The Committee asked how they look after the area around the premises, especially after a big night. Mr Cassidy said there was a person responsible for outside the premises in the evenings. They look after the crowds as well as keeping an eye on the litter in the area. There

- is a bin near where the security is for glass and other rubbish. When the bar closes it is their responsibility to check the state of the streets in the immediate area.
- [37] Mr Schroeder was asked if the premises keeps a log each night. He said they did and, when asked, said it would be a good idea if the log was sent to the Police for their interest.

Sgt Paulin

- [38] Sgt Paulin is the Alcohol Harm Prevention Officer for the Dunedin Police.
- [39] He said this was an interesting application. During the hearings to determine whether the premises was in or adjacent to a residential area it was found not to be in such an area. that being the case the maximum trading hors are 8am to 3am the following day. this alone meant there was no reason to oppose this application to extend the closing time on three days of the week.
- [40] Over the past 2-3 years there has been a good relationship develop between the Police and OUSA. When the OUSA was considering the purchase of the premises they consulted with the Police and other agencies to ensure they were doing things properly.
- [41] Sgt Paulin said there was a meeting about six weeks earlier where the Vice Chancellor, Prof Harlene Haynes, talked about approaching the halls of residence allowing residents to drink until 11pm. If this was to happen it would make a difference in the area. the 'Good One' initiative has allowed for a good collaborative approach. It is proving to be a geed initiative.
- [42] During reorientation queuing outside the Starters Bar was a problem because of the numbers coming from the nearby halls of residence when they had to stop drinking at 9pm. Sgt Paulin said he believed the university needed to be involved with the drinking issue because they have more influence that everyone else combined.
- [43] Another problem in the area were the student flat parties. They tended to stay at these places until 2-4am before going back to their accommodation.
- [44] Sgt Paulin said the Starters Bar was quite unique because it was not profit driven and were there to provide a safe place for students. When there is a problem, they are motivated to resolve the issue and will do whatever is required. The Police supports the application because it will help manage the students late at night, especially the first-year students.
- [45] The university need to help with control of students. Ideally, they would help by providing a large venue for the larger events that were taking place at the stadium.
- [46] When asked about the Sophia Charter, Sgt Paulin said it was fine but unenforceable. It states how each of the signatories will work towards a better environment, but they are just statements of intent.
- [47] The Committee asked about potential noise complaints resulting from the extended hours and bands playing later. Sgt Paulin said the majority of flats in the area are party flats. Noise is more likely to be an issue from these places than the Starters Bar. He said Ms Seque would have known the renewal was due because she was at the hearing at which the licence was granted.
- [48] He said the Starters Bar has good management processes in place. There are more advantages allowing the later trading than there will be disadvantages. Their application is fully supported by the Police.

Ms Paterson

- [49] Ms Paterson is a Health Promotion Officer delegated to carry out the functions of the Medical Office of Health.
- [50] She said usually when there is an application to extend hours they usually get concerned. However, on this occasion the applicant is more concerned for the safety of student aged people in the streets late at night. They are motivated by looking after their clients, not profit. They would not need change any of their operating process with the extended hour because they have them in place now. There Host Responsibility and Alcohol Management Polices will cater for extended hours.
- [51] During reorientation the premises was generally well managed. There was more noise from a flat across the road in Clyde Street than from the premises itself. The courtyard on the Frederick Street side was a lot quieter than inside, but there was not a drum and bass band playing.
- [52] Ms Paterson said the OUSA was part of a strategic planning group looking at alcohol-related harm in the North Dunedin area.
- [53] This was a unique applicant. They are trying to keep people away from the Octagon late at night. This is not a problem premises.

Mr Mole

- [54] Mr Mole is the Dunedin City Council's Alcohol Licensing Inspector.
- [55] He said he endorses the comments of the other agencies. The premises is in a high risk area but the applicant is trying to create a safer environment. The advantages of the extend hours outweigh any potential disadvantages.
- [56] Mr Mole pointed out to the Committee that they could impose a renewal for a lesser term to allow a review.

DECISION

- [57] This is a unique application. The applicant seeks to extend their trading hours, and this is supported by the reporting agencies.
- [58] The Committee is mindful that it deemed the premises was not in or adjacent to a residential area in 2019. This was because it is surrounded by a mix of student flatting accommodation and industrial premises. It was reiterated in this hearing that the majority of the flats in the area are 'party flats' and more likely to be the source of excessive noise than the applicant's premises.
- [59] The applicant and agencies have indicated a desire to keep students in the North Dunedin area rather than have them involved with street parties or wandering into to town late night and then returning even later.
- [60] The reason for the hearing was for the applicant to explain their reasons for the extension of trading hours and for the Committee to hear why the agencies support the application.

- [61] We are pleased to hear there is good collaboration between the agencies and the OUSA generally and the common desire to reduce alcohol-related harm and to make the area a safer environment for younger people.
- [62] The Committee is somewhat concerned that the hire of the Forsyth Barr Stadium is such that the OUSA can not afford to use the venue for the Orientation weeks in the future. While this is not a matter for this application, we are grateful for the information and this issue will be followed up by the Committee.
- [63] We are satisfied that the applicant has the ability to manage the premises with extended hours. The applicant has indicated they are working on a couple of areas of concern, namely the security of the back fence and queues, but we have been reassured by the reporting agencies that the applicant will do what they can to mitigate these problems.
- [64] We have considered the duration of the renewal and believe it would be inappropriate to have a lesser period than the maximum three years. However, we would undertake a review in September 2021 to assess how the extended hours have worked during the 12 months.
- [65] We are satisfied as to the criteria we must consider in section 131 of the Act and renew the licence, with a 3am closing time on Thursday, Friday and Saturday nights, until 7 June 2023, that being three years from the first anniversary of the licence. A one-way door shall apply from 2am on those nights.

[66] We authorise the issue of a replacement licence and notice of renewal.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act but remind the applicant that they have had three years to get the administrative part of running the business right and have still been found wanting. In the future the agencies may not be so benevolent and suggest the matter go to a hearing.

On this occasion, however, we renew the licence until 25 July 2023, that being the anniversary date of the licence and three years from the most recent date of expiry and authorise the issue of a replacement licence and notice of renewal.

In their letter, the MOH said that allowing minors to be exposed to alcohol "is not the establishment of drinking as a normal part of behaviour, rather it is the establishment in the minds of these minors that drinking is not a behaviour that they need to be concerned about or one which has potentially negative, harmful consequences. This normalisation may be exacerbated by the association of alcohol with school which is generally a safe place where students are protected from harm."

International research is finding that the exposure to alcohol is linked to early initiation to drinking which is linked to increased risk of experiencing alcohol abuse issues later in life.

The MOH submitted that "alcohol provision at a school event, for school students, on school grounds is neither responsible nor appropriate."

The Committee has a like view. We are comfortable granting a special licence for the Sports Award Dinner but not the Leaver's Dinner. The applicant was contacted and advised the application would be 'split' so the Leaver's Dinner could be considered at a public hearing. The applicant subsequently advised they accepted the Committee's decision and would alter their plans for the Leaver's Dinner accordingly. There was no need for a public hearing.

That being the case we deal with the Sports Award Dinner only.

There is no certified manager at this event however the person responsible has extensive, relevant experience in the hospitality industry and has held a manager's certificate in the past. The applicant has therefore been granted an exemption by the Dunedin Licencing Committee from having a certified manager present for the event pursuant to section 213(2) of the Act.

The reporting agencies (Police, Medical Officer of Health and Licensing Inspector) have raised a matter of concern. On this application there are 35 dates the applicant seeks to be covered. The agencies have considered the dates and are satisfied they include all normal sailing days during the season with nothing special about any of them. They have voiced their concerns that the club should have a club licence and with a certified manager.

The Committee agrees with the agencies. It is very obvious the special licence is being used in place of what should be a club licence and therefore will expect the club to apply for the appropriate licence as soon as possible.

The club has been sent an application for their own club licence and they will also need to arrange for a member to become a certified manager. We do not want to hinder the club so will allow this special licence to cover their days until the end of January 2021. We would anticipate that they will have applied for, and been granted, a club licence by this time.

While the agencies have opposed the grant of the licence the club has indicated to us that they will be applying for a club licence. There have been no other matters raised regarding the application therefore we do not propose to convene a hearing.
