DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

DECISION

This is an application by Sandymount Kilns Distillery Limited for an off-licence, endorsed as a remote seller, in respect of their premises situated at 71 Sandymount Road, Otago Peninsula, Dunedin, and known as the "Sandymount Kilns Distillery".

The application is in respect of **new** premises in which the production and remote selling of alcohol is the principal business.

The application was duly advertised and no objection or notice of desire to be heard has been received. However, it was revealed during the interviews that the applicant had been producing and selling alcohol without a licence and premises was not registered as required by the Food Act. As soon as the applicant became aware of the requirements immediate steps were taken to ensure compliance. The Licensing Inspector also noted issues with their applicant's website and has offered suggestions to remedy the faults.

Accordingly, we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an off-licence authorising the sale and supply of alcohol for consumption off the premises.

Although sales are made remotely, the licensee must ensure a certified manager is appointed to the business at all times.

Remote sellers have different requirements to other premises. The first is a response to the fact the buyer is not confronted at the time of purchase and to this end, regulation 14 of the Sale and Supply of Alcohol Regulations 2013 details the requirements imposed on licensees to ensure prohibited people do not purchase alcohol. This regulation is reproduced here for clarity:

14 Reasonable steps to verify that people not under purchase age

(1) The procedures described in subclauses (2) to (4) are reasonable procedures for the purposes of complying with $\underline{\text{section } 59(3)}$ of the Act (which requires the holder of an off-licence to take reasonable

steps to verify that the buyer of any alcohol that the holder sells by remote sale (and, if a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age).

- (2) In the case of an order made using an internet site, the procedure is to—
 - (a) ask the prospective buyer to declare, by ticking an on-screen box, that he or she is 18 years of age or over (and, where a prospective receiver is involved, that the prospective receiver is also 18 years of age or over)—
 - (i) once when the prospective buyer first enters the internet site; and
 - (ii) again, immediately before the sale of any alcohol is completed; and
 - (b) refuse to sell alcohol to the prospective buyer unless, on both occasions, he or she declares that he or she is 18 years of age or over (and, where a prospective receiver is involved, also declares that the prospective receiver is 18 years of age or over).
- (3) In the case of a telephone order, the procedure is to—
 - (a) ask the prospective buyer to declare, orally, that he or she is 18 years of age or over (and, where a prospective receiver is involved, that the prospective receiver is also 18 years of age or over)—
 - (i) once when the conversation concerned begins; and
 - (ii) again, immediately before the conversation is completed; and
 - (a) refuse to sell alcohol to the prospective buyer unless, on both occasions, he or she declares that he or she is 18 years of age or over (and, where a prospective receiver is involved, also declares that the prospective receiver is 18 years of age or over).
- (4) In the case of an order made on a physical order form, the procedure is to—
 - (a) ensure that the form—
 - (i) requires the prospective buyer to sign the form at a place at or near its end; and
 - (ii) contains 2 requests for the prospective buyer to declare, by ticking a box, that he or she is 18 years of age or over (and, where a prospective receiver is involved, that the prospective receiver is also 18 years of age or over)—
 - (A) one at the beginning of the form; and
 - (B) the other, immediately before the place on the form where the prospective buyer is required to sign it; and
 - (b) refuse to sell alcohol to the prospective buyer unless he or she has ticked both boxes and signed the form.

Regulation 15 describes the information to be provided by remote sellers. When using an internet website the licence holder must display prominently on the website, any catalogue produced and every receipt issued for alcohol sold remotely:

- (a) The licence holder's name and licence number
- (b) The date the licence expires.
- (c) And in addition to this either a legible image of the licence, or a clearly identified link to such image, must be clearly displayed on the website.

The licence will be subject to the following conditions:

- (a) No alcohol shall be delivered on Good Friday, Easter Sunday, Christmas Day or before 1.00 pm on Anzac Day.
- (b) Orders may be taken at any time on any day

Deliveries may be made Monday to Sunday 6.00 am to 11.00 pm

- (c) The licensee shall ensure that the provisions of regulation 14 of the Sale and Supply of Alcohol Regulations 2013 relating to the sale and supply of liquor to prohibited persons are observed and shall display appropriate signs on the Internet web page detailing the statutory restriction on the supply of alcohol to minors.
- (d) The Licensee must display on its website and in its catalogue and on every receipt issued for alcohol sold remotely:
 - (i) The licence holder's name and licence number;
 - (ii) The date on which the licence expires;
 - (iii) A legible image of the licence, or a clearly identified link to such image, to be displayed in a prominent place on the website.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed in a prominent position on the website or, as an alternative, a clearly identified link to such an image to be displayed.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol for consumption on the premises, to any person who is present on the premises.

The applicant's attention is drawn to ss.56 and 57(a) of the Act obliging the holder of an on-licence to display:-

- 1. A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; AND,
- 2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; AND,
- 3. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

The licence will be subject to the following conditions:

- (a) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day to any person who is not present on the premises to dine.
- (b) Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 11.00 am to 1.00 am the following day: EXCEPT THAT on the Thursday before Good Friday, and on Easter Saturday, and on Christmas Eve and on the day before Anzac Day, alcohol may only be sold between 11.00 am and 12.00 midnight.

- (c) The following steps must be taken to promote the responsible consumption of alcohol:
 - (i) A range of food choices must be readily available at all times that the premises is open. Menus must be visible, and food should be actively promoted. A minimum of three types of food should be available. The range or style of food will be shown on any menu submitted. Alternatively, the range of food should include such items as paninis, pizzas, lasagne, toasted or fresh sandwiches, wedges, pies, filled rolls, and/or salads.
 - (ii) A range of low alcohol and non-alcoholic drinks must be readily available at all time the premises is open.
 - (iii) Water must be freely available at all times that the premises is open.
- (d) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - (i) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (e) The licensee must ensure that signs are prominently displayed within the licensed premises detailing information regarding alternative forms of transport from the premises.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

- [2] There is no requirement to give notice of the application to the Police, however this is the first application received from the applicant for this premises. For this reason, the Committee requested comment from the Licensing Inspector and the Police and distributed the Application.
- [3] The Licensing Inspector submitted an adverse report questioning the suitability of the applicant to hold an alcohol licence. The main reason was that the applicant purchased the business near the end of 2020 and continued to sell and supply alcohol unlawfully and without a licence, until the Inspector learned of the change in May 2021.

- [4] The applicant stopped the sale of alcohol as soon as the Inspector challenged them at the premises.
- [5] The Committee was advised the applicant required an interpreter because of limited English skills. Ms Hughes was engaged for this.

HEARING

Ms Wang

- [6] Ms Wang is the director of Great Taste Limited and one of the two shareholders. She is recorded as the contact person for this application.
- [7] She said when she purchased the business it was already licensed to sell alcohol and the manager had a manager's certificate. Ms Wang said she was not aware of the requirement to inform the council and obtain a temporary authority to sell alcohol.
- [8] Ms Wang said she lives in Invercargill where she looks after her family. She said she forgot to apply to the Council for a temporary authority.
- [9] When asked by the Committee, Ms Wang said she purchased the business on 17 November 2020.
- [10] The Committee asked when they became aware they needed to apply for a temporary authority. Ms Wang said before they purchased Great Taste, they knew the restaurant had a licence and the manager had a manager's certificate. When they took over the business there was a lot of paperwork and subsequently forgot about the temporary authority. As the previous owner had held a licence she thought there would not be such a hurry to get a temporary authority and she thought they could continue to sell alcohol because there was a licence already in place. When the Inspector went to the premises it was at that stage they realised they needed to get their own temporary authority.
- [11] Ms Wang said they stopped selling alcohol immediately and applied for their own temporary authority on 10 June 2021.
- [12] The Inspector asked if, when the business changed hands, if the accounts were changed and the proceeds from sales went into their own back account. Ms Wang said they did.
- [13] In answer to a question, Ms Wang said she has been involved with two other licensed premises. She said when they took over the Kwang Chow Restaurant in the Dunedin they stayed in Invercargill and the manager was responsible for the changes in Dunedin. When asked, Ms Wang said she could not remember who would have applied for the temporary authority for that premises.
- [14] Mr Cheng is the son of the former owner of Great Taste and a friend of the applicant. When asked, he said they didn't realise it was their responsibility to tell the applicant that they needed to advise the applicant that the Council needed to be informed of the sale. They had been in the restaurant industry for a long time so assumed they would know what to do. In answer to a question from the Inspector, Mr Cheng said his father was the person involved with sale of the premises.

- [15] In response to a question from the Inspector, Ms Wang said her English is not good, so she relied on several friends to help with the sale and takeover of the business despite having been involved with licensed premises in the past.
- [16] The Licensing Inspector questioned the need to continue with the hearing. The applicant had admitted selling alcohol without authority. He said he did not believe there was a need for the agencies to present evidence because the applicant's suitability was in doubt.
- [17] After a brief adjournment the Committee advised the hearing would continue. They needed to be certain the applicant had read and understood the evidence of the Inspector and Ms Morrison that had been circulated prior to the hearing and that the Applicant should continue to have the opportunity to prosecute their case to ensure natural justice.
- [18] The applicant confirmed the documents had been read and understood and they were taken as read.

Mr Mole

- [19] Mr Mole is the Licensing Inspector for the Dunedin City Council. His evidence was taken as read but he noted an error in paragraph 13 he spoke to Jun Lin Li, not Deqin Wang.
- [20] He explained how, on 13 May 2021, while looking at a new manager's certificate application, he noted the applicant's employer at the Great Taste Buffet restaurant was Wang Deqin. He checked on the name and found that Great Taste Limited was incorporated in 12 November 2020. Deqin Wang is recorded as the sole director of the company and is an equal shareholder with Junlin Li.
- [21] Further checks revealed the following:
 - a) The partnership of Deqin Wang and Jun Lin Li have held an alcohol licence for the Hong Kong Restaurant in Invercargill since 2018.
 - b) Junlin Li was a shareholder of a company that held a licence for the South City Restaurant in Dunedin from 2016. Mr Li was removed as a shareholder in October 2019.
 - c) The partnership of Deqin Wang and Jun Lin Li was granted an alcohol licence for Kwang Chow in Dunedin in February 2016. When they took over this business they applied for and were granted a temporary authority so they could continue to sell alcohol when they took over the premises in August 2015.
- [22] Mr Mole said he went to the premises with Ms Morrison and advised Ms Nan Ding to remove any alcohol from display and that none could be sold. A subsequent check found that the direction had taken effect.
- [23] A temporary authority application was submitted to the Council on 10 June 2021 and a full onlicence application on 16 June 2021.
- [24] Mr Cheng's name was recorded as the duty manager on the temporary authority application. When spoken to about this he said he had agreed to be the duty manager when there were enough bookings to make it worthwhile. He also said he did not believe he did not have a responsibility to advise the new owners of their obligations for licencing the premises.

Ms Morrison

- [25] Ms Morrison is an Environmental Health Office and Alcohol Licensing Inspector for the Dunedin City Council.
- [26] She said she accompanied Mr Mole to the Great Taste Buffet Restaurant after he learned the premises may have changed ownership. She checked the Council records and learned the change of ownership had not been advised to the council with regards to the food registration.
- [27] Ms Morrison accompanied Mr Mole to the premises and explained the requirements of the Food Registration programme. She subsequently confirmed the premises had changed ownership in December 2020. A further check on the company found they had also purchased the unlicensed premises, Zoo Café, in April 2021 and this also required new food registration.
- [28] Ms Morrison confirmed that the food registration issues were resolved as soon as they were raised with the applicant.

Mr Mole

- [29] In closing, Mr Mole reiterate that the applicant admitted selling alcohol without a licence. The maximum penalty for the unlicensed sale of alcohol, upon conviction, is a fine not exceeding \$40,000 or a term of imprisonment not exceeding 3 months.
- [30] He reminded the Committee that it was not obliged to find a link between suitability and harm. In a very recent decision, *Mainland Hospitality Limited* [2021] NZARLA 100-101, the Authority said at [93]:
 - "While Sheard and Nischays were not enforcement cases in relation to manager's certificates, they confirm that at the heart of any inquiry into suitability are considerations of character, reputation, honesty, as well as considerations relating to the operation of licensed premises."
- [31] In Mr Mole's view, the applicant is clearly unsuitable to hold a licence.

Ms Wang

- [32] Ms Wang admitted she made a mistake. She said she did not know she needed to apply for a temporary authority because the place was already licensed. When Mr Mole visited the premises the sale of alcohol was stopped immediately. However, she would like to start selling alcohol to customers as soon as she can.
- [33] Once she has a temporary authority Ms Wang said she would then have staff apply for manager's certificates and hopes the Committee will give her that opportunity.

DECISION

[34] Ordinarily an application for a temporary authority will not proceed to a hearing. There is no requirement in the Act for such an application to be circulated for comment by the agencies however, because the holder of a temporary authority has the same duties, obligations and liabilities under the Act as the holder of a substantive licence, it would be remiss of the

Committee not to seek comment when it is the first application received from the applicant for this premises.

- [35] In this matter the Licensing Inspector submitted an adverse report because the applicant, by their own admission, sold alcohol without a licence or temporary authority from 17 November 2020 to 13 May 2021.
- [36] The Committee is left with some concerns regarding the applicant's suitability to be the holder of a temporary authority. However, this is not a predetermination for the applicant's onlicence application that has been filed.
- [37] There has been little evidence from the applicant regarding their suitability to hold an alcohol licence. They have previously held alcohol licences, so they need to be afforded the opportunity to present evidence of their suitability before the Committee makes a determination of their on-licence application.
- [38] For these reasons the application by Great Taste Limited for a temporary authority for the premises situated at 12 St Andrew Street, Dunedin, is declined.
