# **DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE**

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

#### **DECISION**

This is an application by Leith Pub Company Limited for an off-licence in respect of their premises situated at 135 Stuart Street, Dunedin, and known as "Albar".

The application is in respect of premises in which the principal business is the sale of alcohol.

The premises currently has an on-licence and now the licensee would like to sell alcohol produced by him for the off-licence market.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

A neighbouring on-licence was recently granted an off-licence to compliment their food delivery service. In this matter the applicant will be producing a salted caramel whisky to sell over the counter. As the production increases a website will be established for the remote sale of their product.

The premises is in the centre of the Dunedin. The product will be higher priced and unlikely to be attractive to the late-night market. It has been suggested by the Licensing Inspector that sales be restricted to the product produced by the applicant. This would ensure the premises is not seen as another inner city bottlestore. We see merit in that suggestion.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an off-licence, with the suggested condition, authorising the sale and supply of alcohol for consumption off the premises, to any person who is present on the premises.

The applicant's attention is drawn to ss.56 and 57(a) of the Act obliging the holder of an off-licence to display: -

1. A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; AND,

- 2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; AND,
- 3. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

The licence will be subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day
- (b) Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 7.00 am to 10.00 pm

- (c) The whole of the premises is designated a supervised area.
- (d) Only alcohol produced by the licensee can be sold pursuant to this licence.
- (e) While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- (f) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
