This is an application by Kim Clifford Distilling Limited for the renewal of an alcohol off-licence, endorsed as a remote seller, in respect of their premises situated at 83 Oakwood Avenue, Dunedin, and known as "www.kimclifford.co.nz".

This is the first renewal for the licence and is for a roll-over of the present conditions.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

The Licensing Inspector has assessed the application against the criteria in the Act and is satisfied that the business is being conducted properly.

The Police has had discussion with the applicant regarding the imposition of two conditions which relate to the sale of single serve RTDs, shots, beer and cider in containers of 500ml or less and the external advertising of alcohol and/or specials on the premises. The applicant agreed to the conditions being included on the licence.

The Committee is unsure of the rationale of the imposition of the conditions. There is no information supporting the necessity of either condition. The applicant has no history of selling shots or single serve RTDs, beer or cider and there is no evidence that the applicant advertises on the exterior of their premises.

The Committee believes the purpose and object of the Act are being met without the imposition of the conditions suggested by the Police and are therefore will not be added to the conditions on this licence. If there is a need to make changes to the conditions of this style of licence the matter should be presented to the Committee.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and therefore renew the licence until 15 September 2025, that being three years from the first anniversary of the licence and authorise the issue of a replacement licence and notice of renewal.

INTRODUCTION

- [1] This is an application by OURFC Bookies Bar Limited for an on-licence for their premises situated at 20 Logan Park Drive, Dunedin, and known as "Bookies Bar".
- [2] OURFC Bookies Bar Limited is a trading entity established by the Otago University Rugby Football Club Incorporated so they can apply for this on-licence for their premises.
- [3] They are seeking the on-licence because they are a very popular destination for functions, many of which are at short notice, which necessitates them applying for special licences. An on-licence would allow them to hold functions without relying on special licences.
- [4] The application has not been opposed but the Committee has called the matter to be heard to reassure itself the premises will be operated as intended by the Applicant.

Mr Hessian

- [5] Mr Hessian is the Chair of the Otago University Rugby Football Club Incorporated.
- [6] He said the premises will continue to be primarily a rugby club with both playing and non-playing members. While the club is known as a student rugby club, a significant proportion of the membership is non-student. The club is affiliated with the Otago University Students' Association and provide and administer a number of scholarships through the University of Otago. Some are independent of the university while some are closely aligned.

- [7] The club works primarily for its membership where its revenue is through the membership and the hiring of the club facilities for functions and conferences. The club needs to raise more money so looked at a new income stream. They receive a lot of requests for use of the venue, often at short notice, and require late applications for special licences.
- [8] There has been a significant upgrade of the premises to better cater for the number of functions being requested and to be able to support community events. There have been significant events in the past year, for example the ICC Women's World Cup, and the FIFA Women's World Cup next year where four games will be played in Dunedin. The facility will primarily be for the membership but will also be available for the community.
- [9] Mr Hessian said they were not considering opening as a general bar but will continue to operate as a club but with the ability and flexibility to cater for functions if they do not interfere with the normal club activities.

Mrs Jackson

- [10] Mrs Jackson is responsible for the running of the bar and functions. She commented that the people who work in the bar are parttime and they do it for the club. When asked by the Committee, she said the examples of the types of functions at the premises are student balls and birthday parties and recently, the All Blacks Experience. They generally open the bar on Thursday, Friday and Saturday nights and, during the cricket season, Wednesday nights.
- [11] The Committee asked if they would open every night if an on-licence is granted but Mrs Jackson said other than Thursday and Friday nights for rugby events, and definitely Saturday nights, the only other times they anticipate opening is for events.
- [12] In response to a query about the lighting at the premises, Mrs Jackson said the building itself has lights and there is Butts Road and Logan Park Drive. That lighting is not controlled by the club. They are always aware of people safety and provide a courtesy van to support patrons travelling from the venue safely.
- [13] The Committee asked if they intended to engage with the students during 'Flo-week', 'O-Week' and 'Re-O'. Mr Hessian said that was not their intention and they have no interest in doing so in the future. They are shut down during the orientation period at the beginning of the year. The students who are around the rugby scene are often training for the coming season.
- [14] The students think their drink prices are too expensive and the club will be maintaining those prices. They can buy alcohol from the supermarkets a lot cheaper.
- [15] The Committee told the Applicant about the strategy used by late night venues where the style of music is changed to more relaxed listening style near the end of the night, so the patrons unwind and get ready to leave. Mrs Jackson said that is something they would look at and Mr Hessian commented that turning the lights up also helps get people ready to leave.
- [16] When asked about nights when there is a game or event at the Forsyth Barr Stadium and how their bar will operate, Mrs Jackson said they would be open pre-game or event and again afterwards. They are aware people will be drinking alcohol at the stadium so will be promoting food. They have a 'chill out room' if needed for people who become intoxicated and need a place of safety.
- [17] The Committee asked if there were occasions when the premises was used by non-club members. They replied that whenever that has happened their club facilities have been closed. The Otago Cricket Association would use the Applicant's space to provide food for cricketers when there was a fixture at the Oval. No alcohol is sold in the Applicant's area. If they want alcohol with their food, they need to return to the Cricket facility. Any large event there will always be club members present.
- [18] The Applicant confirmed the club has no intention of seeking an off-licence.

[19] They have confirmed they were ready to step up from their current club licence to an on-licence. They are aware of the different requirements and responsibilities and have trained accordingly.

Mr Hessian - summary

[20] When the club first applied for the on-licence they stated they wanted to open every day. however, after taking advice they realised that was unrealistic. They hours they now seek excludes Monday with the other days listed below. Tuesday hours are to be able to cater for the occasional meetings. Wednesday to Saturday is mainly for club activities and Sunday is to allow for any games on that day. it is unlikely the premises will open at 11.00 am but there are some functions that require an early start.

DECISION

- [21] This application results from a sporting club applying for an on-licence. This is motivated by the number of requests they received for functions to be held at their premises which is located adjacent to the University of Otago and Otago Polytechnic campuses. The premises is near student accommodation which caters for the high risk 18–24 year age group.
- [22] The application was not opposed but the Committee asked for the hearing so they could satisfy themselves the premises was not going to become a typical tavern.
- [23] The Committee has considered the impacts of having a new venue in the North Dunedin area, especially as the area is identified in Dunedin's Local Alcohol Policy as having a significantly higher density of young people who have demonstrated a higher rate of alcohol misuse and abuse when compared to other groups. However, the Committee is assured the Applicant will still be operating primarily as a club, but the on-licence will provide greater ability for them to be able to use the venue for functions, especially those that are short notice and not able to obtain a special licence. The change from a club to on-licence brings with it additional responsibilities and the Applicant has planned appropriately.
- [24] The club is situated in the same building as the Otago Cricket Association which has an on-licence held by Pelichet Bay Limited. While they do not share facilities, there is access between the two clubs. While section 25 of the Act allows two separate licences to be held in one premises this does not extend to club licences sharing facilities with on-licences. The granting of this licence will remove the issue.
- [25] We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol for consumption on the premises, to any person who is present on the premises.
- [26] The applicant's attention is drawn to ss.56 and 57(1) of the Act obliging the holder of an on-licence to display:
 - a. A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; <u>AND</u>,
 - b. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; AND,
 - c. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.
- [27] The licence will be subject to the following conditions:
 - a. No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day to any person who is not present on the premises to dine.

b. Alcohol may be sold only on the following days and during the following hours:

Tuesday 4.00 pm to 10.00 pm

Wednesday 11.00 am to 10.00 pm

Thursday to Saturday 11.00 am to 12.00 midnight

Sunday 11.00 am to 10.00 pm

- c. The following steps must be taken to promote the responsible consumption of alcohol:
 - (i) A range of food choices must be readily available at all times that the premises is open. Menus must be visible, and food should be actively promoted. A minimum of three types of food should be available. The range or style of food will be shown on any menu submitted. Alternatively, the range of food should include such items as paninis, pizzas, lasagne, toasted or fresh sandwiches, wedges, pies, filled rolls, and/or salads.
 - (ii) A range of low alcohol and non-alcoholic drinks must be readily available at all times the premises is open.
 - (iii) Water must be freely available at all times that the premises is open.
- d. The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - (i) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
 - (ii) The whole of the premises is designated a supervised area.
- e. The licensee must ensure that signs are prominently displayed within the licensed premises detailing information regarding alternative forms of transport from the premises.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance(s) to the premises as outlined in the plan received by the Dunedin District Licensing Committee on 9 June 2022. The entrance from the carpark is designated as the principal entrance.

The Committee is satisfied that the applicant will operate the premises properly and therefore issues an order authorising the applicant to carry on the sale and supply of alcohol, under the same conditions as were granted initially, for a period of three months from 28 October 2022.
