DECISION

This is an application by Ganen Lin Limited for the renewal of an alcohol on-licence in respect of their premises situated at 282 Moray Place, Dunedin, and known as "Wong Gok". The licence is endorsed pursuant to s.37 of the Act which makes special provision to identify the premises as having a BYO licence.

The application is for a roll-over of the present conditions.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

The Licensing Inspector has assessed the application against the criteria in the new Act and is satisfied that if the application was made pursuant to the new Act, it would be granted.

The premises is considered a very low risk of alcohol-related harm however, the Licensing Inspector would like to have a certified manager present when alcohol is present in the premises.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and therefore renew the licence until 17 December 2026, that being the anniversary date of the licence and three years from the most recent date of expiry and authorise the issue of a replacement licence and notice of renewal

A condition has been added requiring the presence of a certified manager when alcohol in being served in the premises.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and therefore renew the licence until 22 October 2026, that being the anniversary date of the licence and three years from the most recent date of expiry and authorise the issue of a replacement licence and notice of renewal.

HEARING at Dunedin, 19 September 2023

INTRODUCTION

- [1] This is an application by Samgan Limited for the renewal of the off-licence for their premises situated at 408 Andersons Bay Road, Dunedin, and known as "Andersons Bay Liquorland". The Applicant is not seeking any changes to the condition on the licence.
- [2] Public notice of the application did not attract any public objection and neither the Medical of Health nor the Licensing Inspector oppose the application.
- [3] The Police have opposed the application to seek the inclusion of two conditions on the licence. The first is a prohibition of the sale of single units of beer, cider and RTDs at, or less than, \$6.00 per unit. The second condition is the prohibition of alcohol advertising and/or promotion of alcohol on the exterior of the premises.
- [4] The Licensing Inspector noted in their report that the Applicant had voluntarily removed high alcohol, low-cost single units from the store.

PROCEDURAL MATTERS

[5] Sgt Jones advised that Dr Jackson was waiting to present using an audio-visual link (AVL) and requested her evidence to be taken as read. The Applicant advised they did not intend to cross-

examine the evidence, so the Committee took her evidence as read and excused her from the hearing.

HEARING

Mr C Hart

- [6] Mr Hart is one of the two directors and shareholders of Samgan Limited.
- [7] He told the Committee they took the sale of alcohol very seriously. They understood having an alcohol licence was an honour, not a right. He gave evidence they enjoy engaging with their customers and the energy the business brings. Mr Hart acknowledged that alcohol was an issue in New Zealand, and they do what they can to mitigate the harms associated with its consumption.
- [8] The premises is situated in a commercial area making it a destination. It is not a premises used for impulse purchases. They offered 'click and collect' but did not offer a delivery service.
- [9] Ms Hogg said they were concerned at the Police proposal to have a minimum price imposed. The government has considered price control in the past, but the idea was discounted because it would not impact the people with alcohol issues. She also said they were not able to enter into agreements that set prices or controlled what can be sold. This was contrary to the Commerce Act.
- [10] Mr Hart said it was unreasonable to restrict single unit sales which were permitted in the Act. The range of alcohol at the store is legal and is intended to cater for their customers.
- [11] The Applicant does not support the conditions requested by the Police. Their position is it would put them at a competitive disadvantage because the same conditions were not imposed on other off-licence premises in the city. The Applicant said they acknowledge what the Police are trying to achieve and because of that, they have removed the high strength alcohol that is sold cheaply.
- [12] To impose a section 117 condition on a licence, it must be reasonable and "no more restrictive than necessary to mitigate against the identified evil" (Vaudrey and Bond, [2015] NZHC 2749). Mr Hart gave evidence that the products referred to by the Police are within what is considered as acceptable for the sale from off-licence premises. There is no restriction in the Act on the size or type of container in which alcohol must be sold. Only the government can declare a product to be banned or restricted.
- [13] Regarding the external advertising, Mr Hart said they only had four black and white posters on the exterior of the premises. When asked, he said the wall was very large and he suggested the area of the four posters would be less than 1% of the total area.
- [14] The Licensing Inspector told the Applicant that their website still showed the high strength, low-cost products in their store. Mr Hart said they should have been removed but head office managed the site. He said they would check their website to ensure they are removed.
- [15] In response to questions from the Police, Mr Hart said all staff undergo training to identify at risk customers and how they should be dealt with in the store. They also learn how to recognise and respond to alcohol-related harm. He said they did not highlight harms to their customers but did consider their levels of intoxication. When they took over the store in 2016 there were 11 budget beers being sold in the store. Now they only have two budget beers. He reiterated that the premises was a destination for people therefore 'impulse' purchases seldom happened. They set their prices for the better products which in turn attracts better customers.
- [16] Mr Hart was asked if they had people coming from the fast-food outlets across the road. He replied that they seldom had people from those places. They did get some tradies stop in on their way from work. Responding to another question, he said they occasionally had young

- children come into the premises with their parents. They had a blanket ban on school uniforms in the store, even if they were 18 years old.
- [17] Sgt Jones cited the object of the Act and asked Mr Hart how their practices helped to minimise alcohol-related harm. Mr Hart said he had not seen any evidence that the sale of single units caused problems. It was more likely to be the 24-pack that cause issues. He emphasised that it was an opinion, but he had not seen evidence relating to harm and the sale of single units. He said he was in Australia about 12 years ago when the excise tax on alcohol was increased. Mr Hart said more issues arose because people turned to much higher strength spirits which could not be controlled the same.
- [18] Sgt Jones asked how many single products they had priced under \$6.00, Mr Hart did not think they had any. When asked why he was opposed to the condition, he said they didn't want to get 'boxed in'. If the economy changed, they wanted to retain the ability to change as well.
- [19] The Committee asked if they had been the subject of a controlled purchase operation. The Applicant said they had in the past but not recently. They had refused service to the minor so there was no breach.
- [20] When asked, the Applicant said the agencies had not approached them about any issues in the past. This renewal was the first he had heard of the Police concern.
- [21] Mr Hart was asked what they did with damaged stock. He said it was taken out the back and the supplier picked it up and a credit came back to them. He said there were some 'core products' provided by Liquorland that must be stocked but generally, there were no company-imposed restrictions.
- [22] The Committee asked what the customers' reaction was when they couldn't buy their single units. Mr Hart said some bought a multipack while others left the store without making a purchase.
- [23] When asked about their external advertising, Mr Hart said their intention was to maintain their current style which consisted of four black and white posters with no logos or pictures. This is a nationwide move by the company.
- [24] Mr Hart said there was a manual incident book in the store. Every incident is recorded in the book and if necessary, CCTV footage of incidents is available for the Police to help their investigations.

Sgt Jones

- [25] Sgt Jones is the Dunedin Police Alcohol Harm Prevention Officer. He presented his submission and evidence, and it was accepted. Sgt Jones also presented the brief of evidence from Dr Jackson.
- [26] He produced data taken from the various platforms used as part of the NZ Police National Intelligence Geospatial Mapping Platform in the form of maps indicating the locations of various alcohol-related offences that have occurred within an 800m radius of the premises. Also included on the maps are the levels of deprivation, which in this case, are very high, so one may get an understanding of the link between deprivation and alcohol-related offending.
- [27] On another map Sgt Jones indicated the locations of the other five off-licence premises within 800m as well as the locations of sensitive locations which include education facilities and a social services centre.
- [28] The data used for the maps is for the four-year period of 2 September 2019 to 1 September 2023.

- [29] Sgt Jones made the comment that the Authority had imposed conditions on licences stating there was a minimum price of \$6.00 per single unit and believed the Committee should follow their example.
- [30] Sgt Jones described the types of incidents he has attended that had alcohol as a contributing factor. He also describes the impact intoxicated people had on other services in the city, for example, the Emergency Department at the hospital where sick people are required to wait while those with alcohol-related injuries are being treated.
- [31] With regard to external advertising, Sgt Jones said that, while he did not have photographic evidence, there was product promotion and specials on the exterior of the premises that was visible from their carpark and Andersons Bay Road. He produced a direction notice from the Auckland District Licensing Committee as an example of what he considered acceptable practice.
- [32] The Committee asked if the Police would oppose off-licence premises that were situated in areas of low deprivation. Sgt Jones said it would be looked at on its merits.
- [33] Sgt Jones was asked what evidence there was indicating single unit sales were the cause of harm. He replied that one needed to focus on the products that were causing harm.
- [34] In response to another question, Sgt jones said the Authority has stated there did not need to be a causal link between alcohol-related harm and specific premises. Andersons Bay Liquorland will be contributing to the alcohol-related harms identified in the area.

Ms Blair

[35] Ms Blair is Licensing Inspector for the Dunedin City Council. She said she had no issue with the applicant nor how they operated the store. She did not oppose the renewal application and had nothing further to add.

CLOSING

Sgt Jones

- [36] Sgt Jones reiterated that the Applicant's store contributed to the alcohol-related harm in the area. He said he produced evidence that demonstrated a correlation between alcohol-related harm and the deprivation of an area. Sgt Jones said the Committee should be responsible and put in place measures to protect the community.
- [37] Dr Jackson is an expert in her field. Her evidence demonstrated there was a link between advertising and alcohol-related harm, especially amongst young people.
- [38] The Applicant has excluded some products from their range but wanted to retain the ability to be flexible. Sgt Jones emphasised that he was not wanting to exclude any products from the store
- [39] The Police sought two conditions. The first is that there is a prohibition on the external promotion and advertising of alcohol. The second is a prohibition of single unit sales of beer, RTDs and shots at or less than \$6.00 per unit.
- [40] The Committee asked if any advertising at the premises exposed people from the sensitive locations listed in his submission to 'harmful alcohol exposure' when the premises was not on any walking route. What influence would the premises have on those 'sensitive people'? Sgt Jones said the harm was clear in Dr Jackson's evidence.

Mr Hart

[41] Mr Hart told the Committee that the Andersons Bay Liquorland was a responsible retailer, and they took pride in how the premises was operated.

- [42] He said that if the Committee did not renew the licence, there would not be any reduction in the amount of alcohol-related harm in the area. If they imposed the conditions being sought by the Police, the store would be at a disadvantage compared to the other off-licences in the area.
- [43] Mr Hart said there had been no evidence presented at the hearing that indicated single unit sales were causing more harm than any other sale.

DECISION

- [44] This is an application for the renewal of an off-licence for the Andersons Bay Liquorland. The premises has been licensed since 2016 and this is the first renewal that has attracted opposition.
- [45] The Police sought two conditions. The first is that there is no external advertising or promotion of alcohol. The second is a prohibition of all single unit sales of beer, RTDs and shots at, or less than, \$6.00 per unit.
- [46] The Applicant said the imposition of the minimum price was unreasonable. The government had considered such a move in the past, several times, but has discounted it stating they did not believe such a move would impact those it was meant to target. The Applicant pointed out that minimum pricing would be contrary to the Commerce Act which prohibited any form of price control.
- [47] With regards to external advertising, the Applicant said they only had four black and white posters on the exterior which named a product with the associated price. There was no image of the product itself. They said this was to be the new standard for the brand across the country.
- [48] The Committee is mindful of the Police goal to reduce alcohol related harm. However, we are not convinced the conditions being sought by the Police would impact the alcohol-related harm alluded to and therefore we consider them to be unreasonable.
- [49] In *Dharma Enterprises Limited* [2023] NZARLA 79, in their discussion of a minimum price, the Authority commented at [22] that, "In general, conditions have been imposed or accepted in various forms relying upon either a volume limit, a price limit, a brand limit or a combination of those elements. Many of these conditions have been offered by responsible licensees…"
- [50] However, in [23] of that case, they went on to say, "The licensing inspectorate has signalled its intention as to a uniform condition comparable to the condition imposed by the DLC. That approach of a fixed price base without any other qualification, does give rise to the concern discussed in this appeal that it may result in motivating customers to choose single units with higher alcohol strength which in itself may increase the risk of alcohol-related harm and thereby be an outcome not consistent with the object of the Act. We leave that broader discussion for a more appropriate set of circumstances."
- [51] The Committee is of a similar mind. We have not been presented evidence of harm from single unit sales. Imposing a minimum price for single units may, as suggested by the Authority, move customers to purchase a higher strength product which we believe would exacerbate the harm the condition is supposed to minimise.
- [52] The Committee therefore will not support the imposition of this condition.
- [53] With regards to the external signage displayed, the Applicant has adopted the same approach as other Liquorland franchises in Dunedin with only four black and white posters stating the product's name and a price. There are no images to attract the attention of passers-by.
- [54] The Police raised the vulnerable people at the nearby schools and social service agencies, the nearest of which is 260m away and separated by a very busy, main arterial route. The premises is not located on a walking path from any residence to the schools therefore the simple signage used would not, we believe, impact those attending the sensitive locations. The Dunedin Local

Alcohol Policy (LAP) states a new licensed premises will not generally be granted to a premises that is near to or adjacent to any 'sensitive facility', such as schools and playgrounds. To avoid any misinterpretation, 'near to or adjacent to' is defined as being within 100m of the nearest boundary to the sensitive facility. This application is for the renewal of a licence and is well outside the 100m described in the LAP.

- [55] In Singh Trading (2016) Limited [2021] NZARLA 123, the Authority said, "In terms of the school being near the premises the Authority agrees that 'nearness' requires consideration of context. It cannot be said that simply because the school is less than 100 m away as the crow flies, it is near the proposed premises. Consideration must be given, as Singh Trading submits, to the premises and the school being separated by the main road, the railway tracks, a grass reserve and another street running behind the train station. These factors tend toward the premises and the school not being 'near' for the purposes of s 106(1)(b)."
- [56] In considering the renewal of a licence, the Committee is guided by section 131 of the Act which in turn directs our attention to section 105.
 - a. Section 105(1)(a) object of the Act. The Committee was presented with no evidence that the Applicant sold alcohol in any manner that was not safe or responsible.
 - b. Section 105(1)(b) suitability of the Applicant. This was not challenged.
 - c. Section 105(1)(c) relevant Local Alcohol Policy. There is a minimum distance requirement for new off-licence premises however this is a licence renewal.
 - d. Section 105(1)(d) trading days and hours. The trading hours for the premises was not challenged.
 - e. Section 105(1)(e) design and layout of the premises. This was not challenged.
 - f. Sections 105(1)(f) & (g) whether the Applicant is engaged in the sale of goods, or provision of services, other than those directly related to alcohol. This was not mentioned.
 - g. Section 105(j) appropriate systems, staff, and training. This was not challenged.
 - h. Section 131(1)(b) amenity and good order. No evidence was presented that the amenity and good order of the locality would improve by more than a minor extent if the licence was not renewed.
 - i. Section 131(1)(d) the manner in which the applicant has sold, displayed, advertised or promoted alcohol. The Police have challenged the advertising on the exterior of the premises however, the Applicant only has four, black and white posters on the exterior of the building which only state the product being sold and a price. There are no images of the products. The Committee does not consider these to be excessive.
- [57] To ensure the current style of external advertising is maintained, we have included a condition on the licence restricting external advertising to black text with only the product and company name/logo and price.
- [58] We are satisfied as to the matters to which we must have regard as set out in s.131 of the Act and therefore renew the licence until 17 May 2026, that being the anniversary date of the licence and three years from the most recent date of expiry. We authorise the issue of a replacement licence and notice of renewal.

DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

DECISION

This is an application by The Local Brews and Bites Limited for an off-licence in respect of the premises situated at 198 Main Road, Waikouaiti, and known as the "Golden Fleece Hotel".

The application is in respect of premises in which the principal business is the sale of alcohol.

The application results from a change of licensee. The premises is currently operating under a temporary authority.

The application was duly advertised and no objection or notice of desire to be heard has been received.

The off-licence premises is a bottle store in a part of the larger hotel structure. The Licensing Inspector reported some of the applicant's processes as being 'rusty' but remedies for these were left for the applicant to correct. There was no opposition to the grant of the licence.

Accordingly, we deal with the matters on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an off-licence authorising the sale and supply of alcohol for consumption on the premises, to any person who is present on the premises.

The applicant's attention is drawn to ss.56 and 57(a) of the Act obliging the holder of an off-licence to display: -

- A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; <u>AND</u>,
- 2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; <u>AND</u>,

3. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

The licence will be subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day
- (b) Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 8.00 am to 10.00 pm

- (c) The following parts of the premises is designated a supervised area: every bar and bottle store.
- (d) While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- (e) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance(s) to the premises as outlined in the plan received by the Dunedin District Licensing Committee on 24 October 2023. The entrance from Main Road is designated as the principal entrance.

DECISION






