DECISION OF THE DUNEDIN DISTRICT LICENSING COMMITTEE

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

DECISION

This is an application by Moyles Supermarket Limited for the renewal of an alcohol off-licence in respect of their premises situated at 230 Main South Road, Green Island, and known as "FreshChoice Green Island".

The application is for a roll-over of the present conditions.

The application was duly advertised, and no public objection has been received. The Police submitted an 'interim opposition' on 1 December 2022 but there has been no further Police correspondence relating to this application. The Licensing Inspector, while not opposed to the application, supports the unstated position of the Police in the interests of a level playing field. The Medical Officer of Health does not oppose the renewal.

The Committee turns to relevant case law in considering this application. In *Paulin v. Scott* [2013] NZARLA 489, the Authority said at [7] "The Authority appreciates that in some situations the Police may not be able to express their grounds for opposition with adequate particularity within 15 working days after receiving the application. In these circumstances, having filed the initial report within 15 working days, it would be permissible for the Police to state their grounds in opposition in more detail within a very short period of time. The Authority envisages that this would be within 15 working days after the initial report."

As clearly stated, it is expected that a full report detailing the matters in opposition is submitted as soon as possible after the first email. This has not happened in this matter.

Further, in Sargent v. Kapiti Supermarket Limited [2015] NZARLA 194, the Authority said at [16] "After the expiration of the 15 day period and at the hearing before the DLC, the Police were not entitled to alter their original stance. ... [I]t is important that District Licensing Committees and the Authority require compliance with the statutory obligations of the reporting agencies. Too often recently have reporting agencies failed in this regard and as a result breaches of natural justice have

occurred. This must not be permitted to continue. Finally, the waiver provisions contained in s.208 of the Act will seldom apply as the neglect or omission will usually be wilful."

Following the precedent set by the Authority, the Committee expected the Police to have filed a more detailed report within a very short period of time after the initial report being submitted. Almost three calendar months have passed since the interim opposition and no additional information has been provided. The Committee finds in the absence of a more detailed report, the Police opposition does not amount in fact or in law to an objection and need not proceed to a hearing. Accordingly, the Committee is guided by *Sargent v. Kapiti Supermarket Limited* in that we have a duty to ensure compliance with the obligations of the reporting agencies and subsequently we must not allow the submission of a detailed report after the expiration of the allowable time period. To do so would be a breach of natural justice.

On this basis, the Committee deals with the matter on the papers based on the information having been submitted.

The Licensing Inspector has assessed the application against the criteria in the Act and reports being satisfied the premises is compliant with the legislation and there are no suitability issues raised with regard the applicant.

The Inspector has, however, anticipated the Police opposition would relate to the sale of single serve, high percentage alcohol beer and the external advertising and promotion of alcohol. The applicant has a display of single serve alcohol but has also indicated they would comply with any direction as to what was acceptable. The Committee has yet to form a position regarding these matters so it would be inappropriate to comment at this stage.

The Committee may release a position statement in the future, and this would be circulated to relevant off-licensed premises.

We are satisfied as to the matters to which we must have regard as set out in s.131 with reference to the relevant subparts of s.105 of the Act. Therefore, we renew the licence until 1 December 2025, that being the anniversary date of the licence and three years from the most recent date of expiry and authorise the issue of a replacement licence and notice of renewal.

The premises has the restaurant on the ground floor as well as office space upstairs. The office space is not part of the applicant's business.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol for consumption on the premises, to any person who is present on the premises.

The applicant's attention is drawn to ss.56 and 57(a) of the Act obliging the holder of an on-licence to display:-

- A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; <u>AND</u>,
- 2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; <u>AND</u>,
- 3. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

The licence will be subject to the following conditions:

- (a) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day to any person who is not present on the premises to dine.
- (b) Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 11.00 am to 1.00 am the following day: EXCEPT THAT on the Thursday before Good Friday, and on Easter Saturday, and on Christmas Eve and on the day before Anzac Day, alcohol may only be sold between 11.00 am and 12.00 midnight.

- (c) The following steps must be taken to promote the responsible consumption of alcohol:
 - (i) A range of food choices must be readily available at all times that the premises is open. Menus must be visible, and food should be actively promoted. A minimum of three types of food should be available. The range or style of food will be shown on any menu submitted. Alternatively, the range of food should include such items as paninis, pizzas, lasagne, toasted or fresh sandwiches, wedges, pies, filled rolls, and/or salads.
 - (ii) A range of low alcohol and non-alcoholic drinks must be readily available at all times the premises is open.
 - (iii) Water must be freely available at all times that the premises is open.
- (d) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - (i) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (e) The licensee must ensure that signs are prominently displayed within the licensed premises detailing information regarding alternative forms of transport from the premises.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S

A copy of this licence must be displayed at the principal entrance(s) to the premises as outlined in the plan received by the Dunedin District Licensing Committee on 9 November 2022. The entrance from Filleul Street is designated as the principal entrance.
