  - (ii) A range of low alcohol and non-alcoholic drinks must be readily available at all time, the premises is open.
  - (iii) Water must be freely available at all times that the premises is open.
- (d) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
  - (i) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.

If the event did not take place, the litter would not have been left in the area.

The agencies have reported the applicant has put in place measures to mitigate what they observed in 2023 and have recommended this event be allowed to proceed so their new controls can be observed. Of note is the ratio of one security person per 100 attendees.

The Committee's first response is to call the matter to a hearing. However, the agencies have been liaising with the applicant and we accept the recommendation as presented. We therefore grant the

special licence; a copy of which is attached to this decision setting out the conditions to which it is subject.

We would like to advise the applicant that this event will determine the outcome of future events of this nature.
