DECISION

This is an application by Pirates Squash Rackets Club Incorporated for a club licence in respect of their premises situated at 4 John Wilson Ocean Drive, Dunedin, and known as the "Pirates Squash Rackets Club".

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

The club was previously licensed but due to a committee member leaving, advice of the pending renewal of that licence wasn't received by active members and the licence expired. Their processes have been amended to ensure no repeat of this occurs.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant a club licence authorising the sale and supply of alcohol for consumption on the premises, to any member of the club, guest of a member at the invitation of that member or member of another club which has reciprocal visiting rights with this club, who is present on the premises.

The applicant's attention is drawn to s.57(2) of the Act obliging the holder of a club licence to display: -

- 1. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons using the premises; <u>AND</u>,
- 2. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

The licence will be subject to the following conditions: -

(a) The club must have a secretary at all times:

- (b) Within 10 working days of the appointment of a new secretary, the club must inform the Secretary of the District Licensing Committee the name of the new secretary:

Alternatively, the range of food should include such items as panni's, pizzas, lasagne, toasted or fresh sandwiches, wedges, pies, filled rolls, and/or salads.
 - (ii) The club must have available for consumption on the premises, at all times the club is open for the sale of alcohol, a reasonable range of non-alcoholic and low-alcohol refreshments.
 - (iii) Drinking water must be freely available from the bar and other suitable locations within the premises.
- (e) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - (i) The licensee must ensure that the provisions of the Act relating to the sale and supply of liquor to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of liquor to minors and the complete prohibition on sales to intoxicated persons.

DECISION

This is an application by As You Wish Limited for an on-licence in respect of the premises situated at 95 Filleul Street, Dunedin, and known as "Brazen". The general nature of the business to be undertaken is that of a restaurant.

The premises has previously been licensed but there is no temporary authority in place.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol for consumption on the premises, to any person who is present on the premises.

The applicant's attention is drawn to ss.56 and 57(a) of the Act obliging the holder of an on-licence to display:-

- A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; <u>AND</u>,
- 2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; <u>AND</u>,
- 3. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

The licence will be subject to the following conditions:

- (a) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day to any person who is not on the premises to dine.
- (b) Alcohol may be sold only on the following days and during the following hours:

Tuesday to Thursday 11.30 am to 10.00 pm

Friday and Saturday 11.00 am to 11.00 pm Sunday 11.00 am to 10.00 pm

- (c) The following steps must be taken to promote the responsible consumption of alcohol:
 - (i) A range of food choices must be readily available at all times that the premises is open. Menus must be visible, and food should be actively promoted. Alternatively, the range of food should include such items as paninis, pizzas, lasagne, toasted or fresh sandwiches, wedges, pies, filled rolls, and/or salads.
 - (ii) A range of low alcohol and non-alcoholic drinks must be readily available at all times the premises is open.
 - (iii) Water must be freely available at all times that the premises is open.
- (d) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - (i) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
 - (ii) The whole of the premises is designated a supervised area.
- (e) The licensee must ensure that signs are prominently displayed within the licensed premises detailing information regarding alternative forms of transport from the premises.

HEARING at Dunedin on 09 December 2024

INTRODUCTION

- [1] This is an application for a new on-licence for the premises situated at 354 Great King Street, Dunedin, and known as "DropKicks". The premises application is to occupy the upstairs area of the former Captain Cook Hotel.
- [2] Public notification of the application attracted two objections. The first was from the Students for Sensible Drug Policy Ōtepoti Dunedin (SSDP) and the second from Mr B Crestani and Ms E McMillan.
- [3] The reporting agencies did not oppose the granting of the licence.

HEARING

The Applicant

[4] Mr DeCourcy is Counsel for the Applicant. He explained that Ms Oxley Lobo would outline how the premises is to be operated and what it's focus will be.

- [5] He said the project is about music, Dunedin music, in a venue that is safe for people to enjoy live performances by local musicians. It will see a return of live entertainment to a traditional home of music in Dunedin. It is not a student bar and will not operate as a bar. It will be entirely event orientated, mainly music events, and the supply of alcohol will be ancillary to the entertainment.
- [6] Ms Oxley Lobo is the sole director, and equal shareholder with her partner Mr B Oxley, of this and another company that operates a nearby business. It is acknowledged that they are two different style premises but she has another similar venue, Errick's, near the bottom of Crawford Street by the Oval that has a similar entertainment focus but will also have other type of events. The process to get the latter premises operational has informed them with preparing for this premises.
- [7] In her evidence, Ms Oxley Lobo explained how they will operate the premises in a manner that makes it safe for all people attending an event and the sale, supply, and consumption at the premises will be undertaken safely and responsibly.

The Applicant's Evidence

- [8] Ms Oxley Lobo is the sole director of the applicant company Loboski Venues Limited which operates "Errick's" and Loboski Hospitality Services Limited which operates "Ombrellos". Both Ms Oxley Lobo and her husband are the shareholders of the businesses. Ms Oxley Lobo explained the experience she and her family has in the hospitality sector.
- [9] "Errick's" is in a former craft brewery and has attached a café and accommodation in part of a heritage hotel that once occupied the site. It is dedicated to music and events and is a hub for live music as well as having in-house production facilities, backline, and rehearsal spaces. They also cater for other events such as business gatherings.
- "DropKicks" is intended to provide an accessible live music and entertainment venue in North Dunedin in a site that has a long association with live music. Ms Oxley Lobo said the name "DropKicks" was chosen because it is used as a derogatory reference to students and to music goers generally. They want to redefine the term and associate it with something worthwhile and of quality. Both "DropKicks" and "Errick's" are intended to rejuvenate and promote Dunedin's music scene and provide safe, well managed environments for the enjoyment of music.
- [11] The Applicant said they were committed to providing a safe and supportive space for students and others to enjoy music. At both venues they believe in the transformative power of bring people together. Their vision is to provide a space where music lovers, artists and the community can come together to celebrate creativity, culture, and friendship.
- Dunedin has longstanding issues with the provision of spaces for people to come together for live entertainment and this has been exacerbated by rising living costs, noise complaints, and the impacts of the global pandemic. Ms Oxley Lobo said they did not want the premises to just be another venue, but a lifeline for the Dunedin community. Their space was crucial for Dunedin, and she cited the following reasons:
 - a. Reducing alcohol-related harm studies have shown that live music can lead to lower overall alcohol consumption and the subsequent alcohol-related harm. They want to foster an environment where people can enjoy high-quality live performances and contribute to a healthier and safer nightlife.
 - b. Supporting local talent they are committed to nurturing local artists and providing them with the opportunity to showcase their talent. Venues are struggling so

- DropKicks will offer a much-needed platform for musicians to perform and connect with their audiences.
- c. Community and collaboration the Applicant's venues are more than just a venue. They are a community hub dedicated to creating a welcoming and inclusive space where people of all backgrounds can come together to enjoy music and events.
- d. Advocate for better planning within the city the Applicant recognises the ongoing challenges that music venues have in the city. They believe in working with local authorities and the community to ensure the city's music and events scene can flourish, advocating for musicians, students, and young entrepreneurs.
- The 'premature announcement of opening' started when someone from The Critic (the Otago University Students' Association publication) wrote a story about the proposed business. They had seen the public notice for the on-licence and found a website being developed by a contract marketer for the Applicant's business. Ms Oxley Lobo said it was not an ideal situation so took control by explaining what was happening. She said they are fully aware of the legal requirements for obtaining a licence and had been fully compliant and co-operative with the process.
- [14] Ms Oxley Lobo told the Committee she had made no social media posts. There was one made by a family member which was out of frustration at what appeared to be personal attack on their ability to operate a licensed premises. The Applicant said they never intended nor expected that it would result in criticism of SSDP.
- The Applicant said they would stock affordable alcohol. By this they mean they will not stock expensive spirits or high alcohol beer or similar products. They will sell their alcohol at a price less than Octagon premises but they will not be cheap drinks. Ms Oxley Lobo said they were very conscious of their obligations regarding the sale and promotion of cheap alcohol and would not in any way encourage excessive consumption of alcohol. They will be targeting a different crowd to that of Ombrellos and Errick's. They want to try and solve some of the social issues and if they priced the alcohol too high then people would not come and the problems would not be solved.
- [16] This will be a music venue and typically less alcohol is consumed at such venues. The patrons will be monitored by duty managers and security staff.
- [17] The premises is upstairs and accessible by two sets of stairs. They will take advice from Fire and Emergency New Zealand (FENZ) regarding evacuation procedures and managing patrons with disabilities. They will generally use one set of stairs to control the number of patrons in the premises and the second set when an evacuation is required.
- The Committee asked about the food that will be available at the venue. The Applicant said they would be similar to the food at Ombrellos and Errick's. The food will be prepared at Ombrellos and brought to DropKicks whenever it is open. There will be food items like fish and chips, burgers, hotdogs, pies and a range of other bar food like chips, bites and hot platters. The cost will be between \$7.50 and \$30 per item. They explained they were fully committed to having quality food available whenever they are open.
- [19] In response to another question. Ms Oxley Lobo said they would not be promoting cheap alcohol. The focus is to make the venue affordable without promoting the alcohol. The primary business at the premises will be events and live music, the same as at Errick's, because there is very little opportunity for people to enjoy live music in Dunedin at the moment, other than at Errick's. There are some very passionate people in Dunedin who have been frustrated for too long. The Applicant has identified this and is trying to do their part to help sort out the problem. The Muso's Club is one place where people go to enjoy the music, not to get drunk. The Dunedin City Council has even written a plan about saving

live music in Dunedin. The Committee referred to the Risk Mitigation to the Community which related to Errick's but was included in this application. Ms Oxley Lobo said the premises would not be operating as a bar. The specials and promotions referred to are for events to get people through the door.

- [20] When asked about staffing, Ms Oxley Lobo said it would depend on the number of attendees. For example, at Errick's, if there were 300 attendees, there would be three duty managers working. In total, the Applicant had five certified managers at Errick's and another three with their LCQ qualification and working towards the manager's certificate, and two at Ombrellos. They would be employing another three certified managers for DropKicks.
- [21] DropKicks will only be open for music events and would be available for private functions. It will not be open as a bar.
- [22] The Committee asked what type of private function could be expected at the premises. Ms Oxley Lobo said they would include celebrations, including birthdays, and corporate events. If the group seeking a private function were students, they would be catered for so long as they agreed to the terms, conditions, and protocols of hire.
- [23] When asked about the hours on the application, Monday to Sunday 11.00 am to 3.00 am the following day, but not operating as a bar, who they were expecting as clientele, Ms Oxley Lobo said students would be their main customer for the music events and the venue would be available for hire by student bands and groups so they had a platform on which to perform. If there are student bands, other students would come and support them. She said they would also look at free hire for student bands.
- [24] The Applicant was asked how often they intended to be open at the premises. Ms Oxley Lobo said their goal would be five days per week but realistically, it would be less initially. The premises would be open to anyone who wants to enjoy listening to music.
- [25] When asked about the premises capacity, the Applicant said they were approved for up to 250 people. In response to another question about the capacity to manage this premises along with the other two, the Applicant said they had everything in place assuming they get their licence granted. They will also keep an incident book at the premises that will record every night they are open and whether or not any incidents occurred.
- The Committee asked about the prices of the drinks listed on their menu. Ms Oxley Lobo agreed that \$6-8 per drink was on the lower side. When questioned further, she said they will be working with No8 Distillery so that cocktails are made fresh for each event and will be served via taps. They would work with the distillery on the price point, depending on the amount of alcohol in the drinks.
- [27] The Applicant was asked about security. She responded that they employ TN Security and they are contracted to work whenever there is an event that warrants their use. The use of security would be dependent on the number of expected attendees and whether or not alcohol is involved. The Committee asked if they would consent to a condition of issue of the licence that security will be provided whenever alcohol is being sold and/or open to the public. Ms Oxley Lobo said that would be fine.

Licensing Inspector

[28] Ms Morrison is a Licensing Inspector for the Dunedin City Council. She said she did not oppose the application and had nothing further to add to her report.

- The Committee asked if the premises was granted a licence, if the Licensing Inspector would visit the premises from time to time, especially in the first year. Ms Morrison said the agencies' visits were based on the risk of a venue. DropKicks would be seen as high risk so there would be active monitoring of the premises. While music would be the venue's focus, it is potentially a high risk venue and so it would be monitored to see how it operates. The type of music on offer will dictate the type of crowd at the venue. One cannot ignore the fact there is no other music venue in the area and it will not be exclusively for students.
- [30] Ms Morrison was asked if she thought there was a possibility that the premises could be 'forced' into a position of taking over the role of Starters Bar and a student orientated tavern. Ms Morrison said she did not know. The previous owner ran a live music venue. The first year will be monitored and determinative of the direction of the business.
- [31] When asked about events with larger than expected attendance, Ms Morrison said there would be a good Alcohol Management Plan in place which would include crowd control and the role of security. In response to another question, Ms Morrison said there would be no use of the footpath area as an extension of the licensed premises.

Medical Officer of Health Delegate

- [32] Mr Whipp is the Medical Officer of Health Delegate. He told the Committee there was no opposition from Te Whatu Ora and advised he had nothing further to add.
- [33] When asked if there were any conditions he would like the Committee to consider, Mr Whipp said security would be the key to ensure safety on the key nights of Thursday to Saturday as under the previous owner, there was a broad spectrum of clientele.

Dunedin Police

- [34] Sgt Jones is the Alcohol Harm Prevention Officer for the Dunedin Police. He said they have no matters in opposition. He was not opposed to a well-managed premises in the area and that it would attract students because of its location.
- [35] His one concern was the availability of quality food on the days when Ombrellos was not open. Sgt Jones also commented that the security staff will require Certificates of Approval (CoA) and these will be checked during visits. Any queuing for the premises would be on Great King Street which is away from the traffic flow and a lot safer than the Albany Street entrance.
- [36] Sgt Jones was asked about the one-way door policy. He said they work well in the central city. Ideally, he would like to see it extended to an hour before close.

Fire and Emergency New Zealand

- [37] Mr Jones is a Risk Reduction Advisor for Fire and Emergency NZ (FENZ). He said FENZ did not oppose the application.
- [38] When asked about the objections raised in relation to fire evacuations, Mr Jones said they visited the premises on 21 November and noted there were two egress routes. This would allow up to 500 people if it was capable of holding that number of people. The building also has a Type 7 detection system installed. This would provide early warning of a fire and there is a sprinkler system that would provide enough control to allow time to evacuate the building. Mr Jones said they would recommend to the building property manager that an extinguisher should be placed in the upstairs bar area.
- [39] The Committee noted that there was no wheelchair access to the upstairs venue.

SSDP - Objectors

- [40] Dr Gordon advised the Committee she was representing the Objectors, Ms McMillan and Mr Crestani and SSDP.
- [41] Dr Gordon told the Committee that the vulnerability of the location was the basis for the objection. The premises is located in an area of high deprivation which is linked to health and alcohol-related issues.
- There is a high student population living in the area which has been identified as highly vulnerable to alcohol-related harm. Dr Gordon said that, because of its location, the Applicant needed to consider the higher vulnerability threshold, and the Committee needed to consider their suitability to that higher threshold. Dr Gordon said the three matters to be considered in relation to the Applicant's suitability were:
 - a. The demonstration of their knowledge of the locality and surrounding community. The Objector's concern is that there did not appear to be any focus on the venue being a student venue. The premises had previously been a student location, and this needed to be acknowledged.
 - b. The identification of potential problems likely to be associated with the premises. Dr Gordon did not believe this was adequately addressed in the application.
 - c. The Applicant needed to explain how the potential problems would be managed. She acknowledged that the Applicant had explained that a security provider would be present when the premises were open, and alcohol was being sold.
- [43] Dr Gordon expressed concern at the comment that alcohol would be priced lower than in other places when their market was the vulnerable student market. The Applicant also did not appear to have regard to the students pre-loading and/or side-loading.
- [44] Dr Gordon told the Committee that there were four areas of concern raised by the Objectors in relation to the Applicant's suitability:
 - a. The pre-announcement of the opening of the venue ahead of the issue of an alcohol licence.
 - Music and alcohol; the Objectors believe the premises could be run as an alcoholfree venue.
 - c. The social media reactions to the venue.
 - d. An assault on an SSDP member.
- [45] The Committee advised Dr Gordon that they would be considering the facts, not hearsay. They said they considered points b and d above hearsay because there was no evidence provided.
- [46] Dr Gordon said they considered the application lacked the required information. As an example, the drinks menu referred to in the application is from Errick's so they are unsure of what the prices would be at DropKicks.
- [47] The Object's concerns included:
 - a. The suitability of the Applicant;
 - b. The Applicant operating at Errick's under a temporary licence (TA);
 - c. The layout of the premises and whether it was safe for the proposed operation and suitable for those with disabilities to attend;
 - d. Amenity and good order of the locality; and
 - e. Staff and systems the application provided very little detail, and they wanted to view the rosters and the number of duty managers.

- [48] The Objectors did not believe the application met the threshold to gain an alcohol licence.
- [49] The Committee asked where it stated in the application that the drinks list was from Errick's. Dr Gordon replied that DropKicks is not a venue yet so the Errick's list is being used.
- [50] The Committee asked what SSDP were referring to as being ultra vires. Dr Gordon stated that if Errick's wanted to continue then the renewal for New New New should have been notified within the required 20 working days. There is no record of this.
- [51] Dr Gordon stated that the application provided very little information regarding the operation of DropKicks and suggested the matter be adjourned to allow the information to be added. The application makes reference to their other premises, Errick's. This is a very different premises being on the ground floor and very open.
- [52] When asked about the reliance on the decile system for extended suitability, Dr Gordon said they were relying on the vulnerability of the people in the locality of the premises. Referring to the decile rating, the higher the rating, the more likely crime and social, health and alcohol-related issues being the proxy indicators. Dr Gordon clarified that they were referring to the deprivation level from the NZ Census as a decile system.
- [53] In response to another question, Dr Gordon said some of their questions have been answered but there have been no assurances that the venue will be safe. The Objector's position is that there are a number of red flags indicating risk at the premises.

Mr B Crestani

- [54] Mr Crestani is a witness for SSDP. His statement had been circulated to the parties.
- [55] Mr Crestani referred to the death of his daughter at a house party. As a result of this their focus is the safety of students and other patrons at this premises. His main concerns include accessibility, lighting inside the venue, fire safety, emergency management in the stairwell, and food offerings. Mr Crestani said they would like a better understanding of how the venue would operate.
- [56] The Committee acknowledged Mr Crestani's daughter's tragic death and the Hold Onto Your Friends movement that was formed by her friends.
- [57] The Committee asked if Mr Crestani had any further comments to make after hearing the Applicant's submissions. He replied that he was looking for an in-depth understanding of how the venue will operate. He would like to see a refreshed application or an updated operating or management plan to meet the information discussed and operation experience.
- [58] When asked if he thought an on-licence venue was a safer environment to encourage people to come together, Mr Crestani said that with proper management plans, security, and a competent management team checking alcohol levels in patrons, an on-licence is preferable to off-licence premises.

Mr S Stücki

- [59] Mr Stücki gave the evidence on behalf of SSDP. The brief of evidence was pre-circulated. He said SSDP had two major concerns with this application. The first is the overloading of the premises and poor intoxication control by staff.
- [60] Mr Stücki referred to evidence of an anonymous witness. He was advised by the Committee that, unless he provided the name of the witness in confidence, the hearsay

- evidence would be given little weight because the Applicant would not have an opportunity to test the evidence. Mr Stücki continued without producing the evidence.
- [61] Mr Stücki discussed the Applicant's other venue, Errick's, in relation to its occupancy limits. Mr DeCourcy questioned the relevance of this discussion because it was not relevant to DropKicks. Mr Stücki argued there was relevance because it was the same Applicant in both, which holds merit.
- [62] Mr Stücki said that one of the matters raised by Dr Gordon and Mr Crestani was the number of unknowns about the application, including the over-capacity of the venue. The intention of SSDP was to raise concerns about what was missing from the application for the public record.
- The Committee acknowledged that SSDP aimed at promoting well-managed on-licence premises and the need for such premises in the city. They asked what the challenges were and what was their next step in the process. Mr Stücki said it was a complex and dynamic matter. The former Starters Bar was not profitable and had to close and SSDP asked how DropKicks hoped to be different. He said he would like to see something in place that was similar to the University Union putting together a management plan with the assistance of the Committee and reporting agencies. He said, however, that SSDP could not work with the Applicant on a management plan because they questioned whether they could have an honest discussion with the Applicant.

Ms Oxley Lobo

- [64] The Committee asked Ms Oxley Lobo if it was their intention to have a cover charge for the venue. She replied they would with the amount of the charge being dependent on the cost of the artist.
- [65] When asked about the viability of the business, Ms Oxley Lobo said she had a lot of support and guidance available to her and was confident the business would be viable. The Committee asked if a detailed management plan could be put together and made available to them. Ms Oxley Lobo said she would commit to drafting such a plan and would do it in consultation with the reporting agencies.

CLOSING

Licensing Inspector

- [66] Ms Morrison said they would like to see a well-managed venue that was available to everyone, not just the student community. The premises would be monitored for compliance with the legislation because of the high-risk nature of the location. Ms Morrison said they were very supportive of active engagement with the agencies to ensure robust systems and improvements were established.
- [67] The Licensing Inspector remains unopposed to the application.

Medical Officer of Health Delegate

- [68] Mr Whipp commented that a lot of information was presented during the hearing regarding the venue. Although it was a seeking a tavern style licence, it was to be a music venue which would cater for two markets, the student population, and the Dunedin community generally. This made it different to their other entertainment venue.
- [69] The Medical Officer of Health did not oppose the application.

Dunedin Police

- [70] Sgt Jones commented that there was a risk with every application and the Committee was required to consider the evidence put before it. He said that little weight should be placed on the unsubstantiated allegations made during the hearing.
- [71] He said the premises will attract students as well as other members of the public. Sgt Jones said he would expect the Applicant to engage in regular communication with the agencies and the Police looked forward to working collaboratively with the Applicant should the licence be granted.

The Applicant

- [72] The Applicant acknowledged and respected the input of Mr Crestani. The Applicant assured the parties at the hearing that they do have an understanding of the venue and have taken advice from a security firm and the reporting agencies.
- [73] The Applicant confirmed the details relating to the 'one-way door'. It would apply at least an hour before the closure of the premises. At live music events, there will be a one-way door for the duration of the event, that is, once a person leaves the venue there is no reentry.
- [74] The management plan was being worked on in collaboration with the reporting agencies and would be forwarded as soon as it is completed. If the licence is granted, the Applicant is looking forward to working with the community to ensure the best outcome for everyone.
- [75] The current Fire Evacuation Plan was dated 2016. The Applicant will undertake to have the plan independently reviewed to ensure it meets the requirements for the premises.

DECISION

- [76] This is an application by Loboski Venues Limited for an on-licence for the premises situated at 354 Great King Street, Dunedin, and known as "DropKicks". The Applicant is intending to re-establishment an entertainment venue in the upstairs space of the former Captain Cook Tayern.
- [77] Public notice of the application attracted two objections: Students for Sensible Drug Policy Ōtepoti Dunedin, and Mr B Crestani and Ms E McMillan.
- [78] The reporting agencies did not oppose the application.
- [79] The Applicant stated they wanted to establish a safe and supportive space for people to enjoy live music performed by local musicians. They said there was a movement in Dunedin to revitalise the live music scene and the Applicant believes this is an opportunity to re-establish the former live entertainment venue for the North Dunedin area.
- [80] While they also have Errick's, the Applicant said the two venues, while both offering live music, they will be different.
- [81] The Applicant said they were aware of the issues in North Dunedin and the alcohol-related harm in the area.
- [82] The Applicant said their goal is to create a safe, well managed environment where alcohol is not the focus. The premises would not be operated as a bar per se. Alcohol will be offered for sale and at a lesser price than the premises in the Octagon, but not so cheap as to be in breach of the legislation. They are also very conscious of their obligations regarding the sale and promotion of alcohol so excessive consumption is not encouraged in

- any way. There would be a limited range of affordable alcohol for purchase but alcohol would not be promoted at the venue. The Applicant said this was to try and encourage people to stay in North Dunedin rather than move into the central city.
- [83] The Committee has looked at the Applicant's management plan and is concerned the required information is not in the one document. We would like the Applicant to produce a single document that covers the main management processes that will be in place at the premises, including the safe egress from the premises.
- [84] An area of concern expressed by the objectors was the access to the premises. The Applicant said they had a maximum occupancy of 250 people. They said FENZ had inspected the premises and said with the egress routes available, they could cater for up to 500 people. However, the size of the area would not cater for that number so they would stay with 250 as a maximum.
- [85] The Applicant has committed to working with FENZ to ensure there is an approved and operative Fire Evacuation Scheme in place before the 2025 O-week.
- [86] SSDP described the Applicant as being disrespectful of the Act and its processes because of a premature announcement of the opening of the premises. The Applicant denied involvement with the early media comment saying someone saw the public notice and assumed an opening date based on legislative timelines. They had not been approached for comment. The Applicant admitted there had been one social media comment made by a family member out of frustration at what was perceived as an attack on them.
- [87] During the hearing, SSDP referred to the Applicant's other premises, Errick's. They believed the issues relating to that premises and the fact the Applicant has been operating on temporary authorities and special licences casts doubt on their suitability. The applicant had been operating on temporary licences and this was a result of the premises location and the planning rules for that locality. The Committee is satisfied the Applicant has complied with any direction required of them to have that matter resolved.
- [88] The Committee heard about the Applicant's disrespect of the Act, due process, and their attempts to silence community voices. No evidence was presented that indicated the Applicant was not complying with their obligations pursuant to the legislation and from what we understand, they have been receptive to suggestions from the agencies.
- [89] The suggestion the Applicant tried to silence community voices was not supported by evidence nor was the objector willing to provide any other detail.
- [90] The Committee would like to thank Mr Crestani for his interest in the application. The concerns expressed by him in his objection have been discussed by the Applicant and we are satisfied that they do take their business seriously and have appropriate management systems in place to mitigate the concerns raised.
- [91] The Committee would also like to acknowledge the intentions of Mr Stücki and SSDP and the Hold On To Your Friends group. We have the same goals: to have safe, welcoming and well managed premises in the city. This hearing was an opportunity for the Applicant to explain how the premises will be operated.
- [92] In considering an application, the Committee must consider the following criteria:
 - a. S.105(1)(a) the object on the Act. The Committee is satisfied the proposed business operating from the premises will meet the object of the Act. The business will focus on live entertainment and will only be open when entertainment is available. They will not be promoting alcohol, but the acts playing at the venue.

- b. S.105(1)(b) suitability of the Applicant. There was no evidence presented that would indicate issue with the Applicant's suitability. They have indicated they would work with the reporting agencies to ensure there is communication between the parties.
- c. S.105(c) relevant alcohol policy. The Local Alcohol Policy permits the activity at this location.
- d. S.105(d) days and hours of operation. The Committee finds the days and hours for such a venue are appropriate.
- e. S.105(e) design and layout of the premises. Some concern was expressed that there were only two egress routes from the premises. FENZ have indicated the premises was safe for up to 500 people with the egress available, but the Applicant has indicated a maximum occupancy of 250 people.
- f. S.105(f) the sale of goods other than those associated with a licensed premises. This matter was not raised.
- g. S.105(g) provision of other services at the premises. The other 'service' is live music. The Committee considers this to be appropriate at this location.
- h. S.105(h) amenity and good order. The Committee does not believe the amenity and good order of the locality would be reduced by more than a minor extent by the issue of this licence.
- i. S.105(i) amenity and good order of the locality is already so badly affected by existing licences in the area that it would be undesirable to issue another licence. There are only two other nearby on-licences, both more food focussed. The Committee does not believe the amenity and good order of the area is already so badly affected that the issue of this licence is undesirable.
- j. S.105(j) appropriate systems, staff, and training to comply with the law. There was no evidence presented to indicate there was an issue with the systems, staff, or training at the Applicant's other premises. They have indicated they would be employing more certified managers once they start trading.
- k. S.105(k) any other matters raised in agency reports. There was no opposition from the agencies and there were no other matters raised in their reports.
- [93] The Committee is satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol for consumption on the premises, to any person who is present on the premises.
- [94] The Applicant has made an undertaking to produce a single source document which details how the premises will be managed generally, how incidents will be dealt with, and how patron safety will be managed at all times. We are mindful the premises is on a first floor with limited access so this needs to be addressed in the document, along with evacuation procedures in the event of an emergency.
- [95] The licence will be subject to the following conditions:
 - (a) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day to any person who is not present on the premises to dine.
 - (b) Alcohol may be sold only on the following days and during the following hours:
 - Monday to Sunday 11.00 am to 3.00 am the following day: EXCEPT THAT on the Thursday before Good Friday, and on Easter Saturday, and on Christmas Eve and on the day before Anzac Day, alcohol may only be sold between 11.00 am and 12.00 midnight.

- (c) The following steps must be taken to promote the responsible consumption of alcohol:
 - (i) A range of food choices must be readily available at all times that the premises is open. Menus must be visible and food should be actively promoted. A minimum of three types of food should be available. The range or style of food will be shown on any menu submitted. Alternatively, the range of food should include such items as paninis, pizzas, lasagne, toasted or fresh sandwiches, wedges, pies, filled rolls, and/or salads.
 - (ii) A range of low alcohol and non-alcoholic drinks must be readily available at all times the premises is open.
 - (iii) Water must be freely available at all times that the premises is open.
- (d) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - (i) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
 - (ii) The whole of the premises is designated a restricted area.
- (e) A one-way door shall apply from 2.30 am.
- (f) The licensee must ensure that signs are prominently displayed within the licensed premises detailing information regarding alternative forms of transport from the premises.

[96] <u>DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE/S</u>

A copy of this licence must be displayed at the principal entrance(s) to the premises as outlined in the plan received by the Dunedin District Licensing Committee on 4 July 2024. The entrance from Great King Street is designated as the principal entrance.

In accordance with section 191(2) of the Sale and Supply of Alcohol Act 2012 this application has been considered under delegated authority.

DECISION

This is an application by Three Seeds Dunedin Limited for an on-licence in respect of the premises situated at 484 George Street, Dunedin, and known as "Lone Star Dunedin". The general nature of the business to be undertaken is that of a restaurant.

The application results from a change of licensee. The premises is currently operating under a temporary authority.

The application was duly advertised and no objection or notice of desire to be heard has been received. Accordingly, we deal with the matter on the papers.

We are satisfied as to the matters to which we must have regard as set out in s.105 of the Act and we grant the applicant an on-licence authorising the sale and supply of alcohol for consumption on the premises, to any person who is present on the premises.

The applicant's attention is drawn to ss.56 and 57(a) of the Act obliging the holder of an on-licence to display:-

- 1. A sign attached to the exterior of the premises, so as to be easily read by persons outside each principal entrance, stating the ordinary hours of business during which the premises will be open for the sale of alcohol; AND,
- 2. A copy of the licence, and of the conditions of the licence, attached to the interior of the premises so as to be easily read by persons entering through each principal entrance; AND,
- 3. A sign prominently displayed inside the premises, which identifies by name the manager for the time being on duty.

The licence will be subject to the following conditions:

- (a) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day to any person who is not present on the premises to dine.

- (c) The following steps must be taken to promote the responsible consumption of alcohol:
 - (i) A range of food choices must be readily available at all times that the premises is open. Menus must be visible, and food should be actively promoted.
