HEARING at Dunedin on 13 February 2025

INTRODUCTION

- [1] This is an application for the renewal of an alcohol on-licence for the "Regent Theatre" situated at 17 The Octagon, Dunedin.
- [2] The Applicant is seeking a change in their licence hours. Currently the hours are 8.00 am to 2.00 am the following day. They have indicated on the application form they are seeking new hours of 10.00 am to 10.30 pm daily.
- [3] Public notice of the application did not attract any objection and neither the Police not Medical Officer of Health Delegate opposed the application.
- [4] However, the Licensing Inspector has raised matters of concern including the premises operating without a certified manager, a lack of substantial food items available and the amount of alcohol allowed to be purchased by patrons.

HEARING

The Applicant

[5] Ms Anderson is the Director of the Regent Theatre. She acknowledged the points raised in the Licensing Inspector's report and has thought about solutions to the issues.

- [6] She said the Regent Theatre is run by The Regent Theatre Trust of Otago but relies on volunteers for the running of the theatre during performances with the support of the Trust. In recent years there has been a loss of some of the core members of the team and Ms Anderson accepted she had not kept an eye on those in the core roles.
- There has a been a new certified manager appointed and there are three who have completed their Licence Controller Qualification (LCQ) and have applied for their manager's certificates. The Licensing Inspector confirmed that the three have had their manager's certificates issued. The Theatre had not been operating for the past two months but they have decided that all front of house staff will be certified and there have been some volunteers also step forward who are being assisted through the process. There will be a pool of available certified managers to cover all of the licensing requirements.
- [8] Ms Anderson said they have reviewed their induction process including their Alcohol Management Plan and Host Responsibility Policy. In the past there have been briefing notes prepared for those working in the bar on performance nights. A part of the notes included crowd control in the premises. Below the notes a roster is shown so the volunteers can know what they will be doing in a night. A checklist has been developed so anyone coming in can check that everything is in place for a night.
- [9] The food options are more difficult because there is only about 20 minutes for an interval. Ms Anderson said they are looking at various options that would comply with the substantial food requirement. They are looking at removing the hot food items because of the time it takes to prepare and the risk people will take the food into the auditorium. She said they are looking for non-heat options because of the time constraints. They have found substantial muffins which have proved to be popular with patrons. A problem is the lack of shelving and cool storage available, especially on the mezzanine floor.
- [10] The Committee asked how difficult it would be for them to get sandwiches brought in for each night? And sugar and gluten free options? It was noted that service stations had better food options than the Regent Theatre. Ms Anderson said they would be happy to look at sandwiches as another option. The Committee acknowledged the practicalities of providing hot food at the premises but asked the Applicant to reconsider possible options.
- [11] Regarding the volume of wine served, Ms Anderson said she had contacted colleagues from other theatres and generally, the volume was about 200ml which was considered a large pour. The line on the cups used at the Regent Theatre indicate a 150ml pour. The signage has been changed to indicate the pour sizes.
- [12] When asked if a patron could purchase multiple drinks at one time, Ms Anderson said they would make the sale but there would be an expectation that the purchaser would have someone to assist with carrying the drinks. The intoxication levels of the patrons is monitored by staff throughout the night. In response to another question, Ms Anderson said the small bottles of sparkling wine are in glass and there are also cans and glass for soft drinks.
- [13] The Committee asked if the bar was open after a performance. Ms Anderson said she could not remember the last time there was a post-show event. They may happen once per year. The bar is only used in relation to performances and a staff event at the end of the year.
- [14] In response to a question about the request to have a licence from 10.00 am, Ms Anderson said it was a carryover from the past licences. They do not have morning events where alcohol is served and the bar area is covered when not in use.
- [15] The Committee asked if, with a lot of large events this coming year, whether the 10.30 pm finish time was practical. Ms Anderson admitted she had not thought too much about that

but was confident a 10.30 pm finish would cover most occasions. Midnight would cover everything. They do not encourage late events with alcohol. The Committee commented that a licensee did not need to use all the hours provided by a licence. They wanted to ensure the licence covered the majority of events at the theatre.

- [16] The Committee acknowledged the practicalities of offering hot food at the intermission time but questioned why food couldn't be taken into the auditorium. Ms Anderson said the volunteers were concerned at the mess that would be made inside the auditorium and them being required to clean it after a show.
- The Applicant acknowledged their systems for recording intoxication incidents has been poor. There is no single place in the premises where the information has been stored. However, they now have a place where the 'Bar Bible' is held. Staff are also aware of other substances people are using so now, if any one is showing signs of such use, they will asked to leave the premise. They will maintain a tight process going forward. The log has been kept in the foyer but Ms Anderson is not confident every incident had been recorded.
- [18] When asked how many people are removed from the premises, Ms Anderson said there may be up to half a dozen people each year. She said she doesn't work every night but relies on what she is told.
- [19] The Committee asked about the preparation of hot food. The Applicant said it can take about 10 minutes because the food is heated in a microwave two floors above the theatre and then brought down to the patron. Ms Anderson told the Committee it was clear this needed to be readdressed.
- [20] The Committee noted there was a 0% beer available but asked if they had considered offering other zero alcohol dinks, for example wines. Ms Anderson said she has ongoing conversations with colleagues at other venues and has learned the zero alcohol options are generally not popular. The Regent Theatre, as a venue, has limitations and is a compromised hosting environment.
- [21] The Committee asked if the premises was fit for selling alcohol. Ms Anderson responded that they were working on making improvements and apologised for the delays.

Licensing Inspector

- [22] Ms Blair is a Licensing Inspector for the Dunedin City Council. Her initial report for this application was taken as read.
- [23] She said the revised menu presented by the Applicant today was worse than that submitted with the licence renewal application. The food is not suitable for a licensed premises. The microwave used to heat food was two floors above the bar area is not appropriate. She said there are other premises worse than the Regent Theatre but they manage to provide suitable food.
- [24] Ms Blair said the training provided to staff has been improved however, with the large number of volunteers working at the premises, the manager needs to be aware of what is required and what it means to be a manager a licensed premises. There are now three duty managers available at the premises all with roles that keep them away from the point of alcohol sales. This means the training of the volunteer staff needs to be robust and of a high standard to ensure the staff know how to deal with alcohol related issues.
- [25] Ms Blair said the large pours, while not unlawful, are not suitable for this style of premises. The Committee asked why the large pour was not suitable when there is only a brief period in which alcohol can be purchased. Ms Blair replied that it depended on the number of drinks able to be purchased per sale. The Applicant's lack of knowledge about standard drinks and the norm for the industry was a concern.

The Committee asked if the premises incident book was sighted at their visit to the premises and where such a book should be kept. Ms Blair said they did not see the incident book. They asked Ms Anderson if there had been any incidents or where people had been asked to leave the premises but the answer was there had been no such incidents. A copy of the 'On-licence Toolkit' was left with Ms Anderson. It is expected that the incident book is retained at the bar and is made available to the agencies if requested.

Medical Officer of Health Delegate

- [27] Mr Whipp is the Medical Officer of Health Delegate. He said he submitted an interim opposition but did not get to follow up with a formal opposition in the time allowed. He does, however, support the position of the Licensing Inspector.
- [28] He said he was shocked when he saw the menu. What the Applicant has on their menu are snacks, not substantial food as required by the legislation. Mr Whipp also commented that the training offered was not up to the required standard.
- [29] Mr Whipp described his experience in working at three different theatres without kitchens in New Zealand. He said the Opera House in Wellington was worse than the Regent Theatre but they found acceptable work-arounds to comply with the legislative requirements.
- [30] Mr Whipp described the Applicant's presentation at the hearing as unacceptable.

New Zealand Police

- [31] Sgt Jones is the Dunedin Police Alcohol Harm Prevention Officer. He said the Police did not oppose the application but did forward a copy of the Graduated Response Model (GRM) warning for operating the premises without a certified manager present for the information of the Committee.
- [32] When asked, Sgt Jones said he could not think of any incident relating to the premises. However, the location of the premises meant there need to be an elevated mantle for a licence albeit the style of licence meant the risk was a lot lower than the neighbouring premises.
- [33] Sgt Jones said the operation of the premises was below par and appeared to have further declined since the meeting with the agencies.
- The Committee asked what he thought of the licence hours requested by the Applicant. He said the premises is still operating traditionally and has not changed with the times. He agrees with the proposed hours stating there was no reason for patrons to be able to access alcohol after a show. To allow the staff and performers to have a drink after a show, it would be preferrable for the premises to be licensed to ensure the minimum requirements were maintained. In response to another question, Sgt Jones said the Police can enter a licensed premises. They usually visit premises based on risk but would look at this premises going forward.
- [35] Sgt Jones said there could be agreement on the licence hours somewhere between those advertised and what has been suggested at this hearing.

CLOSING

Applicant

- [36] Ms Anderson said she has started working towards obtaining her LCQ which has given her a better understanding of the legal requirements of licence holders.
- [37] She said the Bar Bible used for incident recording would be kept at the bar.

- [38] She said the hours on the licence are a carryover from the past. The hours she put on the application form are more in line with how they operate as an entertainment venue. She said while extending the licence hours beyond the suggested 10.30 pm was not a priority, it would be worth considering. If they knew there was going to be a requirement to have a later licence they could always apply for a special licence.
- [39] Ms Anderson said food was clearly an issue but thought it could be quickly resolved. She said she would source a supplier for non-heated, better options because they would like to keep the bar operating as it is currently.

Licensing Inspector

[40] Ms Blair advised she had nothing further to add.

Medical Officer of Health Delegate

[41] Mr Whipp had nothing further to add.

Police

[42] Sgt Jones said he was interested in the size of the pours at the bar, patrons drinking after performances and the hire of the premises. Ms Anderson responded by saying she had no issue removing the large pour and could not remember an occasion where the bar was open after a performance.

INTERIM DECISION

- [43] After considering the application and information provided at this hearing, the Committee is not satisfied the Regent Theatre is compliant with the Act. An alcohol licence is a privilege and with that is the responsibility to comply with the legislation. While this premises is low risk, there is still a minimum standard that must be met.
- [44] The Committee has found the requirement for substantial food is not being met, rather a reliance on offering basic snacks. Options were discussed at the hearing and the Applicant has undertaken to source a better quality food that meets the required standard.
- [45] There has been a failure by the Applicant to ensure staffing has been maintained and trained to an appropriate level and that there are sufficient certified managers available to oversee the operation of the bar. The Applicant is working to resolve this issue with three of their staff now with manager's certificates, but they should not have been put into the position which warranted a Police warning.
- [46] There was discussion about the volumes supplied for the various pours of alcohol. While there is nothing illegal with the volumes offered, the Applicant needs to gain a better understanding of standard drinks and what was appropriate for this style of premises.
- [47] While the Committee is of a mind to not renew the licence, as a courtesy, the Applicant will be given until 3 March 2025 to present a plan to the Committee detailing a new way of operating the premises. A File Minute will be issued detailing the information we expect to see in the plan.

DECISION

- [48] This hearing relates to the renewal of the on-licence held by The Regent Theatre Trust of Otago.
- [49] Public notification of the application did not attract any objections and neither the Police nor Medical Officer of Health opposed the renewal. However, the Licensing Inspector identified issues which raised questions as to the suitability of the Applicant.
- [50] The Committee heard that the premises was being operated without a certified manager being present which lead to a formal warning being issued by the Police. This raises the

question about the systems and processes in place at the premises and whether they are adequate.

- [51] The food available at the premises is not considered to be 'substantial' as required in the Act. The intermissions during shows are about 20 minutes long. If one wanted to order one of their limited hot food options, there would be a delay in getting it because it was heated two floors above the bar area where the food is ordered, and once in possession of the food, it cannot be taken into the auditorium.
- [52] The Inspector was also concerned at the volume of alcohol able to be bought at one time with a large pour being 275ml which is the equivalent of 2.75 standard drinks of wine. This volume and not being able to have substantial food would require very careful monitoring and in the theatre environment, this may not be possible.
- [53] The Medical Officer of Health Delegate described the food options stated on the Theatre's menu as nothing more than snacks and did not meet the requirements for an on-licence. He also commented that the training recorded as taking place at the premises was inadequate.
- [54] Mr Whipp told the Committee he has personally worked in three theatres elsewhere in the country and they all had developed protocols for ensuring adequate food was available when they were operating. He did not believe the issue was insurmountable, they just needed to think through what could be done.
- [55] The Police did not oppose the renewal of the licence but noted that the operation of the premises did not meet the expectations of the agencies and from what he heard during the hearing, it appeared that the was a further decline in the standard of operation.
- [56] He said the premises was low risk but, because of it's location, it needed to be operated properly.
- [57] The Committee was unimpressed with what was presented at the hearing and was of a mind to decline the application. It is accepted that the Trust relied on volunteers to run the theatre during shows but that does not detract from the need to meet the requirements of the Act.
- Other than ensuring there is a certified manager present when alcohol is being sold, they must also ensure there is substantial food available and that patrons get the opportunity to eat it. During the hearing, it was suggested that they consider looking at sourcing sandwiches, rolls and salades which would not require reheating. For the products that did require heating, the Trust needed to consider placing microwaves at the bar areas so the food could be bought and heated in a very short time.
- [59] The Committee provided the applicant an opportunity to supply a plan which addressed the issues raised during the hearing. The plan was finalised in consultation with the three agencies and submitted to the Committee on 25 February 2025.
- [60] The Applicant noted the optimal hours for them would be 12.00 midday to 12.00 midnight. The do not sell alcohol in the mornings and a midnight close would cover all their events.
- [61] The criteria the Committee must have regard to are found at s.131(1) of the Act. The matters raised during this hearing relate to:
 - a. S.105(1)(a) object of the Act: the Police advise there have been no issues with the premises and, because of the nature of the venue, the Committee believes the object of the Act is being met.
 - b. S.105(1)(b) suitability of the Applicant: the Committee initially doubted the Applicant's suitability but they were able to make appropriate changes quickly which

- indicated to us they were willing to adapt and therefore their suitability no longer questioned.
- c. S.105(1)(d) the days and hours during which alcohol may be sold and supplied: the Applicant requested lesser hours but after discussion, opted for licence hours between the current and those initially sought on the renewal application. We find the proposed hours suitable for this premises.
- d. S.105(1)(e) design and layout of the premises: the layout of the premises does not lend itself to readily provide substantial food during performances. They have made changes which now has microwaves in the bar areas to heat food and the menu itself now has substantial food listed that does not require heating.
- e. S.105(1)(j) appropriate systems, staff and training: the Applicant has now put in place better systems and training to ensure the Act is complied with at all times.
- f. S.105(1)(k) other matters raised: the Inspector raised the lack of substantial food available during performances and the volumes of alcohol sold per serving. These matters have been addressed by the Applicant. The food options have been expanded to ensure substantial food is available and the volumes of alcohol per pour have been reduced and the signage amended accordingly.
- [62] The Committee is now satisfied that the Applicant complies with their legal obligations and renews the licence with the amended hours of 12.00 midday to 12.00 midnight. All other conditions remain unchanged. To ensure the changes are embedded, the licence will be renewed for a truncated period of 18 months to 26 February 2026.
