Time limits vary (30 minutes, 60 minutes, 240 minutes or all day) and are advised on the signs and pay and display meters in the area.

Policy

That the Dunedin City Council provide free parking in 'metered parking areas' to Residents of Dunedin City, who are aged 75 years or over, who hold a valid New Zealand driver's licence, and drive their own vehicle.

Concessions

The permit allows the holder to park without payment, for the maximum period permitted, in all areas controlled by Pay and Display meters both on street and in carparks.

Time limits vary (30 minutes, 60 minutes, 240 minutes or all day) and are advised on the signs and pay and display meters in the area.

Conditions

1 Eligibility:

The applicant must:

- a) be a resident of Dunedin City
- b) hold a valid New Zealand Driver's Licence
- c) be 75 years of age or older on the day of application.
- 2 The permit is valid only in pay and display parking areas and does not provide the holder with an exemption from any other parking statute or bylaw.
- 3 The permit must be displayed in the position specified.
- 4 The permit is issued to the applicant and may only be used by the applicant.
- 5 It is the permit holder's responsibility to inform the DCC Customer Services Agency, Telephone 477 4000, of any change of circumstances which may affect eligibility e.g. change of residential address, no longer able to drive a vehicle etc.
- 6 Permits are issued for a period of up to 5 years. It is the permit holder's responsibility to renew the permit upon expiry; no reminder letter will be sent.
- 7 The permit may only be used in the vehicle/vehicles stated on the application form.
- 8 The applicant is required to supply proof of residency e.g. utility account, rates account, tenancy agreement etc.
- 9 For all new applications the applicant is required to supply proof that they hold a valid New Zealand driver's licence and date of birth. For verification, licences may be presented at any DCC Customer Service Centre or at the offices of Age Concern, 9 The Octagon, Dunedin or Grey Power, 211A King Edward Street, South Dunedin. If applying by post or online the applicant must include a copy of both sides of their licence and proof of residency.
